#### Phil Luke Scores \$1,100 29-Hand Veteran's Day Open in Reno Draws Record 348 Ruth Rutherford Takes Crown

Once again, the Sands Hotel and Casino in Reno has drawn a record crowd...this time for the Veteran's Day Classic (November 8-10). 348 peggers from throughout the United States (and Canada) gathered for this pegger's shootout, and in the wee hours Saturday night Ruth Rutherford, a fine pegger from Meadow Valley, CA, was crowned champion. This honor came complete with a bushel of Master Rating points and \$2,000.

John Thiems, Winston, OR, claimed 2nd and \$1,500. Master player Greg Schleusner, the Truckee, CA king edged by Butch Reynolds, Santa Maria, CA to finish 3rd. Butch finished 4th.

One of the Northwest's best peggers, Jean Edwards (Roseburg, OR) had the hot hand in the qualifying round, scoring some 39 game points.





### The President's Column Joseph Petrus Wergin

The Grass Roots Champion of each club has been invited to participate in the Tournament of Champions for the first time.

The 1990-1991 club champions played 250 to about 360 games in winning the honors. Nine games are played each session and clubs may play as many as 40 times. That totals up to 360 games. A player really earns the rating. Contrast this to a player who captures a title in a 64-player week-end event who plays about 35 games to nail down an invitation.

David Proctor of East Longmeadow, MA, is Chairman of the Order of Cribadier Generals and is conducting a drive to replinish funds used in the past months for the Youth Program. Jim Arblaster, originator of the group, former Congress Secretary, and a Director since day one, turned the reins over to Proctor last year.

The purpose of the order is to promote the Youth Program and to back any other worth-while activity within the borders of the Congress. You may become a Cribadier General by paying the \$25 initiation fee. All dedicated players are asked to send a couple of bucks to Proctor to fund the programs. The address is: 2 Lull St., East Longmeadow, MA 01028.

Joyce Gearin of Dufur, OR, writes: "The avowed purpose of the Congress was to obtain uniformity in the play of 'The Grand Old Game'. Yet, as demonstrated at a recent tournament, standardization is lacking."

Joyce went on to say that in one type of playoff, a person could skunk an opponent the first two games and could lose the match. In the other type, the match would be won by skunking the opponent in the first two games. She says that it doesn't make sense. When identical hands can produce inconsistent results...a winner in one tournament and a possible loser in another.

The advertising program is beginning to roll. The first ad, CRIBBAGE ANYONE, appeared in the November issue of the BADGER LEGIONNAIRE, the monthly Wisconsin magazine for the American Legion.

Contracts have been signed for January with the Rotary National Magazine, the American Legion National, Yankee, and Maryland Legion, for either one column-inch ads or classified listings. Phil Babcock, a Board member and vice-president of the Public Relations Committee, has written an article for the Maryland Monthly.

A temporary setback occurred in regard to the contact to be listed on the bumper sticker. The Board of Directors will consider the feasibility of listing an 800 number on the sticker.

Babcock has suggested that Grass Rooters place posters in key spots to encourage cribbers to come out of the woods and join the club. When a local player wins a title in a tournament, be sure to pass the information on to your local newspapers, especially in the small towns. And give the address of a local club or of the American Cribbage Congress. Take every opportunity to promote the game. Think BIG!

224 peggers stayed around for the Sunday consolation. Harold Buckley, Palmer, Alaska, took home the marbles in this event. Harold has been a serious pegger in the Northwest for several years, and is always a threat to win any event. His job was NOT easy, as he had to get by recently crowned Life Master Jesse Jarrell, Pittsburg, CA. Jesse finished 2nd. In third and fourth was Robert Sutton, from sunny Burbank, CA, and co-director Bill Irons, Sparks, NV.

One of the tourney's highlights was Phil Luke's 29-hand in the main event. The Sands offered \$1,000 for anyone scoring this 216,000 to 1 gem...and Phil not only collected this sum, but also another \$100 from the American Cribbage Congress. This is ONLY the 3rd 29-hand scored this cribbage year in sanctioned play.

In the early bird kickoff doubles event, Jeff Monroe and Wayne Sharp, Napa, CA, nailed the huge crowd of 264 peggers (132 teams) for this win, picking up some \$965.

In the Saturday night high roller, Avon Ray, Santa Rosa, CA came away the winner. In the Sunday "last chance" high roller, Jesse Jarrell, fresh from a 2nd in the consolation, continued his "roll" and picked up some "gas money" for his return to Pittsburg, CA.

As usual, Bill and Dorthalee Irons, with help from the Sand's Barbara Woodward ran a first class tournament, attested by the record crowd. And the veteran's benefited once again from the percentage deducted from entry fees. With this increase in players from last year, the upcoming ACC Open, and Tournament of Champions certainly holds promise of also setting new records for attendance.

The wrinkled and gnarled Sir John was holding a 29-hand across his chest...and if tampered with, Sir John would slowly rise in protest. Needless to say, players recoiled in horror!

Once the "Goblins and Ghosts" costumes were discarded, and play began in earnest, Edgar Bastedo, the Lethbridge, Alberta pegger, came away with the championship...and he had to win the hard way. Getting by Ray Van Orsow lately is earning your win! Ray, the Portland king, has been tearing up the track lately, fresh from winning the Montana Championship.

Dorothy Roum, the world travelling pegger from Joseph, OR, is also continuing her streak with a nice 3rd place finish, edging out Keith Forrest, a fine pegger from Stevensville, MT. This main event drew a "perfect" 128 peggers...as the playoff board had 32 qualifiers, with no "byes."

The Van Orsow clan continued their winning ways in the consolation, as Denny picked up this win, besting some 106 peggers. Denny hails from Culver, OR. Denny also had to win the hard way, as he had to get by All-American Paul Hatcher, the Salem, OR king. Two other fine peggers finished 3rd and 4th: Jim Keeling, Spokane, WA, and Joyce Gearin, Dufur, OR.

45 teams pegged for the doubles crown, and Paul Calhoun, LaPine, OR, teamed with rookie Jason Hofbauer, youngest son of the famous Hofbauer clan to claim the doubles crown.

Tom Semans, Garden Valley, ID, won the "high-roller" event.

In addition to the halloween theme, Ken and Betty Capper also conducted their usual "calcutta" at the Saturday night banquet, auctioning the top 32 qualifiers...an event well received by the players.

This North Easton, MA pegger is setting a torrid pace in the 1992 MRP race. Bob also qualified 2nd in this 124-pegger event, earning some 184 MRP's, running his yearly total to about 450. Only Roy Hofbauer, the Washougal, WA, bomber is keeping pace.

Paul Strutton, Chesapeake, VA took 2nd. All-American Phyllis Schmidt, the Williamstown, MA queen of cribbage, finished 3rd, followed by Mike Midgette, Kill Devil Hills, NC, in 4th.

80 peggers stayed around for the consolation event...and George Bright, Atlanta, GA, took the crown, edging out David Oglesby, Virginia Beach, VA. 3rd and 4th were taken by Ford Jewer, Wakefield, RI, and Grand Master Harry Palmer, West Springfield, MA.

Dick Wade (VA) and Kate McNemar (Wash., DC) scored that elusive 28-hand, but NO 29-hands were played...making the 1992 cribbage year a tough one as only three have been scored the first three months of the 1992 season.

Director Richard McCormick handled this large crowd in fine style...and Virginia cribbage continues to grow. Richard wishes to schedule this tournament again next year, to be played October 9, 10, and 11.

It seems to me that it would be a good idea for the ACC to have a policy regarding the acceptance of handicapped players and guidelines for tournament directors and Judges regarding how to deal with any rules' technicalities. It might turn out that there is a need for some recognition in the rules of allowable rule variations to suit handicapped players but that is not clear to me at this time.

I hope that there is some merit in this idea and that some one will take the lead in organizing and developing it. Please send your views and any suggestions to me.



#### **Cribbage Conjugations**

Remember that humerous example of the conjugation of the verb "to be," I am firm, you are stubborn, he is pigheaded? Regarding the strict conformance to Cribbage rules, a similar example could be, I am forgetful, you are inconsiderate, he is breaking the rules.

Hopefully only a few of your opponents are inconsiderate and fail to always call out the count when playing a card. If you don't like to "make a fuss," and allow them to get away with it, there are two undesirable results. First, they are unlikely to improve their playing habits and secondly you suffer the disadvantage of not being able to profit from their miscalling the count.

The very first time it happens they should be told that the rules require the count to be stated; the applicable rule is VII 1c.

#### Standardize!

A serious problem arose at the recent Grand National at Ft. Lauderdale and should be addresses by the BOD.

As the American Cribbage Congress is a national organization and the point system determines member standings, the point system should be universal no matter what tournament is played.

If one tournament you were playing 4 out of 7 games in the playoffs, and skunks count double, if your opponent won the first 2 games and you skunked him the next 2 games, you would be declared the winner. Yet in another tournament, if you were playing in the playoffs, a win would count as one point (whether you skunked him or not) and the player that won 4 out of 7 games would be declared the winner.

The same thing is happening when some tournaments a win counts as one (1) point, a loss as no (0) points, and a skunk doesn't count any more than a win. Yet in another tournament, a win counts as two (2) points, a loss as no (0) points, and a skunk as three (3) points. This can make a difference in how a tournament winner is declared. In one tournament you would be a winner but yet in another you would lose depending on which system the tournament director is using. It just doesn't seem right that all of these different point systems can be used.

The Master Point system should be determined in the same manner in all tournaments for the point system to be fair to all.

A winner should be declared by his play...not the place. This should be brought to a vote by the membership.

is better than the guidelines given by the ACC (some are protected by a "grandfather" clause, and others ignore the guidelines). Perhaps the ACC should tighten the guidelines and make scoring systems standard nationwide. You have my vote, Joyce!

### Russ Adam's **Discarding Decisions**

Russ Adams is an excellent pegger from Minneapolis...and he has been doing his homework! He recently ran a 2,000 sample of hands, complete with the discarding decisions for the non-dealer. Russ is one of the ACC's top "number's nuts" and his fine 7th place finish in the Central Region last year (659 MRP's) is evidence working with "numbers" pays off.

#### DISCARDING DECISIONS An analysis by Russ Adams

Discarding and pegging are the distinguishing marks of winning cribbage since, in the long run, players receive an equal amount of good cards and cuts. DeLynn Colvert and Joe Wergin, as well as others, have offered valuable tips and rules on discarding and pegging, which should consider: 1) dealership; 2) board position; and, marginally 3) the known or suspected tendencies of opponents toward particular plays ("loading" their cribs, "busting" opponent's cribs, etc.). The obvious consideration of dealership means that the dealer need not fear his/her discard, while the nondealer may be dubious about holding a maximum-point hand if the crib throw is dangerous. Sacrificing, say, two hand points to reduce or increase the crib potential. If the dealer is desperate for points, or conversely the nondealer is not, four or more points may be sacrificed for a more secure position, There are no absolute rules, such as 'never throw a pair of 5's to opponent's crib,' but there are general probabilities for guidelines. Any crib may contain 14 or more points, regardless of discards, but some combinations yield an AVER-AGE of less than three points. Board position is always important in the discard decisions. The following table classifies discards, based upon average results, into five categories:

#### Comments:

The four 'supersafe' discard combinations are K-10, K-9, Q-6, and K-6. The King is the safest overall because it is at the end for runs. These four yield an average crib of 2.3 points, or roughly 1.7 less than average.

Nineteen of the 91 discard combinations are 'safe' (3.0 points). They involve facecards. separated (non-touching), and Aces, including

Medium-level discards account for 43 combinations which equal the crib average. These include most of the 10-small card combinations, touching higher cards, but also the 5-8, 5-9, and 4-6 throw which many regard as dangerous, as well as 5-2, 5-1, 4-2, 3-1, and 2-1. Within each group there is variation in risk, such as from 3.6 to 5.7 points per crib in this group.

"Dangerous discards include all pairs, excepting those of the K, Q, and Ace, an 8-9, 6-9, 5face, a 5 with touching cards, etc. These yield average cribs of 6.0 up to 7.7.

"Double-danger" discards are the pair of 7's (which outranks 8's), the 7-8, 2-3, and, not surprisingly, the 5-5, in that order; 5's yield average cribs of 8.9, while the 2-3 is close at


