# Green Bay: Scott Kooistra St. Paul: John McGrail

Green Bay, February 28: Scott Kooistra has once again taken a prestigious champion-ship! This Yankton, South Dakota Life Master nailed the 478-pegger MGM Open in Green Bay, WI, and with the 379 MRP's earned vaults back into 2nd place (lifetime) nationally.

Scott ran a 21-5 run in the playoffs to win the championship, \$3,000, and a sizeable clock for his wall in South Dakota.

Local Larry Lagassie needed 3 skunks in a row (games 20, 21, and 22) to qualify for the playoffs...and he did exactly that! Then he ran a good run of cards into 2nd place, \$2,000, and 316 MRP's. Moose Biegler, West Bend, WI, finished 3rd, followed by Wayne Steinmetz, Milwaukee, WI in 4th.

Local Joe Beaster took top qualifying honors with a nifty 40 (16) +399...and some \$825 Q money.

The consolation drew 228 players, and Harvey Cohen, Milwaukee captured this title, fol-

lowed by Don Tofte, Madison, WI in 2nd, Richard Hefty, Madison, in 3rd, and local "Buzz Peters in 4th.

Green Bay is a hot bed for doubles action, and once gain, huge crowds played Friday and Saturday nights. R. Cornell and M. Hook took the Friday action (20, (9) +151) and took home \$1,100. Saturday night's doubles saw P. & J. Healey post a 21 (9) +165 to take home the marbles.

Bay City, Michigan's "Wink" Birch captured the Friday "high roller" event (\$1,000), and Saturday night's singles action was won by Ted Hokenson, Marquette, MI (21 (9) +182. The Sunday "last chance" was won by Life Master DeLynn Colvert, Missoula, MT.

Once again, Tom Gallagher, Jerry Lemke, and Bob Miller ran a smooth event, aided by a fine staff. This tournament remains the largest in the Central Region.

How many times have you reached the last few games of a qualifying round and said, "I need to skunk 'em all to qualify!" Well, it happened in Green Bay at the MGHM tournament. Larry Lagassie of Green Bay had a 19 GP card with three to play and went skunk, skunk, skunk, for a total of 28. He qualified 118th out of 120, and the next day finished 2nd in the tournament!

Why do cribbage players always turn over their scorecards? At Reno, 22 out of 24 players at my table had their scorecards face down. It's probably a good practice, because it could potentially influence how a game is played. However, I always wonder if anyone is hiding something.

My thoughts on the issue of spectators watching championship matches. I like the National Open in Raleigh method of ringing the

entire championship table with chairs about 8-10 feet behind the players. Spectators can still watch the match but they wont be right on top of the players. If there isn't sufficient space, I'm in favor of keeping the on-lookers away.

A big statement for all players: when you have enough points to win, make sure to peg out! I've already seen three players in the past month forget to peg out and they have lost their points. Be proud to win the game. Show your pride by pegging out.



St. Paul, MN, March 7: John McGrail, Elgin, IL, came north to St. Paul and took the Capital City Open, besting some 158 players in the process. John picked up some 160 MRP's and \$1,200 to make the weekend well worthwhile. Local Ed Blecker finished 2nd and with the 152 MRP's earned vaulted over the 2,000 MRP plateau and earned his Master rating. Bob Chase, Crystal, MN took 3rd, followed by local Larry Meath in 4th.

Shelley Vadnais, Oakdale, MN had the hot hand in the qualifying round, posting a nifty 36 (17) +259.

The "All Events" race ended in a tie with Jim Jeffers, and Boyd Lundquist both posting 56 GP's. Jeffers hails from Green Bay, and Lundquist hails from Lakeville, MN.

The Friday "early bird" was won by Ron Morgan, who made a long trek from Missoula, MT to pick up some \$600 with a 16 (7) +134 score. James "Tubby" Dahl, Blair, WI nailed the Saturday night game, posting 18 (8) +198.

110 peggers stayed for the consolation, and Bill Cook, Rhinelander, WI came away with the title, followed by Al Mahowald, Carver, MN, in 2nd. Newton, Iowa's Larry Loupee and Seymour WI's Lloyd Kraft are both Master peggers and by finishing 3rd and 4th, maintain their spots in the top 100 nationally (lifetime).

Director Ron Hamilton and his fine staff ran a first class tournament...and a "tune-up" for 1994's Grand National.

## Plumas Stokes Takes Willows Title

Master pegger Plumas Stokes, Quincy, CA, nipped Sundae Webb (another Master), Antioch, CA, in the final match to capture the 116-pegger 12th Annual Willows Open, in Willows, CA, February 20. Clyde Ross, Grass Valley, CA took 3rd, and Barbara Ruiz, San Lorenzo. CA finished 4th.

## Anne Matti Takes Orlando Open

Naples FL's Ann Matti captured the 3rd Annual Orlando Open February 28...and this edition set a new high in attendance with some 144 peggers!

A relative newcomer to tournament play, Anne played with precision, and nailed her last two matches 3-1 and 4-0 to win going away!

Her husband, Gaylord, is no stranger to play, however. He will direct the upcoming Madison Masters Classic XV, with assistance from codirector Jerry Dickinson.

## Clarification of Renege Rule

When a renege occurs, there is a two-point penalty for each card that singly could have been played. In other words, if the count is "25" and a player holds a 4 and a 3 and says "go," he or she has committed a 4-point penalty. If the count is "22" and a player says "go" with a 7, 8, and 9 in his or her hand, the penalty is SIX points. Both cases occurred in the past month. When you have a card under or equal to 31, you must play it or suffer a penalty.

See the new Rule Book, Rule VII, Section 3A.

## Northwest Open Features Rare Double-Double Lea Horbeck, Carol Holt Clean Up in Baker City

Lea Hornbeck, Washougal, WA, and Carol Holt, Portland, OR, made a clean sweep of the recent 16th Annual Northwest Open. Lea was top qualifier, and finished 1st in the playoffs, and Carol was the 2nd high qualifier, and finished 2nd in the playoffs.

Master pegger Otto Bartholow, Boise, ID, changed the format somewhat, as he struggled to the 30th qualifying (and last) position, then warmed up in the playoffs and finished 3rd, edging perennial winner (and Master pegger) Paul Hatcher in the 3-4 playoff. Hatcher hails from Salem, OR, and with the 90 MRP's earned for 4th, throws his hat into the MRP race for the 1993 year, standing near the top nationally with nearly 700 points.

118 peggers played for the championship, and an impressive 88 stayed around for the consolation. Doug Brown, a Master pegger from Pasco, WA claimed this title, edging Charlotte Springer, Summerville, OR, in the final match. Henry Carle made a long trek south from Anchorage, Alaska, and with his third place money, helped pay for the trip. Roger Lueschow, Maple Valley, WA, finished 4th.

In the early birds, local Steve Palmer took the Friday "timepasser," Bo and Clarence Van Orsow, Redmond and Culver, OR, snared the doubles, and Bernie Saueressig, Richland, WA grabbed the "high rollers." Jo Evans, Richland, WA, won the Saturday special.

This was the 16th edition of this match...making it the longest running tournament in the Northwest...and Rob Palmer has been the director from day one. All events ran smoothly, attesting to his long experience of tournament managing. And, as usual, Marvis Reynolds did her fine job of assisting with the bookwork.

Paula Lowrey from nearby Bend, OR came close and finished 2nd, taking home a nifty \$800.

Ken Capper, Hermiston, OR, earned a spot on last year's Western Region All-Star team, and is making another run for the team by finishing 3rd...and picking up 219 MRP's. Bob Nunamaker, Sunriver, OR finished 4th.

Jeff Studnick, Madras, OR, had the hot hand in the qualifying round, besting the 226 players...and picking up a nifty 80 MRP's and the top Q prize.

A sizeable 144 peggers stayed around for the consolation event, with Don Jurgens, St. Paul, MN coming away the winner. Local Russ Rhoden finished 2nd, Bob Herrmann, Bend, OR, 3rd, and Jeff Monroe, the ACC's Membership Chairman from Napa, CA, took home 4th.

In the early birds, Darrell Hoffman, Eugene, OR took the high-roller and in the doubles event, Carroll and Anthony Shadley took home the marbles.

Director Joe Nelson once again conducted a well-run tournament, with able assistance from Marvis Reynolds, and other members of his staff. Nelson's trophy boards are coveted far and wide, and, again, he awarded a sizeable number. Nelson, along with Rob Palmer of Baker City, have a long, colorful, history of organized cribbage in Oregon.

## New Criteria

## Hall of Fame Election Procedures

New criteria for possible election to the ACC Hall of Fame was adopted by the board of directors at its meeting in Reno February 4.

Three mandatory qualifications are required:

- 1- Be an ACC member in good standing for seven (7) consecutive years, or have been a member for a minimum of five (5) consecutive years until death intervened.
- 2- Have displayed and complied with the rules of ethical play.
- 3- Have displayed and complied with the standards of good sportsmanship.

In addition, to be eligible for nomination, a candidate is required to meet at least three (3) of the following optional criteria:

- 1- He or she must have promoted the game of Cribbage and served the ACC by specific acts of accomplishment.
- 2- Established his/her expertise by being rated a Master player or higher in ACC sanctioned tournament competition.
- 3- Established his/her expertise by being rated a Bronze award recipient or higher in Grass Roots competition.
- 4-Served as a Tournament Director, or Co-Director, of an ACC sanctioned tournament for a minimum of five (5) years.
- 5- Served as a Grass Roots Club Director for a minimum of five (5) years.
- 6- Served as a member of the Board of Directors of the ACC for a minimum of four (4) years.

Any exceptions to or exemptions from the above criteria must be initiated by a current member of the ACC Board of Directors. (Under the ACC membership requirement, Sir John Suckling--founder of the noble game--and several other non-member Hall of Famers could not have been able to be nominated or elected.)

This new criteria goes into effect immediately for Hall of Fame voting by the BOD at its July meeting in Raleigh.

Any member of the ACC may submit a written nomination, following the listed criteria. Deadline for submission of nominations for 1993 requires a May 15, 1993 postmark.

Nominations should be sent to the Hall of Fame Ballot Committee, c/o Chairman Lee Norris, 380 Davisville Road, N. Kingston, RI 02852. Other members of the committee, who will prepare the ballot for the board's annual meeting, include Larry Loupee, Newton, IA, and Bev Sauer, Portland, OR.

Next year, the same nominating procedures will be followed, but a change in the voting structure will see a mail vote conducted by the Hall of Fame Ballot Committee, with voting extended to ACC Directors, all sanctioned tournament Directors, and all active Grass Roots Club Directors (those on record as of August 1 the previous year).

They may cast votes for any or all of the nominees, with a 75% majority vote required for election to the Hall of Fame. Inductions, as usual, will take place at the annual Grand National tournament held every September.

The new criteria was developed for Board consideration by six directors headed by Norris and including Loupee, Sauer, Joe Ramos of West Warwick, RI; Fred Dettling of Aurora, CO; and Jim Waldorf of Madras, OR.

## New Invitational United States Invitational Championship


Larry Samet, Scott Kooistra, and Jeff Monroe are organizing an invitational match that they feel will more fairly crown a winner.

The format: The top 100 (lifetime) plus the top 15 from each Region (not in the top 100, lifetime) will be invited. Entry fee is \$250, plus \$50 for a second half of the tourney. Entrants will play a 32-game round on Friday before the Grand National. 18 games before the BOD meeting, and 14 games after. The top 16 will play a playoff match against one Regional opponent at a time and place by agreement (or as designated by the 3 directors) after the Grand National and before the ACC Open. Eight winners play a match at the ACC Open. The remaining four winners after this match play a match at their choosing. The two winners play a final match at the National Open in Raleigh (or by agreement). The rounds of 16 and 8 consist of a best of 30 games, and must win by two games. The round of 4, best of 35 games, and must win by two games. The final round: best of 45 games, winning by three games.

Based on 96 entrants, prizes are projected to be: 1st-\$7,500, 2nd-\$4,500, 3rd, 4th-\$2,000, 5th-8th-\$1,000, and 9th-16th-\$500 each. The \$50 fund would be divided among the players with the best record in the last 16 games, as a separate and additional fund. Entry fees will be kept in a interest-bearing account, with interest to defray expenses. Extra money given in prizes or to the ACC.


Co-director Samet believes this style of play will crown a true champion, and offers a rare opportunity for major head-to-head play. More information will be printed in *Cribbage World* as it becomes available.



## Larry Lee Hassett Wants Rule Book Articles

Roseburg, OR, pegger Larry Hassett has been going over the new Rule Book, and has several questions. He asks for a possible monthly article for readers to present their questions concerning our rules...and perhaps get an official ruling from our senior judges.

He presents a couple of questions: Rule VII, Section 3a "Renege." If a player discovers they have "reneged," before the card is played (after a "go" has been pegged) is there a two-point penalty? The card should be dead.

Rule VIII, Section 5a "Pegging from 1st to 4th street;" if a player on a long board incorrectly pegs from 2nd to 3rd, does the same ruling apply (they lose their score)?

Rule VIII, Section 5b "Removing both pegs of not on 4th street;" what happens if a player inadvertently removes both pegs on 4th street (and is not claiming the game)?

Senior judges, send Cribbage World the rules that apply...and do we need a monthly article on our Rules? Larry feels it should raise the awareness of ACC members and improve the quality of play.

## Correction on Mandatory ACC Membership

Cribbage World has kept its string of issues with typographical errors intact! Last month Cribbage World reported that the BOD voted mandatory membership for all sanctioned tournaments starting with the 1993 season. Oops...it will take effect for the 1994 season!


