### KAH-NEE-TA Van Orsow Clan On War Path Clarence Wins Main Event Bo Wins Consolation

The Fourth Annual Kah-Nee-Ta Open, played at the Confederated Indian Tribe's Kah-Nee-Ta resort in Warm Springs, OR, hosted some 122 peggers December 3, 4, and 5...and Clarence Van Orsow (the senior member of the Van Orsow "tribe") went on the war path and took the main event. His son, Bo, put on his "war-paint" and won the 98-pegger consolation event.

Clarence is the patriarch of the peggin' Van Orsow clan, and he has been overshadowed by the younger members of the clan...Denny, Ray, and Bo, who are all Master peggers. But Clarence had his day in the sun by winning this event.

Local John Wright came very close to winning it all, but had to settle for 2nd. Rookie Keith Blackman, Canby, OR, finished 3rd in his very first sanctioned tournament, and Ray Leland, Roseburg, OR, took 4th.


Joyce Gearin, Forest Grove, OR, nailed the qualifying round with a fine 36 (17) +196 to take home the "Q" prize. Forest Grove produces a bevy of fine peggers, and they have a habit of taking home more than their share of the prize money!

### New 28-Awards

Awards Chairman DeLynn Colvert has re-designed the ACC's 28-awards (see below). These awards are smaller, and have an improved look. They will replace the 8"x10" awards that simply take up too much wall space for those players who have earned several awards. The new award fits a standard 5"x7" frame.

Any player wanting to upgrade their 28-awards may do so for a grace period of 30 days. To re-make your old awards to harmonize with future 28's, send the following information to ACC Awards, PO Box 5604, Missoula, MT 59806:

# Yankee Classic "Stuck" On 138

## Carl Deyette Wins In Connecticut


1992's edition of the Yankee Classic (Manchester, CT) drew 138 players...and this year's edition played to another 138. But the winner had a new name...Carl Deyette from nearby East Hartford. Not only did Carl win this event, he qualified 5th, and picked up 175 MRP's, throwing his hat into the Eastern Region's MRP race.

Pat Llewellyn, Bellingham, MA, nailed 2nd, Arthur Martin, Northboro, MA, took 3rd...and also was the top qualifier. Arthur will move up in the Eastern Region's MRP standings by picking up some 169 MRP's. Jim Ready, Stoughton, MA finished 4th.

94 peggers stayed for the Consolation, and Cindy Veradt, Taunton, MA, continues her fine 1994-season play by winning this event. Tom Scott, Fiskeville, RI, took 2nd, and Eastern Region Tournament Commissioner George Bickford, W. Springfield, MA finished 3rd. Bill Weskowsky, Munson, CT, nailed 4th.

Doris Perkins (Quincy, MA) and Nelson Bakken (Chaplin, CT) scored 28 hands, but that elusive "29" failed to show.

Directors Mimi and Rit Alkas plan on renewing this event next November. Perhaps 139 peggers will show!

### Bo Van Orsow Cops Consolation

After his father, Clarence, had made off with the Main Event trophy, Master Bo Van Orsow followed suit and took the Consolation event. Margery Clark, Bend, OR, took 2nd in this sizeable event (98 peggers), followed by John Hatfield (co-director), Madras, OR, and Bob Oriet, Forest Grove, OR, in 3rd and 4th.

In the early bird events, Gary Rose, Pasco, WA, not only cleaned up the "Q" money in the High Rollers, he also won the 4-player play-offs. In fact, the playoffs proved to be a waste of time, as they paralleled the qualifying round scores, with Jim Hartung (Richland, WA), DeLynn Colvert (Missoula, MT), and Willie Evans (Richland, WA) finishing 2, 3, & 4. In the doubles event, Masters Bill Becker (Bend, OR) and Paul Hatcher (Salem, OR) took the title. In the Time Passer, Dale Hatfield (Madras, OR) came out on top, and the Saturday Night event saw Thelma Weber, Vacaville, CA, nail an excellent 20 GP, 8 win card (9 game match) to pay for her trip home.

Directors Jim Waldorf and John Hatfield have an easy time of it, as the Kah-Nee-Ta facility is first rate, giving the players plenty of elbow room. And, of course, Marvis Reynolds's expertise in managing tournaments gave Waldorf and Hatfield plenty of "walking around (and playing) time."

### Jim McDonald Jaunts to Jersey...And Wins!

Jim McDonald hit the road for Gibbstown, NJ, and the "Jersey Jaunt"...and came away with a nifty win. This Monson, MA player picked up some 84 MRP's (also qualified 2nd) and his gas money home. Hugh Berry (Richmond, VA), George Rasmussen (Arlington, VA) and Cindy Veradt (Taunton, MA) finished 2, 3, and 4. Rasmussen took the "Q" money by topping the field in the qualifying round in this 52-player event.

Irvin Solomon, Cranbury, NJ won the 34-pegger Consolation, edging Jerry Bernier, Wales, MA, in the final match.

## "Bag Lady" Finds Fortune

Marvis Reynolds is a fixture on the Northwest circuit, as she manages the bookwork and playoff boards for many tournaments, in addition to handling her many vinyl bags of entry fees.

In Salem, OR's Capital City Classic, Paul Hatcher collected some \$550 in entry fees for the Saturday Special, and deposited the money in one of Marvis's vinyl bags. When the tournament wound down, and the winners were paid in the Consolation and Main Event, director Fabian Nelson thought he was a little short, but he wasn't sure.

A month later, at the Prineville Benefit event, Marvis opens one of her vinyl bags, and, Eureka! \$550! And to Marvis's credit, Fabian was notified, and we have a happy ending to the story!

# American Cribbage Congress Hall of Fame

## Hall of Fame Nominating Criteria

1- All nominations for the American Cribbage Congress Hall of Fame must be submitted in writing to the Chairman of the Balloting Committee.

2- An individual nominated for the American Cribbage Congress Hall of Fame must meet the following **mandatory** criteria:

A- be a member in good standing of the ACC for seven (7) consecutive years or have been a member for a minimum of five (5) consecutive years until death intervened.

B- have displayed and complied with the rules of ethical play.

C- have displayed and complied with the standards of good sportsmanship.

3- In addition, to be eligible for nomination, a candidate is required to meet at least three (3) of the following **optional** criteria. He or she must have:

A- promoted the game of cribbage and/or served the American Cribbage Congress by specific acts or as specified in the written nomination.

B- established his/her expertise by being rated a Master player or higher.

C- established his/her expertise by being rated a Bronze Award recipient or higher in Grass Roots competition.

D- served as a Tournament Director, or Co-director, of an ACC sanctioned tournament for a minimum of five (5) years.

E- served as a Grass Roots Director, or Co-director, for a minimum of five (5) years.

F- served as a member of the Board of Directors of the American Cribbage Congress for a minimum of four (4) years.

4- Any exceptions to or exemptions from the above criteria must be initiated by a current member of the ACC Board of Directors.

## Hall of Fame Balloting Procedures

1- Publish annually in the January or February *Cribbage World* the criteria for nominating individuals to the Hall of Fame. Declare that nominations are currently being accepted and must be in written form to the Chairman of the Balloting Committee of the ACC postmarked not later than 15 April of that year.

2- The Chairman of the Hall of Fame Ballot Committee will review all letters of nomination received for compliance with the nominating criteria and submit those letters to the Ballot Committee.

3- A Ballot Committee consisting of three (3) members of the Board of Directors shall be established to conduct the voting process for the Hall of Fame. The committee will prepare copies of the nominating letters and ballots which will be mailed to each member of the Board of Directors, each Director of an ACC sanctioned tournament, and each active Grass Roots Director on record as of 1 August of the previous year. All ballots must be postmarked not later than 15 June to be counted. No individual tournament or club will be allowed more than one ballot. The results will be tabulated by the Ballot Committee and announced at the July meeting of the Board of Directors. The National ACC Tournament Commissioner and the National Grass Roots Commissioner will provide the names of tournament and club directors to the Ballot Committee at the February Board of Directors meeting.

4- Votes may be cast for any or all of the nominees. A candidate must receive at least 75% of the ballots cast to be elected to the Hall of Fame. Each nominee will be notified of the results of the balloting applicable to him or her. The President of the ACC will notify in writing any members who are elected to the Hall of Fame. Induction will take place at the Grand National tournament held in September.

### Another Virginia Classic Scheduled


November's issue of CW had the "grapevine" praising the upcoming Virginia Beach Classic, scheduled for February 18-20.

## Rules, Rules!

I've got a rules question and I don't know who to ask. It involves a situation I've seen in our local tournament and in major tournaments.

The situation is simple. A player with first count and enough points in hand to win ignores a final "go" and, instead, pegs the hand to win the game. Some people around here think that the player has made afalse claim of game (Rule VIII - Section 4a). They say the player pegged into the game hole on a one-point "go," and therefore had insufficient points to win. Others say the player had sufficient points to go out and should not be penalized on such a technicality. The former think the penalty should be according to Section 4b.

The situation obviously involves slightly sloppy play. The point is, the player took no excess points. If anything, the player missed a point and might be liable under Muggins, if it were in effect. What do you think?

*In my opinion, if the player has laid his hand on the table fully exposed, and, indeed, does have sufficient points to win, he wins! The cards speak for themselves! You need not take your "go" if you so chose...except, as you say, if Muggins is in effect, then a case is certainly made for a missed point. Let's be good sports! This player has obviously won the game! No penalty, please! I pleaded with the BOD years ago to "lighten up" on their pegging out rule, as players who had obviously won the game had them stolen away because they carelessly failed to peg out, even though their hands, fully exposed, clearly showed they had sufficient points to win. However, the majority of the BOD felt otherwise. A word to the wise for all our players: Learn to play by the rules...this will eliminate much hard feelings and problems of this nature! Be especially careful around the "game hole!" Ed.*

## **Please, NO Mandatory Membership**

I disagree with the rule that cribbage players must be members of the ACC in order to participate in an ACC-sanctioned tournament.

I used to have unbounded respect for the ACC Board of Directors (BOD) because it was obvious that the BOD's first loyalty was to the game of cribbage and those who play it, but it appears that avarice has reared its ugly head. It seems that the desire to increase the ACC's coffers has overcome all other considerations of the BOD. What a shame, since history has shown that excessive greed has been the downfall of many organizations.

What about the casual cribbage player? The one who is not on the tournament trail but still loves to play the game. I have some of these casual players who attend my tournament, and it is the only one which they do attend. In my recent Jersey Jaunt, 9 of the 52 players (17%) weren't ACC members (although one asked for an application). One of these players was a wheelchair-bound patient from the VA hospital. Why should he be forced to join the ACC to play again next year? I posed the question of required membership to members of the BOD and was told that non-members get ACC benefits for which they don't pay, such as standardized tournament rules, qualified judges, etc. That is really not true, because \$1.50 of the entry fee goes to the ACC, so all players are paying the same.

As a matter of fact, if required membership remains in effect, the casual player will pay more for playing in one tournament than a player who goes to several, i.e., a one-tournament players pays \$7 (ACC membership) for one tournament, but a player who attends 7 tournaments pays only \$1 per tournament. That hardly seems fair.

If the ACC really needs more money, increase the player's fee per tournament from \$1.50 to \$1.75, but first let the ACC membership know why all the extra money is required. Members of the BOD, please rethink the membership rule.


## Grand Slam...and a String of Pearls

## Help!

Here's one for the books (*Cribbage World & Rule*) that occurred last week in our club. I probably ruled wrong. What's the answer?

After the play, Pone was 10 points from the game hole and the back peg was 10 holes further away. Pone had a 10 hand **BUT** picked up the **FRONT** peg and placed it in the game hole. Dealer protested.

After 15 minutes of discussion and 30 different opinions from our 20 players, I decided as follows: when Pone picked up the front peg, the back peg immediately became the front peg. Because Pone had not pegged incorrectly, Pone was then allowed to peg 10 and again ended 10 points from home. No penalty points were assessed for placing the front peg in the Game Hole (falsely claiming game) because Pone had properly pegged the 10-point hand, albeit with the front peg.

If I had to do it over, I might declare Pone the winner because, being only 10 holes out with a 10-point hand, all Pone had to do was place a peg in the game hole. Some might argue with that because, if there was a count dispute, there would be no proof where Pone's front peg had been. However, in this case, there was no dispute concerning the facts.

I can't find a definitive answer in the *Rule Book*. Help.

PS: My ruling cost Pone first place; glad I'm not married to her.

*As a Senior Judge, I would concur with your ruling. Picking up the front peg is a no-no! It immediately becomes the back peg and points earned are then pegged from that point. Tough break to lose first place that way. And it obviously was not a false claim of game, as witnesses and the players agreed where the front peg was. The opponent may have had a case for a false claim of game if he claimed her peg was 11 (or more) points from the Game Hole. However, in this instance, it appears this was not the case.*

*I witnessed (and co-judged) an important playoff match in Reno where a player pegged three of a kind for "six"...pegged the six and waited a brief instant for his opponent's response as to whether it was also a "go" or not. Not getting an immediate response, he let go of his front peg, moved his hand about five inches from the board, and then his opponent said "go." He reached back and pegged the point with his front peg...a procedure that he would normally do all in one motion ("six and a go for seven, pegging seven). This habit cost him the match, as he made the fatal mistake of letting go and then picking up his front peg! This was a tough call but rules are rules. Be careful everyone! Ed.*


