13th Annual Smashes Attendance Record

Ron Sather Tops Twice In Marinette James "Tubby" Dahl Takes Wheelchair Consolation

A record-breaking 183 peggers descended on Marinette, WI, April 8, 9, & 10 for the 13th running of the Tri-Cities Open...and Ron Sather, Northfield, MN, came away a double winner!

Not only did Sather take top qualifying honors, but went on and claimed the championship.

1993 All-American John Hiland, West Allis, WI, almost repeated his 1993 win at this tournament, but had to settle for 2nd money, as Sather was not to be denied.

Donna Aird, Gladstone, MI finished 3rd, followed by Marlene Lazachek, Greenfield, WI in 4th.

James "Tubby" Dahl (Blair, WI) came out winners in the all-wheel-chair finals in the 100-pegger Consolation event, as he edged Karen Danielski (Green Bay, WI) for the title.

Joe Aird, not to be shown up too badly by his wife (3rd-Main), finished 3rd in the Consolation, followed by tournament director Robert "Mick" Michaelis in 4th. Mick earned 42 MRP's and is edging in on his Life Master, One-Star (10,000 MRP's). However, he earned this honor three weeks later. (See inside story).

Al Schaefer (Milwaukee) took the All-Events title, Life Master Warren Sondericker (Greenfield, WI), and Clarence Charles (Seymour, WI) took the Friday and Saturday night \$50 Classics. Helen Railsback (Syracuse, NE), and Al Schaefer took top honors in the Friday Early Bird and Saturday Night Special.

This 13th Annual event topped all previous attendance records, attesting to director's Michaelis expertise (and experience) in running ACC sanctioned tournaments.

In this issue's Centerfold **Revised Constitution and By-Laws**

At the recent Board of Director's Meeting in Reno (February, 1994), members voted to amend the American Cribbage Congress's Constitution and By-Laws.

This issue has the updated version (as a centerfold). The changes are minor. The major change is **scheduling only two BOD meetings per year...**at the Grand National and the JPW/ACC Open in Reno.

Locals Nail World Championship

Bart Hurley Tops 256 Peggers In Quincy

Quincy, California lays claim to being the World Capital of cribbage...and after the 23rd Annual World Championship matches wound down and three of the top four places went to the locals...well, they may have a strong case for their claim.

Bart Hurley (Quincy) nipped 1985 Champion Plumas Stokes (Quincy) and took home the grand prize (\$1,500). Another Quincy player-Laurie Logan--captured 4th place. Third went to Jim Langley (Red Bluff, CA).

And the Quincy peggers also nailed the doubles event, with Dave Joseph and Sharon Foley sweeping this Friday early bird event.

122 peggers played the Consolation, and LaDonna Govenor from nearby Napa won the title, followed by the streaking Gary Sand from Sunnyside, WA. John Card, Santa Maria, CA took 3rd, and Ed Horgan from Virginia Beach, VA nailed 4th...and the 56 MRP's will keep Ed among the top ten nationally, running his yearly tally to the 900 mark.

But the big news concerning Master Rating Points belongs to Milwaukee's **Bob Julian**. He qualified 2nd (83 MRP's) and finished in the 9-16 bracket (166 MRP's) to wing it over the 1,300 mark for the year, taking over the top spot nationally.

Ron Morgan, formerly from Quincy, and now a Missoula, MT resident qualified 6th (72 MRP's) and earned the 185th Master Rating awarded by the ACC.

Dave Thorne, Sonora, CA, played only the 2nd 29-hand ever in the 23 year run of this tournament...and the 12th of this cribbage year in sanctioned play. The ACC will pay Dave a cool \$100 for this gem.

The Saturday night High Rollers was won by Cedric Larson, Forestville, CA, and the Cry Baby was split by local Dave Gott and Mike Clements.

The 10th Annual \$100 Kozlowski Memorial award (awarded to the high qualifier from Nevada) went to Cheryl Mussell of Sparks.

Directors Mike Taborski and Dan Smith ran a first-class tournament, kicked off by a well-done National Anthem sung by Teri Gallagher. Following the anthem came a procession of 4th Street Terrorists (Wayne Glashan, Sundae-Webb Wiley, Jesse Jarrell, and Steve Reynolds) down the aisles wearing huge playing card placards proclaiming their exploits in recent events. This was brought on by last year's crowned champion (local Ev Bey) being carried in on a throne.

This tournament is sponsored by Quincy's Rotary Club, and benefits many community projects. In addition, this year's event was dedicated to the memory of co-founder Bob Moon, and to Faye Bey, the late wife of Ev Bey (another co-founder).

Was That Nine-Year Old John McNair?

John McNair, Boston, MA, flew out to San Francisco by himself, and was then driven to Quincy for the World Championship match by his uncle (Roger Ryan, Meadow Vista). John is only nine years old, making him the youngest...and he came the longest distance to play!

Husband-Wife Sweep Atlanta Classic Peggy and Ken Goss Play Championship Match in Atlanta

In a rarity, Peggy and Ken Goss (Mr. and Mrs.) played for the recent Atlanta Classic title. With Ken leading the best 4 of 7 match at three games to two, Peggy came on like Gangbusters and skunked Ken for a two game win...and took home the title.

This McLean, VA couple went home as happy as newlyweds, and will redecorate their home with two plaques.

Betty Schaeffer, Kissimmee, FL, finished 3rd, followed by Ken Cambell, Modoc, SC.

High qualifying honors went to Clyde Awtry, Acworth, GA (31-14+141).

The Consolation was won by tournament director Bobby Stuart (Lawrenceville, GA), edging Dave Ritchey, Orange City, FL.

256 Peggers

Len Roberts Cops Rhode Island Open

After qualifying 48th, Len Roberts, Mattapoisett, MA, came on strong and nailed the 256-pegger Rhode Island Open April 17. Neil Matheson, Fairhaven, MA, came close, but had to settle for 2nd place in this record-setting tournament.

Roch LePage from nearby Wilton, CT finished 3rd, followed by David Marchick, Lincoln, RI, in 4th.

The Omni Hotel was buzzing with the large crowd in downtown Providence. This 13th annual event saw Phyllis Aronoff, Quincy, MA, top the field in the 12-game qualifying round, with Paul Gallagher, Avon, MA, close behind.

But after the qualifiers played a round-robin playoff (10 games), the marbles belonged to Roberts. The top four played a best 3 of 5 final.

The Consolation drew a sizeable 166 peggers, and Jeffrey Del Santo, Warwick, RI, took home the title, edging Brenda Palmer, W. Springfield, MA. Paul Finley, Enfield, CT, finished 3rd and Marguerite McKenna, Bellingham, MA took 4th.

Director Joe Ramos reported that this 13th annual set a record for attendance. He also reported that each player contributed \$2 to the Muscular Dystrophy Association. The 14th annual is planned for April 30, 1995.

Leo Lawrence Takes Milwaukee Challenge

With 156 peggers in the field, Leo Lawrence from nearby West Allis came away the winner in the recent Milwaukee Challenge (played in Menomonee Falls, WI). Another West Allis player...Rudy Rogutich...nailed 2nd, and Richard Horvath (Milwaukee) took 3rd, followed by Life Master Jim McManus (Milwaukee) in 4th.

John Stamschror, Waukesha, WI, won the 89-pegger Consolation, with Canadian Frank Bodogh taking 2nd.

Grand National XIII Directors Warming Up? Ron Hamilton, Joan Rein Nail Hawkeye Classic VIII

The upcoming Grand National will be played in St. Paul, MN, this September...and the directors are Ron Hamilton and Joan Rein.

At the recent Hawkeye Classic VIII, this pair of peggers took home all the marbles, with Hamilton finishing first, and Rein taking 2nd. Are they warming up for the Grand National?

Life Master Joe Bernard, Libertyville, IL, finished 3rd, and Grand Master Syl Lulinski, LaGrange Park, IL, took 4th. Both players are in the thick of the MRP race this cribbage year. Bernard tacked on another 99 MRPs, and Lulinski picked up 90.

111 peggers played the Main Event, and some 74 stayed for the Consolation. Perennial winner Buzz Railsback, the Syracuse, NE King of Cribbage picked up the Consolation win. Larry Smith, Ankeny, IA, came in 2nd. Russell Adams, our pegging professor from Minneapolis, and Norbert Kniech, Brown Deer, WI, came in 3rd and 4th.

Tournament director Larry Loupee is planning on renewing this match again next April 29, 30, and May 1, 1995. Mark your calendars.

195 Peggers In Lincoln City Laurie Logan Takes Oregon Coast Classic

Laurie Logan, Quincy, CA, took on a huge field of 195 peggers in Lincoln City, OR, May 15, and came away the Oregon Coast Classic winner. Just a week earlier, Laurie nailed the World Championship match for a 4th place finish, and, combining the two events, added nearly 500 MRP's to her total for this cribbage year...one of this year's better runs by any player nationwide.

John Hardy from Portland came close, but settled for 2nd. Two Rohnert Park, CA, players took 3rd and 4th...Alice Wilson and Dean Wooldridge.

Ed Ristom, El Paso, TX, was a long way from home, and he went home all smiles as he nailed the high qualifier spot, taking home a huge trophy. He scored a nifty 38 17 +271.

Harvey Honeycutt, Beatty, OR, captured the 136-pegger Consolation (and adds to his Grand National laurels), besting the streaking Willie Evans in the final match. Willie picked up 65 MRP's for this fine effort and wings it to the 900 MRP mark for this cribbage year, keeping alive his top ten chances for the 1994 season.

And Bob Julian, Milwaukee, WI, finished 3rd, earning 61 MRP's, sending his season's total to a whopping 1,405 nation-leading total. He confided to *Cribbage World* that he has scheduled at least eight more tournaments in winding down this year's play...making him almost a shoe-in to nail national honors. In addition, Bob is but a scant 13 MRP's short of earning Grand Master.

Mary Stoll, Crescent City, CA finished 4th.

In the satellites: Early Bird; Merl Mulkey, (Keizer, OR). High Roller; Tom Jackson, (Bandon, OR). Doubles: Brent Southan (Salem, OR) & Todd Sampson (Eugene, OR). Saturday Night; Charlie Ball (Mesa, AZ). Cry Baby; Jeff Monroe (Napa, CA).

The 195 peggers set a new mark for this tournament, making directors Bernie Nelson,

Jeanne & Roy Hofbauer, and Rollie Heath and crew well satisfied. Adding to this tournament's popularity is the location. The Pacific Ocean and the natural charm of the area will certainly bring players back time after time.

Only 187 players have earned this honor in the 15-year history of the Congress. A player must earn some 2,000 Master rating Points to join this elite group. Keep pegging!

Paul Hatcher directs Salem's action...and he offered \$10 to the player that beat *Cribbage World* editor Colvert the worst! What a dirty turn of events! Of course the very first player (Bob Landon) won by 37 points to take the ten spot!

Mildred Wolf Scores **RARE** 29-Hand

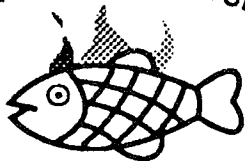
Mildred Wolf, Schroeder, MN, was busily pegging in the Hermiston Open April 30, when, out of the blue, up popped a rare 29-hand.

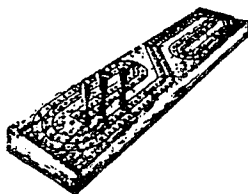

hot hand in the qualifying round and took honors. Dellinger, in a foreboding preview of the playoffs, was 2nd.

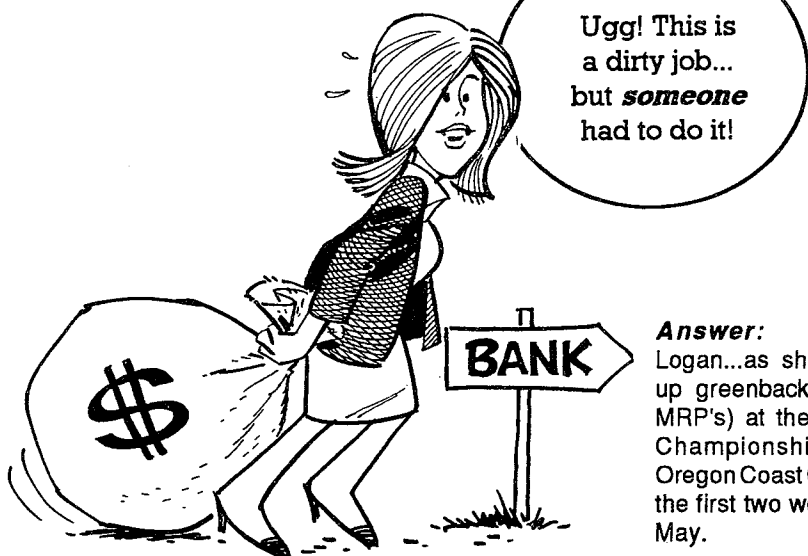

Constitution and Bylaws

of the American Cribbage Congress, Inc.

ARTICLE I: Name

- a. This organization shall be known as the **AMERICAN CRIBBAGE CONGRESS, INC.** (hereinafter called the Congress).
- b. If required by the law of the State in which the Congress is incorporated, the Congress shall maintain an office of record in that State, but the principal business office and other necessary offices shall be located wherever the Board of Directors deems it appropriate.

ARTICLE II: Objectives

- a. To foster the spirit of good-fellowship and interest in the game of Cribbage, and to establish rules and regulations governing sanctioned play in all organizations officially affiliated with the Congress.
- b. To establish a system for advance sanctioning of all organized play for which rating points are awarded, and to publish procedural guidelines for conducting sanctioned competition.
- c. To manage the income and expenditures of the Congress through the budget process at the national level, and to insure that income and expenditures related to sanctioned tournaments are in compliance with guidelines published in ACC Regulations.
- d. To establish a schedule of membership dues and other fees required to operate the Congress on a non-profit basis.
- e. To develop and publish ethical standards governing the behavior and play of all Congress members, to outline the method for documenting and reporting alleged breaches of published ethical standards, and to establish procedures to be followed by the Board of Directors in dealing with reported breaches of ethical standards.

ARTICLE III: Members

- a. Any individual not officially barred from membership in the Congress is eligible for membership upon submission of an Application for Membership, together with the fee established for his/her class of membership.
- b. Memberships shall be classified as (1) Regular, (2) Junior (under 18 years of age), (3) Life (over 59 years of age), and (4) Any others established from time to time by the Board of Directors.
- c. Voting rights of the general membership of the Congress is limited to its election of individuals to serve on the Board of Directors of the Congress. The only way that ACC members not on the Board can individually influence the operation on the Congress is through its elected representatives on the Board of Directors.

ARTICLE IV: Board of Directors

- a. The management of the Congress shall be vested in its Board of Directors, which shall consist of twenty-five (25) members in good standing elected by mail ballot of all members of the Congress. The terms of service of all Directors shall expire August 31st of odd-numbered years. New terms of office commence September 1st of odd-numbered years. (Effective with 1995 election.)
- b. Any member of the Congress is eligible to be a member of its Board of Directors. All that is required for that member's name to be placed on the ballot is for that member to be nominated in writing to the Nominations Committee, either by another bona fide member of the Congress, or by himself/herself. The nomination must be accompanied by a statement signed by the nominee that he/she is willing to serve as a Director, if elected, and to be appointed to at least two standing or ad hoc committees during his/her term of service.
- c. No more than ten (10) members of the Board shall be elected from one Region.
- d. No less than six (6) members of the Board shall be elected from one Region.
- e. No more than four (4) members of the Board shall be elected from one State.
- f. When more than the number of nominees specified in Sections c and e (above) are among the top twenty-five (25) finishers in the election, those with the least votes who exceed the ceilings specified in Sections c and e (above) will be passed by in the election process.
- g. Vacancies on the Board that occur between elections shall be filled for the unexpired term by Presidential appointment, with the concurrence of a majority of the Executive Committee.
- h. A Director who misses 50% or more of the Board meetings scheduled during his/her term (unless excused by the Executive Committee) shall be removed from the Board by the President and replaced by an appointee as soon as practicable. A person so removed from the Board of Directors shall be barred from running again or serving as a Director.

ARTICLE V: Officers

- a. The Officers of the Congress shall consist of the President, Executive Vice President, Vice President- Policy, and Vice President- Operations, selected for a one-year term by majority vote of the Board at the Annual Meeting held in conjunction with the Grand National Tournament, plus a fifth Officer (Executive-Member-At-Large) without functional designation, to be nominated from the floor and selected by majority vote of the Board.
- b. In the event that the Office of the Presidency is vacated, due to death, resignation, or removal action by the Board, the Executive Vice President automatically becomes the Acting President during the period that remains before the next Annual Election of Officers. The Acting President is authorized to appoint Officers to fill other vacancies that occur during the same period.

ARTICLE VI: Executive Committee

- a. The Executive Committee shall consist of the Officers of the Congress.
- b. No more than two (2) members of the Executive Committee shall be elected from one Region.

c. Executive Committee members shall be elected in the sequence listed in Article V-a.

d. The Executive Committee shall be empowered with authority to act for the Board between meetings, subject to Board ratification of a written Report of Actions Taken by the Executive Committee, submitted by the Executive Committee at each of the scheduled Board meetings.

e. The Executive Committee shall meet at least once, either face-to-face or by conference call, between each scheduled Board meeting.

f. A limitation on the dollar amount that the Executive Committee can approve for expenditure shall be established in ACC Regulations.

ARTICLE VII: Other Committees

a. Five Standing Committees, operating on a continuing basis, shall be appointed by the Executive Committee, with the terms expiring after August 31st of odd-numbered years. At least one member of the following four committees must be a member of the Board of Directors:

- (1) Rules Committee
- (2) Tournament Guidelines Committee
- (3) Public Relations/Publicity Committee
- (4) Grass Roots Program Committee

b. A fifth Standing Committee, "with power", shall be established and its members shall be appointed by the Executive Committee following the Annual Meeting, with terms expiring after August 31st of odd-numbered years. *All* members of this committee must be members of the Board of Directors, and each Region shall be represented on the committee.

- (5) Ethics Committee

c. Special (ad hoc) Committees, operating under guidelines contained in ACC Regulations, shall be appointed by the various Officers of the Board of Directors. Members of these committees need not be members of the Board of Directors, and as soon as the tasks for which they were created have been completed, they shall go out of existence.

ARTICLE VIII: Meetings

a. Two meetings of the Board of Directors shall be scheduled each year in conjunction with the two ACC-sponsored major tournaments, the Tournament of Champions during the period of January-February, and the Grand National Tournament during the period of September-October. The latter shall be known as the Annual Meeting. The only difference between the Annual Meeting and the other scheduled Board meeting is that the annual report of Officers and Standing Committees and the annual election of Officers for the ensuing term shall be on the agenda for that meeting. (Effective immediately.)

b. Board members shall be informed of the date and time of a Board meeting sufficiently in advance to make plans to attend. An agenda for the meeting and any available advance materials shall be provided for their review before the meeting.

c. A quorum of the Board of Directors shall consist of thirteen (13) members.

d. No proxies shall be allowed in voting on questions presented to the Board.

ARTICLE IX: Amendment of Constitution and Bylaws

a. Any provision of this document may be amended or repealed by a two-thirds affirmative vote of the Directors present, provided that any such proposed action is forwarded to all members of the Board of Directors at least thirty (30) days prior to the meeting at which it is to be considered.

b. The effective date of any such action shall be the following September 1st, unless a different date is specified at the time the action is taken.

ARTICLE X: Ethics

a. Documented violations of ethical standards in sanctioned Cribbage competition shall not go unpunished. Examples of actions considered unethical shall be publicized, and a continuing effort shall be made to advise players to watch for such actions and to report them to tournament officials when they occur. Tournament officials shall be advised to document the reported violations, regardless of how insignificant they seem, and to submit them to the Ethics Committee for possible action, or future reference in the case of repeat offenders

b. The Ethics Committee shall receive all reports of alleged ethical standards violations. Before taking any action on a complaint, the Committee shall inform the alleged offender of the nature of the complaint that has been received, and ask if he/she wishes to submit a defense within 30 days. If the alleged offender fails or declines to respond, and the Committee feels that the breach is not serious enough to warrant expulsion, the Committee may immediately impose a punishment (of less than expulsion), and inform the alleged offender of the punishment imposed.

c. **As a minimum, sworn affidavits by not less than two (2) reputable members of the Congress, containing the facts and circumstances of the reported conduct or action, from the affiants' personal knowledge, shall be required to initiate expulsion proceedings.** If the Committee feels that the breach is serious enough to warrant expulsion, the complaint is referred to the full Board for action, and the alleged offender is informed of the referral. If the Executive Committee of the Board feels that expulsion is warranted, the alleged offender is informed that the matter is being referred to the full Board for action, and that he/she is barred from further sanctioned play until the matter is resolved. A date for the hearing by the full Board is set, and the alleged offender is offered a reasonable opportunity to appear before the Board if he/she desires, and/or to file counter-affidavits concerning the circumstances. He/she shall, upon request, be furnished copies of the complaining affidavits not less than thirty (30) days prior to consideration by the Board.

d. If the Board concludes that the complaint is not serious enough to warrant expulsion, it will be referred back to the Ethics Committee for imposition of a lesser punishment.

e. If any member is suspended or expelled, that fact (only) shall be included in the next regular publication of the Congress.

Is This A Tournament of Champions?

Would you consider these changes as reasonable for national and world sporting events: A 38-minute Super Bowl?

A 4 game/6 inning per game World Series?

A 9 1/2 round World Heavyweight boxing match?

A 64 yard dash (instead of 100 yards)?

All of these represent a 36% reduction in the usual time or distance of each if these events.

If you say unreasonable, as I do, then why in the world do we accept as reasonable just such an abbreviated format for determining the champion of our own Tournament of Champions? The 14-game TOC we now have is but 64% of the 22-game tournaments that most of us are accustomed to playing in during the year to reach the TOC. Shouldn't those competing for the title be playing on a field of about the same distance as the ones they have been playing on all year long?

Now I know the **powers that be have a somewhat compressed time frame to work with** but getting this prestigious tourney up to say a more representative 18 games should add no more to the time schedule than what we are now dealing with.

The following, I think, constitute some very valid reasons for considering such an expanded format:

1. In a 14-game tourney, an early loss of 3 games in a row and you are just about dead in the water...from a practical standpoint your day ends pretty early.
2. In a tourney of 18 games there are comeback possibilities and you might well survive two such 3-game losing streaks and still make the finals.
3. In the longer tourney, a winning % of 66.67 will almost always get you into the finals and a 70% win rate will invariably do so. Not so in a 14-game tourney...a 66 2/3% win rate and you can most likely head for the showers early. 70% is no guarantee either. If you have

low spread points, you may very well be on the cusp and singing the blues.

The expanded format as suggested could very simply be accomplished by reducing the number of playoff games from 3 of 5 and 4 of 7 for the final match to 2 of 3 and 3 of 5 for the final match, which is customary for a 1-day tourney. Moving in this direction would probably require no increase in the time frame and might even reduce it by virtue of the reduced number of games required in the playoffs.

Are any of you out there, including members of the BOD of a like mind on this suggestion, or does the present dwarfed format seem more logical?

Pat, I agree that a prestigious event such as this should have a full format...but, you answered your own question (bold face, para. 2). Every year the number of players increase. This year's 402 created a monstrous logistical problem. A huge Main Event and a Consolation (246) in the same day! This event began in Las Vegas in 1982, and since very few players were qualified for the TOC in the early days of the Congress, a sister-event was held so that more players could attend. Perhaps we've outgrown this "doubleheader" concept...but, I'll bet, if put to a vote, the majority would leave it as is. If you bomb out in the shortened TOC, you can still win \$10,000 in the following JPW/ACC (full format) Open! This doubleheader is the highlight of the cribbage year! And the players are voting with their feet...and their airline tickets! Ed.

George Bickford Professional "Starter"

The Eastern Region's Tournament Commissioner gets 'em started playing cribbage! But did you know George also gets 'em started at the Oak Ridge Golf Club in Agawam, MA? The Agawam News showed it all...there was George with his 3-wheeled golf cart, emblazoned with 'STARTER' on the front. You could almost hear him saying "Get the lead out! ... and no fivesomes!"

Would Mandatory Membership Work?

In response to Harry Kantas' letter (May CW), I would like to offer my viewpoint as a BOD, Tournament Director, and Grass Roots Club Director. Mr. Kantas claims he was astounded by the 23-4 vote to remove mandatory membership for play in ACC tournaments, and I can't blame him. I feel he has many fine arguments as to why we need mandatory memberships but I would like to add a few more reasons to DeLynn's list of why we can't and won't force a player to join the ACC.

From a Tournament Director's point of view, try to imagine the nightmare of asking each and every player to produce a membership card upon arrival at your tournament, and telling them to leave if they don't have it or refuse to join on the spot. Lets say three guys from Marinette, WI, Yankton, SD, and Missoula, MT, respectively show up at Pat Llewellyn's tournament next March in MA but can't produce ACC membership cards. Would you ask them to leave? Not me! I can't see myself or any other Tournament Director taking on such a huge job while trying to get 50 other things done at the same time during the weekend.

As DeLynn said, every tournament player pays his "dues" through the entry fee, as \$1.50 goes back to the ACC for each player, member or not. Many people play in the MGM in Green Bay every year that are not members, and that is the only tournament they ever play in. They don't care about MRP's, the tournament trail, or the ACC, but that is their right and privilege as long as they paid their entry fee. If you force these people to join, they may not ever play there again.

As far as I can see, anyone who does not want to join the ACC is missing out on an inexpensive way to become a member of an elite group of people. If they told me the dues went up to \$50 a year, I'd pay it, but that's up to me and nobody else!
