# Bobby Stuart! Joe Aird Wins Consolation

In the early 1900's, Ty Cobb ruled the baseball diamond...and he was nicknamed "The Georgia Peach!" And as the 1900's roll to a close, yet another "Georgia Peach" has come to the fore, and in another sport. Cribbage!

Bobby Stuart, pegging out of Lawrenceville, Georgia, came away with the championship at Daytona Beach's Grand National XVII. In besting a large crowd of 284 peggers, he took home bragging rights, 252 MRP's and a bushel of prize money. In last year's action, Stuart nailed 516 MRP's and was among the Eastern Region's top 25, but the 1999 pegging season may even be better for Stuart as he is among the national leaders in the early going.

His final playoff match had him pitted with Lissa Mooradd, South Hadley, MA. The match see-sawed back and forth, but in the final two games, Stuart pulled away and came away with the win. Mooradd, in finishing 2nd, had a stellar tournament, nailing 196 MRP's and a sizeable runner-up check.

Life Master Larry Samet (MA) had a great tournament, finishing 3rd, and was a member

of the winning 5-person team play. With the 147 MRP's earned, he vaults to 15th place in the ACC's lifetime standings (7,800 MRP's). John J. Rooney (MA) finished 4th...and is moving in on his Grand Master rating.

Brian Heroux (RI), the ACC's youngest Life Master (age 24) also had a great tournament. He nailed the top qualifying round score (a 38 GP card) and led his 5-person team to a winning score. He also fared well in the Friday High Roller event, running his total awards to over the four-figure mark.

Grand Master Joe Aird (MI) came away with the Consolation title, edging Bruce Sattler (MD) in the final playoffs for that honor. Peter Setian, a newlycrowned Grand Master (MA) came away with 3rd, followed by Glenn Gauthier (WI) in 4th. Bob Brown (WI) topped the 213-player field in the qualifying round.

### The President's Column

### **Grand National XVII**

Congratulations to Paul and Joy Barnes and John Groz, co-directors of the highly successful Grand National held October 16-18, 1998 at the Ramada Resort, Daytona Beach, Florida.

They surprised themselves when 284 cribbage players showed up to participate in the seven tournaments that ran over the three-day event, despite a 180,000 crowd for a re-scheduled NASCAR race at the speedway the same weekend, a sellout of all available hotel-motel rooms, followed by a weeklong Biketoberfest when thousands of bikers with fancy Harley-Davidson motorcycles invaded the beachtown resort.

Topping off the festivities was a popular Hawaiian luau banquet Saturday night which preceeded the humongous awards presentations: four Life Master-One Star (10,000 MRP's) awards; six Life Masters (6,000 MRP's); 24 Grand Masters (4,000 MRP's); 46 Masters (2,000); 21 perfect "29" hands; the ten-person 1998 All-American team led by Paul Hatcher and his travelling buddy, DeLynn Colvert, each with 1,331 points; three Central Region All-Regional honors; four Eastern Region All-Regional honors; the President's Award to Steve Sattler, publisher of ACC's Web site on the World Wide Internet; as well as awards to more than 100 Grass Roots champions, etc.

Frank Abernathy, Raleigh, NC, also donated \$300 to the Youth Fund in the name of the late Nick Pond, honoring two tournament directors who showed great gains in participation: John Thiems for 1997 and Al Lindner for 1998, \$150 each. Previously he had given trophies to two tournament directors, Ev Bey for the Arizona Roadruner Championship, 1995, and Mike Taborski, World Championship, 1996.

Al Lindner made a successful bid for the XIX Grand National to be held at the Ramada Inn in Eau Claire, WI, in the year 2000, Sept. 22-24.

Next year's Grand National, the XVIII, will be held at the Riviera Hotel-Casino in Las Vegas on Sept. 10-12, 1999. Room rates at \$68, according to Bob Julian, co-director.

It was with much regret that I accepted Martha Fingleton's resignation from the ACC Board of Directors. She has served in that capacity for the past 10 years, now noting it was time to step aside and let "new blood" take over. She and Warren Sondericker will be getting married Sat., Nov. 28, 1998 at the Clarion Hotel, Milwaukee, WI.

With approval of the Executive Committee, it was my pleasure and privilege to appoint Al Lindner, Eau Claire, WI, to succeed Martha on the ACC Board.

Seven Senior Judge appointments were announced by Jeff Shimp, Commissioner of the Judges Program: Bobby Stuart, Lawrenceville, GA; Jack Howsare, Virginia Beach, VA; Wayne Steinmetz, Milwaukee, WI; Sundae Webb, Pittsburg, CA; Jim Keeling, Spokane, WA; Roger Wilson, Boulder, CO; and Jones Hom, Fairfield, CA.

Seeking to elicit a greater voter turnout at the next ACC Board of Directors election, in 1999, the Board voted to send all ballots via first class mail rather than insert them in *Cribbage World*, which was done previously. The additional cost, \$3,000, is expected to be justified if it prompts a larger ballot response.

With the Joseph Petrus Wergin Open tournament topping out at the Sands Regency's maximum, 1,024 participants, Tournament Director Scott Kooistra suggested several options: qualifying rounds on Friday as well as Saturday, or two qualifying shifts on Saturday, 8 AM to 1:30 PM, and 3 PM to 9:30 PM. Directors will debate removing the 1,024 ceiling at the next BOD meeting in February.

My sincere appreciation to the Barnes-Groz Grand National directors for a job well done. Congrats to all the winners and award winners who participated in this great event.

A highlight of the tournament saw Betty Shaeffer, Kissimmee, FL play the only 29-hand! This rare hand popped up in the Consolation playoffs.

28-hands were scored five times. In another rarity, Gina Daesch (FL) scored a 28-hand early on...and not to be outdone, husband Joe also scored this gem. Jeanne Hofbauer (WA) travelled some 3,500 miles to get hers. Bruce Sattler (MD) and Robert Read (FL) also nailed this 15,028 to 1 longshot.

But in another rarity, two players scored identical qualifying scores in the 22-game event. Larry Samet (MA) and Alan Schaefer (WI) both came home with 28 13 +100. And both players had +235 and -135! Since all four tie-breakers failed to break this deadlock, a coin was flipped and Samet won the toss. It proved to be important as he moved to 3rd place, while Schaefer finished 33-64.

Grand Slams? Two were scored in the Consolation qualifying round. Bruce Brown (MA) had the top score with a nice 20 9/9 +140. Anna Abbott (CA) scored a 18 9/9 +82.

The Last Chance event saw Helen Bolstad (CA) come away the winner. Alas, no MRP's for this top-ranked Western Region player. She scored a whopping 818 MRP's last season.

Lucille Simpson (NY) does her best pegging at night...in the High Rollers. She nailed the Friday event and came home 2nd in the Saturday edition to more than pay for her trip to the Sunshine State.

## Grass Roots Controversy Addressed By Ev Bey, President

By a near-unanimous vote, the American Cribbage Congress Board of Directors at its Annual Meeting on October 16,1998 at the Ramada Resort, Daytona Beach, Florida, blew the whistle on a renegade Grass Roots administration, reaffirming ACC jurisdiction over the Grass Roots program.

The new and controversial Grass Roots manual that had recently been distributed was temporarily continued in force until the next ACC Board meeting, Thurs., Feb. 4, 1999 at the Sands Regency in Reno, Nevada. The ACC Board will review it in the interim and then probably set up a committee to re-write the manual in similar style as the previous manual that was summarily replaced. The new manual practically eliminates any connection to the sponsoring body, the ACC, even discarding the ACC logo from the publication. The Grass Roots committee that re-wrote the new manual at the behest of Grass Roots officials included Lee Norris, Cathy Perkins and Steve Sattler, bypassing the ACC Board input and approval.

Election of ACC officers saw four of five Executive Board members re-elected: Ev Bey, Sun City, AZ, was elected President for a sixth one-year term; Syl Lulinski, LaGrange Park, IL, Executive Vice-President; Paul Hatcher, Salem, OR, Vice-President Policy; Jim Ready, Stoughton, MA, Member-at-Large. Bob Julian,

Milwaukee, WI, defeated incumbent Joe Ramos, West Warwick, RI, for the seat of Vice-President-Policy. In that position, he will oversee the operation of the ACC's Grass Roots program.

By unanimous vote, the Executive Committee re-appointed Gene Mikulsky, Sobieski, WI, as National Grass Roots Commissioner, giving him a strong vote of confidence for his administration of the ACC program that now includes some 4,800 members and 140 local active clubs.

The Board criticized Grass Roots leaders for unauthorzed incorporation as a separate organization and for unapproved issuance of the controversial manual, causing a tug-of-war that has been brewing for the past six months.

Besides the Grass Roots program, the Executive Committee reappointed chairmen of five other major standing committees: Rules, Lulinski; Tournament Guidelines, National Tournament Commissioner George Bickford, W. Springfield, MA; Public Relations/Publicity, Bey; Commissioner of Judges Program, Jeff Shimp, Nashville, IN; and Ethics, Hatcher, Salem, OR, In addition, Larry Hassett, Roseburg, OR, was named Assistant to Joe Ramos, Grass Roots National Statistician, succeeding Membership Secretary Jeff Monroe, who it was deemed has too much to do to handle both jobs.

To report all players would really increase the workload of all concerned dramatically. # Bruce Brown Tops Eastern States



# American Cribbage Congress Hall of Fame

### Hall of Fame Nominating Criteria

- 1- All nominations for the American Cribbage Congress Hall of Fame must be submitted in writing to the Chairman of the Balloting Committee.
- 2- An individual nominated for the American Cribbage Congress Hall of Fame must meet the following *mandatory* criteria:
  - A- be a member in good standing of the ACC for seven (7) consecutive years or have been a member for a minimum of five (5) consecutive years until death intervened.
  - B-have displayed and complied with the rules of ethical play.
  - C-have displayed and complied with the standards of good sportsmanship.
- 3- In addition, to be eligible for nomination, a candidate is required to meet at least three (3) of the following **optional** criteria. He or she must have:
  - A-promoted the game of cribbage and/or served the American Cribbage Congress by specific acts or as specified in the written nomination.
  - B- established his/her expertise by being rated a Master player or higher.
  - C-estanlished his/her expertise by being rated a Bronze Award recipient or higher in Grass Roots competition.
  - D-served as a Tournament Director, or Co-director, of an ACC sanctioned tournament for a minimum of five (5) years. E-served as a Grass Roots Director, or Co-director, for a minimum of five (5) years.
  - F- served as a member of the Board of Directors of the American Cribbage Congress for a minimum of four (4) years.
- 4- Any exceptions to or exemptions from the above criteria must be initiated by a current member of the ACC Board of Directors.

### Hall of Fame Balloting Procedures

- 1. Publish annually in the November issue of Cribbage World the criteria for nominating individuals to the Hall of Fame. Declare that nominations are currently being accepted and must be in written form limited to one (1) page to the Chairman of the Hall of Fame Committee of the ACC, postmarked no later than December 10 of that year
- 2. The Chairman of the Hall of Fame Committee will review all letters of nomination received for compliance with the nominating criteria and submit those letters to the ACC Hall of Fame Committee.
- 3. Voting will take place at the Board of Directors meeting held in conjunction with the JPW/ACC Open Tournament in Reno, NV. All attending current ACC Board members have voting rights and each eligible nominee will be voted on by the Roard.
- 4. Each nominee will be notified of the results of the balloting applicable to him/her. The President of the ACC or the Chairman of the Hall of Fame Committee will notify in writing any members who are elected to the Hall of Fame. Induction, if any, will take place at the Grand National Tournament and Awards banquet later that year.


### Abigail Cohen Tops Sierra Classic


