George Webb, a Life Master from Avon, MA came home the winner in this event, besting some 82 players...and took home 162 MRP's (after qualifying 8th). Jeff Raynes (NC) took 2nd, followed by Sean Murphy (MD), and Sharon Deane (VA) in 3-4. Jack Howsare (VA) took qualifying honors with a nice 31 13/20 +228.

Larry Phifer (NC) won the 64-player Consolation, winning his last playoff match with Tom Ballweg (VA). Paul Barnes (ACC BOD member) (FL) and Larry Gould (NC) finished 3-4. Master Lucille Simpson (NY) won 9 of 10 in the qualifying round to take honors.

At Last! Good Mail Delivery!

It took a little time, but we think we've got prompt delievry of your Cribbage World solved.

Thanks to Paul Vogel, USPS Great Lakes area, Mike Stevens at the Minneapolis Post Office; and Kenneth Sachs, also at the Minneapolis Post Office, they put us on the right track to get the job done.

If you'll notice the address on your CW, you'll note a series of some 60 little lines...it's called a "bar code"...which quickly identifies the address of the mailing piece and gets it into a speedier route delivery sequence.

When Larry Hassett took over as Membership Secretary, he waded right in and installed the \$999 Post Office automated system to cleanse and clarify our membership address system.

March issue was mailed at Richfield, MN Post Office on Friday, March 12 and I received mine on Tuesday, March 16 in Sun City, AZ. I'm satisfied with that kind of delivery!

Editor DeLynn Colvert took a little swing through the Midwest in February, so his CW work suffered a little time lapse. Add a new Membership Secretary who extended himself by installing a new addressing system and we still get delivery of our March CW at least a week earlier than was usual.

Now, when we get back to regular deadlines and printing schedule, your CW should be in your hands about the 10th of each month.

Want some comparisons? In February, CW mailed 5,775 24-page copies at a cost of \$1,517. In March, CW mailed 6,004 40-page copies at a cost of \$1,506...4% greater volume plus 66% increased size nets an \$11 reduction in mailing costs. Larry sez, "Look for a further decrease in mailing costs for CW when some 200 addresses with errors are corrected." Maybe as much as \$1,500 per year!

Well done, Larry!

One of the best cribbage publicity shots we've seen recently was in the Green Bay (WI) Gazette. It showed Mark Kropp and Kerry Paulson, both of Seymour, WI playing cribbage while waiting for fish to bite on the frozen Kewanuee River near Footbridge.

We recently had to respond several times to one of our members who insisted that an Ace, 2 twos, a three and a Jack totalled the impossible "19." The only way he could work it out was to have the pair of 2's be the same suit, matching the Jack for a flush and Nobs. No way! It's either 15 or 18, depending on the card placement.

March CW had a record 40 pages, complete with 82 sanctioned events listed...and thanks to our new bar coding, it arrived right on schedule, despite a new Membership Secretary, a new mailing system, and the record pages. When editor DeLynn Colvert began publishing CW in the spring of 1990, his first issue was a 20-page publication, complete with 19 sanctioned events. We've come a long way in nine years.

Life Master 37! Roger Wilson Takes Timber Capital

Roger Wilson, the ACC's travelling pegger from Denver, won the recent Timber Capital Classic played at the Seven Feathers Casino in Canyonville, OR. The win was a special one for Wilson as he earned Life Master...and another 196MRP's as well. In winning his 5th sanctioned Main event, Wilson joins the ACC's race for the roses this cribbage year and is over the 500 MRP mark.

Jay Maloney (OR) nailed down 2nd in this huge meet (218 players)...and 147 MRP's. Sally Peters (OR) and Joe D'Amico (WA) took home 3-4. D'Amico was a walk-in from the casino who loves cribbage. He immediately joined the ACC...and loved the action. He finished high in the High Roller event, qualified 43rd in the Main...and begins his ACC pegging with 105 MRP's!

Jerry Hahn (OR) smoked the field in the qualifying round...scoring a nice 39 17/22+291.

Jackie Doppelt (CA) scored a grand slam 9/9 in the Consolation (20+195) to easily earn honors, but in the playoffs in this 140-player field Lowaine Pruett (OR) came home the winner. Master Frank Ornie (OR) took 2nd, with Walt Howell (OR) and William Summers II (CA) in 3-4. Summers garnered 45 MRP's and remains in the national championship race for this cribbage year.

Synopsis ACC Board of Directors Meeting Reno. NV. February 4, 1999

Called to order at 11 AM by Executive Vice-President Syl Lulinski. Roll call taken, all present except for Monroe. Minutes accepted from last meeting.

McGibney's Financial Statement for 6-month period ending 12-31-98 accepted.

McGibney reviewed auditor's investigation of Membership Secretary. Auditor's recommendation to replace Jeff Monroe and proceed accordingly. Accepted. Shimp moved to suspend Monroe indefinitely. Carried unanimously.

Executive Committee informed BOD of decision to install Larry Hassett as new Membership Secretary, replacing Monroe, Joan Rein to act as back-up. Both accepted.

McGibney moved to authorize a bank account at South Umpqua State Bank, Roseburg, OR in the name of the ACC for membership dues. Hassett, McGibney, and Julian approved for authority to withdraw and deposit funds. Hatcher moved that Hassett be furnished copies of resolution of incorporation to establish checking account.

Hatcher moved to authorize National Tournament Commissioner authority to waive sanctioning fees in emergency situations. Approved.

Hatcher moved to approve \$3,200 for implementing balloting via first class mail. Approved. Schedule for balloting approved.

Barnes will present Hall of Fame pictures on the internet for next meeting.

Discussion JPW/ACC tournament size, number of playoff rounds, space, etc. Webb presented proposal from Nugget. Rein passed out comparison sheet (Nugget vs. Sands). Barbara Woodward and Tim Morton (Sands) offered their insight to additional space at the Sands. Comparisons discussed. Sands voted as playing site for next two years. Kooistra amended motion "with unlimited numbers unless they were unable to accomodate us." Carried.

Ready reviewed cross-checking of scorecards. Change approved to add "If the spread is marked upon only one card, accept the spread."

Bickford addressed "Early Departures." Motion carried that any card with more than one player earning Game Points shall be disqualified. The card will be used for cross-checking only.

Judges calls regarding common sense discussed, and will be reviewed at September meeting.

Bickford moved at allow irregular formats for:

Connecticut Peer, National Open (NC), and Granite State Open (CT). Approved.

Perkins moved to lower GR ACC membership dues fees and not send Cribbage World and/or make them ineligible for Master Points in tournament play. McGibney amended the motion to charge \$5 (noting that CW costs \$5.33) and allow members to earn Master Points. Motion defeated.

Ready moved to approve a family membership dues category (amended by Perkins). Defeated.

Julian moved that all players in sanctioned events be required to be members. Defeated 12-11.

Grand National 2001 (Eastern Region) voted to be advertised in *Cribbage World*. Only proposal to date was withdrawn.

Barnes moved to discontinue framed 29-awards for presentation at Awards Banquet at Grand Nationals. Framable certificates will be mailed to players, in addition to \$100. Carried.

Barrett reported on the internet and the growth of the ACC. The internet is a growing part of the ACC.

Mikulsky and Ramos reported that Grass Roots will be filing tax reports and doing audits on the Grass Roots separate from the ACC. They noted this would be necessary to be in compliance with our non-profit status.

Julian moved to rescind the motion from Oct. 1998 BOD meeting that "The ACC BOD reaffirms its jurisdiction over the Grass Roots Program according to the ACC Constitution & By-Laws (that is the Grass Roots Program, as a standing committee of the ACC report to the ACC BOD prior to taking action) and replace it with "The ACC BOD reaffirms its constitutional control over the Grass Roots Program as a standing committee of the ACC." Carried.

Ramos addressed defamation of Mikulsky and himself regarding Grass Roots controversy.

Kooistra reviewed JPW/ACC Open, and noted 60 standby players for the tournament.

Rein reviewed Tournament of Champions, noting 512 players. Alternatives will need to be looked at regarding another playoff round if number surpasses 512. This issue will be discussed at September meeting.

Barnes discussed Junior tournaments. Five were held last cribbage year. Dan Zeisler doing great job and changes should be up to him.

Bernard moved to appropriate up to \$700 for Rein to update office equipment. Carried.

Regional commissioners given discretion to sanction events on same weekend within 400 mile radius.

Lulinski moved to increase Grand National allocation to \$1,250. Carried.

Executive Committee reported approving providing Master cribbage boards to the 46 new Masters, replacing plaques if preferred. Appointed Chairpersons and/or Commissioners for 6 standing committees for coming year: Rules-Lulinski; Tournament Guidelines-Bickford; Marketing-Bey; Judges-Shimp; Grass Roots-Milkulsky; and Ethics-Hatcher. Approved Director's liability insurance of \$1,300 for 1 year. Authorized expenses to Wilson and McGibney to audit Membership Secretary's account. Issued correction to Dec. '98 CW relative to 'appointment' of Hassett as assistant National GR Statistician. Τt should read 'recommendation." Appointed Hassett as Membership Secretary, effective Jan. 31, '99,

Hassett moved to bond three positions (Membership, Treasurer, Grass Roots Commissioner) for up to \$100,000 each but not to exceed \$500 aggregate in cost. Carried.

Shimp moved to authorize Julian to contact legal council and any other person as required to resolve the Membership Secretary situation.

Meeting adjourned.

Nominees for election to the Board of Directors will soon be announced. (Or you have now received the nominations for election to the BOD.) The election of our representatives is most important and it is equally important for everyone to make their choices known by casting their vote.


A sorrowful small percentage voted in past elections.





Membership Secretary Hassett Update

I would like to thank everyone for their patience and support. When requesting information (email or voice mail), please include your ACC number with your name and address! We have over 400 members who have at least one other member with exactly the same name!

ACC memberships expiring on or after January 1, 1999 will be temporarily extended to May 1st, 1999. Renewal notices should have been sent at the end of March. Members will have one month to renew their memberships.

The membership cards should be mailed by the middle of April.

The CW now qualifies for the USPS automated mailing system. Getting there was a process similar to a keystone cops movie. Addresses qualifying for automated service received their CW in 3 to 4 days.

You may have noticed some changes to your address. The USPS approved software modifies the address to meet their standards. Almost 7% of the current addresses could not be found in the USPS address database.

The savings are not nearly as great as reported. The savings should be from \$1,500 to \$2,000 per year.

All the duplicate ACC numbers have been eliminated. Current members whose ACC number were changed will be getting a new membership card. Any changes are being coordinated with Bob McCabe and Joe Ramos to insure proper accounting of ACC Master and GR Rating points.

Sending the renewal notices and membership cards and catching up the backlog of inquiries are the priorities for April.




