#### Record Crowds In Reno

## C: Schiffman PW/ACC: Kraft

and Canada descended in record numbers on Reno the first weekend in February. The Sands Regency (\$1,260), followed by Susan Turcottte (RI) in was awash with peggers from Friday through Sunday evening...and they were all on the prowl (MA) nailed 3rd, with Sue Schenck (MI) takfor record purses and bragging rights.

The gala weekend kicked off with the annual All-Star game on Thursday night (see story, this issue) With the Western squad taking home the win. Then on Friday morning some 512 peggers (a record) were on hand for the Annual Tournament of Champions, a meet by invite only. In a very competitive 16-game qualifying round, Darrell Miotke, a Grand Master from Sublimity, OR, scored the top card (31 15/16), taking home the top Q prize. But when the playoffs began, it was veteran Morris Schiffman, a Master pegger from Portland, OR, who held on to win the championship. The win came with a whopping \$8,000...one of the richest prizes in ACC history. No Master Points were awarded, however, as this match is by invite only.

Joe Angelo, pegging out of New York, nailed 2nd...and \$6,000! Mike Azevedo (MA) and Master John Syftestad (WI) took home 3-4. Azevedo took home a nice \$4,000 and Syftestad earned \$3,000.

Cribbage players from throughout the United States A sizeable Consolation event saw Master Gaylord Matti (WI) take home the marbles 2nd (\$1,150). Grand Master Paul Gallagher ing 4th (\$925).

> On Saturday morning, the crowd doubled in size. With some 60 peggers on the waiting list, it appeared a certainty that a maximum 1,024 would play, but in the last confusing moments, many players failed to show, and standbys failed to materialize. Nevertheless, 1,014 players sat down to play in this granddaddy of all cribbage tournaments ...the Joseph Petrus Wergin/American Cribbage Congress Open.

> Wayne Steinmetz, a Grand Master from Milwaukee, roared out of the gate, scoring a whopping 41 18/22 +280 to capture qualifying honors...and a huge Q pool prize. He also took home 75 MRP's for this excellent card.

#### The President's Column

#### 20th Year

The American Cribbage Congress has begun its 20th year, being organized and incorporated in North Carolina in 1980.

Cribbage World also started its 20th year of publication with the January, 1999 issue.

I don't know whether any of you have noticed the significance of the playing cards displayed in the front page flag of CW by our tricky editor, DeLynn Colvert? In January, he used aces (representing month one); in February, he changed to deuces (the second month); and this month, March, is represented by a couple of treys on the front page, signifying the third month.

Jacks and queens will represent November and December, but we'll never get to kings (the 13th card).

Twenty-four founding directors were listed on the original ACC Articles of Incorporation. Half of them are still alive and active in cribbage affairs.

Thirteen-year President Emeritus Joseph Petrus Wergin, who conceived establishment of the organization, turned 89 on January 22 and is now living at the Hebron Oaks Health Care Center, 6201 Mineral Point Road, Madison, WI 53705. Call (608) 238-1663.

Other founders still active in ACC events are: Air Force Major Bill Campbell (now a retired civilian and newspaper columnist in Florida); attorney Dick Graham of Englewood, CO; Tom Miller, Raleigh, NC; Dr. William Shoemaker, La Jolla, CA; John Chambers, Rhode Island; Ernie Driscoll, Raleigh, NC; Robert Read, Florida; Jeff Shimp, the Michigan kid now moved to Nashville, IN; Tats Tsruda from sunny Hawaii; and two women: Marion Quackenbush, Lawrencville, PA, and Phyllis Schmidt, Williamstown, MA.

At least four have passed away: Nick Pond, formerly of Raleigh, NC; our original secretary, Jim Arblaster, of Florida; Allan Lichty, of Iowa; and Arnold Crews, also of Florida.

I've lost track of the other eight: pilot Bob Immel of Northfield, MN; Art Boulette, Alexandria, VA; Edna Boyd, Bluefield, WVA; George Haendle, Carson City, NV; Elbert Hargesheimer, Hamburg, NY; Frank Wise, Orlando, FL; Dutch Klintworth, Greer, SC; and Marvin Kluck, Mystic, CT.

Arblaster introduced and published the first Cribbage World, followed by Bob Madson from Chicago, IL; Dale Munroe, Collinsville, CT; and the present editor, DeLynn Colvert of Missoula, MT.

Multiple changes and growth have come and gone during these past two decades.

I'm proud to continue the legacy I inherited from previous Presidents: Wergin, Bob McCabe, interim Scott Kooistra and now EEB for the past five years.

However, I'm saddened when I have to report the failings of a friend whom I installed as Membership Secretary a dozen years ago.

A recent surprise audit of Jeff Monroe's accounts by Treasurer Fred McGibney and Auditor Roger Wilson, following two years of unanswered audit inquiries, revealed a substantial cash shortfall.

Other major discrepancies reported to the ACC Board of Directors at its recent Reno meeting included Monroe's failure to submit any dues remittances to the Treasurer from July 1, 1998 until January 30, 1999; failure to respond to Internal Control recommendations of the last two years; failure to make any serious attempt to explain possible reasons for the perceived shortage; and delay in sending the final fiscal 1998 (June) payment to the Treasurer until September 1998, claiming it was lost in the mail.

Numerous other alleged discrepancies were also revealed: members under 60 allowed to become Life Members; accepting dues at an older rate than currently charged; continuing *Cribbage World* subscriptions after memberships have ceased; processing delays in issuing current membership cards to members. etc.

At least we're solvent and continuing to do business as usual.

Needless to say, the ACC Executive Committee acted promptly, suspending Monroe and appointing Larry Hassett as new Membership Secretary to straighten out the whole mess. He'll be very busy for the next 60 days, so if anyone has any particular or peculiar membership problem, let me know about it at 10826 W. Thunderbird Blvd., Sun City, AZ 85351-2646. He held 10-10-Q-Q, and held his breath. Only a jack cut could save the match. And Lindner held a jack in his hand, giving "Gabby "only three chances to cut the winning card in the 40-card pack on the table. "Gabby" has paid his cribbage dues with many years of outstanding pegging, and the cribbage gods came through with the jack! Winning 4-3, Kraft took home the grand salami....\$10,000! And 315 MRP's to boot!

Alan Lindner's 2nd prize was a whopper...and his 252 MRP's will toss his hat in the annual MRP race as well. This Wisconsin pegger directs many tournaments, in addition to his prowess on the boards.

Frank Bodogh (NY & Canada) and Leo Rutledge (CA) came home 3-4. Each pegger earned huge prizes...and 196 MRP's.

Earning large prizes in the 5-8 bracket were: Jim Blough (MI), Grand Master Charley Rapoza (MA), Allen Bailey (MI), and Linda Swiontek (CA).

An unbelievable 814 peggers were on hand for the following Consolation. Grand Master Jim Gogolin (OR) came home the winner in this huge event (only the ACC Open will be larger this cribbage year). The win came with 135 MRP's, placing Gogolin among the nation's MRP leaders for this cribbage year. Alaskan Henry Carle nailed 2nd, with two Californians in 3-4...Len Wahlig and Grand Master Jones Hom.

The Sands Regency, once again, were great hosts to the ACC, with Barbara Woodward's expertise aiding immensely in the management of the tourney. Joan and Jim Rein (TOC), Scott Kooistra, Roy and Jeanne Hofbauer (ACC Open), and scores of helpers ran another first class event...and next year, the Sands promises more playing area, giving everyone a shot at winning the greatest cribbage match on earth!

Last month's Cribbage World made a gross mistake...and in bold headlines on the front cover!


It read: Elinor Breen Wins Holiday Classic

#### **Election Year**

## Grand Master Sharlene Medeiros Wins Virginia Championship





#### Membership Secretary Scandal

On January 31, 1999 the Executive Committee announced that Larry Hassett had been appointed Membership Secretary of the American Cribbage Congress effective immediately. He succeeds Jeff Monroe who was relieved of his duties after an audit on January 30, 1999 showed substantial shortage of ACC funds.

The Executive Committee authorized the emergency review of the Membership Secretary's accounts and records based upon the auditor's 1997 and 1998 internal control recommendations and significant failure to follow through by the Membership Secretary in implementing the recommendations and explaining the possible shortage of funds in his (ACC Membership) account.

The audit was performed by ACC Treasurer Fred McGibney and auditor Roger Wilson at the Napa, California office of Monroe. The report to the Executive Committee stated, "We visited the Membership Secretary's office on January 30, 1999 and were immediately confronted with a 'bombshell!"

Membership Secretary, Jeff Monroe, indicated that in early December 1998 the Internal Revenue Service had attached the Membership dues account due to the Membership Secretary's other outside interests not related to the ACC. The Membership Secretary said the IRS was able to attach the account because the account, while having the ACC's name on it, was set up as a business account by the Membership Secretary using his own personal Social Security Number.

They asked for a copy of the IRS documentation of the levy but were told by the Membership Secretary that he had given all paperwork to his attorney and didn't keep any copies for himself. They requested and were given the attorney's name, address and telephone number. When asked why he hadn't reported the IRS action (when it happened) to the ACC's Board of management, the Membership Secretary's response was that he was embarrassed and was attempting to recover the funds before notifying anyone. Bank statements provided to the auditors showing the IRS attachment of a substantial amount were later proven to have been falsified.

Details of this matter were revealed and discussed at the ACC's Board Meeting in Reno, Nevada on February 4, 1999 at which time the Executive Committee was authorized to take whatever action is needed to resolve the situation.

## **Grass Roots Controversy Resolved**

The ACC is proud of the Grass Roots Program and we believe it will continue to grow and prosper under its present leadership.

The so called controversy between the American Cribbage Congress and the Grass Roots Program has apparently been resolved without any sides designated as winners or losers.

When the new Grass Roots Manual is revised there will be at least three definite changes:

- 1-The cover will have the ACC logo on it and the name of the Grass Roots Cribbage Program changed to either, "The American Cribbage Congress Grass Roots Program" or, "The Grass Roots Cribbage Program of the American Cribbage Congress."
- 2- The Grass Roots Program of the American Cribbage Congress is the hometown component of the American Cribbage Congress and not a separate organization as some perceive it to be.
- 3- The Ethics Committee of the ACC and the Grass Roots Cribbage Program's Board of Volunteers will establish a committee to develop precedures.

We recommend tabling any further revisions to the manual until presented for review by the entire ACC Board of Directors at the September, 1999 meeting.

#### **Reward Close Games**

I have been playing cribbage for many, many years so what I am about to suggest should not be construed as the thoughts of a Johnny-come-lately. My experience of these many years doesn't make me a better player, as my points show, but I do think and wonder, as these ravings will attest.

I have always wondered why they give an extra point for a skunk. Anyone who has played cribbage for a while knows that only the Cribbage Gods are responsible for a skunk and skill plays only a small part. What kind of brains does it take if you are holding 7-7-8-9 and your opponent is holding 2-6-8-J and you cut an 8? Oh, some players will argue that the skill comes in when you are trying to keep your opponent from crossing into 4th street, but you must realize that you had to be getting good hands and good cuts to be in that position that you are so far ahead of him. And even if he does cross over that line, you still will wind up with two points. So, you are not losing that much. I know most tournaments are won and lost on that one point, so I have an alternative.

I think winning a game by one point is the hardest thing to do in cribbage, so why don't we give the winner of a one-point match, three points? That way we will all know that the player really earned that extra point and it wasn't all luck. I would also suggest that the loser be awarded one point, but that might seem too radical.

I know a change like this would never go through, but I would like to throw it out to the Congress and see what they think. Thank you for allowing me to express myself.

Members of the ACC, let's hear it for Sam's idea. By the way, this has already been kicked around in years past. Ed.

## Speeding Up the Game and Pegging Tips

Don Smith, an avid pegger from Oregon City, OR, recently wrote two lengthy letters on how to speed up the game...and pegging etiquette.

He feels that "rehashing the last hand" can be a problem. Play and count the hand, and leave the speculation for what might have been for a later time. And when counting your hand, simply condense the counting and lay your cards face up for verification. For example, you have a double run with knobs, say "nine" and peg the hand. Don't say "a double run of three for six, a pair, and knobs for nine." If your opponent is confused, or a beginner, allow extra time for this verification.

Smith also writes about pegging etiquette. When pegging, always leave your cards face up so your opponent can verify the count, and peg at a reasonable speed. Allow time for verification before turning and pegging your crib hand. And, of course, do not mix your hand and crib cards before this verification is complete. Be a good sport and allow your opponent ample time to check your pegging...and keep the cards exposed for easy checking. And above all, do not turn your cards face down while pegging.

Raggedy-Ann in Canada?

Harold Buckley, a Master pegger from Canada says they call Raggedy-Ann (1-1-6-7-8) "Cincinnati" in Canada. He does not know the origination of this name.

Cal Ripken, Move Over...

Many cribbers know full well that Cal Ripken, the Baltimore Oriole infielder, has set a record for consecutive games played, but what about Grass Roots consecutive games played?

Patrick Barrett writes CW to report that his father, Jack Barrett, has played 2,907 consecutive games in Grass Roots play (Club 120).

His streak was from September 27, 1990 until December 10, 1998. Only knee surgery could keep 70-year old Jack from play! He is a Bronze Award winner and patriarch of the Barrett family. He taught his offspring the game of cribbage, and the newest player, 19-year young Nicholas Barrett (step-grandson) just happened to take 1st place on the night of Jack's absence.

Family's that play together, stay together. Cribbage fever, catch it!

#### Frank Lilliman Teaches Cribbage

Way up north in Canada, Frank Lilliman is teaching 5th and 6th graders cribbage. His Hamilton, Ontario peggers are quoted:

"Cribbage is really fun. It teaches you a lot about counting and especially helps you with quick addition. It's a thinking game. You need a lot of concentration. I taught my cousins, my sister and my mom. We play at home now. I downloaded the game from internet and I play at home all the time."

Two Topics...

I have two topics I would like to address. The first being conflict between this years' Grand National and seven tournaments which took place in 1998. These directors should think about re-scheduling in 1999. The seven tournaments held during the 2nd weekend of September 1998 were the Gateway to Sierras Classic, Wisconsin Dells Classic, Capital City Classic, Pensacola Beach Open, Blue Mountain Open, Season Opener, and the Hawaiian Open. GN XVIII will be held in Las Vegas on September 10-12, 1999, thus taking a weekend rarely used for past Grand National Tournaments. I have moved the Wisconsin Dells Classic into mid-October and I hope other directors can find an open weekend for theirs.

In response to ACC Testing Examiner Al Miller's letter warning judges to be more alert during judges calls brings to mind two important things I have learned as a judge. Always have 2 judges with rule books at every judging call. many of us think we can rule on problems without looking them up, but no one that I know has memorized the entire rule book, especially the latest one. Also, new judges should be eager to be involved in all situations but be patient and precise in your decisions. I have seen judges eager to "get on with it" as they think they are falling behind in their game, are nervous, or just want to get it over with. Experience helps all of the ACC judges and I feel there are far more correct calls than bad ones but the bad ones may cost any one of us dearly someday.
