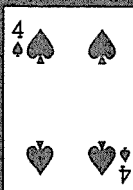
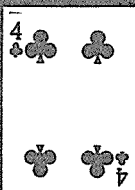

## Marvin Helfgott Tops Orlando Open

Marvin Helfgott from Boynton Beach, FL came home the winner at the sizeable (142 players) Orlando Open on February 25. Helfgott's 211 total MRP's earned will place him among the Eastern Region's top 50, in addition to a sizeable purse. Aimee Kargen (GA) nailed down 2nd, and took home 147 MRP's. Doug Page (WI) unofficially zipped to his Life Master rating by taking home a 3-4 finish, and was joined by Bill Young (FL) in this slot. Duane Gier (FL) scored a 33 GP card to take qualifying honors, and took home an aggregate 56 MRP's (with a 17-32 finish).

The Consolation played to 98 players, and Louis Gardner (GA) took home the bacon (and 63 MRP's). John Blowers (FL), Connally Thomas (FL), and Terry Johnson (FL) finished 2-3-4. Fred Adolphson (FL) had the top card in the qualifying round.

Director Paul Barnes had a full slate of satellite events.

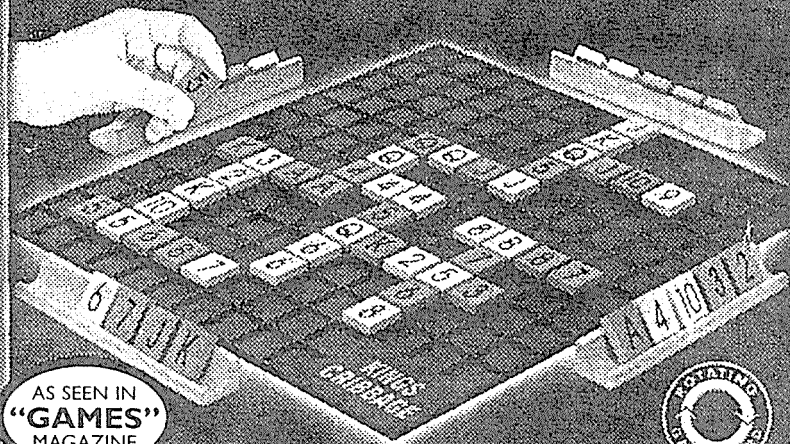

## 131 "Gruberized" In St. Paul

According to Jeff Crane's biography (centerfold, this issue), he has been "gruberized!" And so have 131 other peggers that attended the Capital City Open in St. Paul on March 3-4. Life Master Jerry Gruber (MN) had a weekend he will not soon forget as he qualified 1st (37 16/22 +222) and roared home the winner in the playoffs as well. He finished 13th in the Friday satellite, and 3rd in the Saturday Special. Needless to say, he won the All-Events in a waltz, scoring a whopping 69 GP's. All in all he won some 76% of his games for the entire weekend, and carted home 251 MRP's!

Master Norbert Upton (MN) was the last victim in Gruber's run, but, nevertheless, he took home 147 MRP's...and is nearing his Grand Master. Cyril Schmidt (WI) and Dennis Ulberg (WI) took home 3-4.

Chuck Mokres (MN) had the same idea in the Consolation, qualifying 1st, and finishing in the 5-8 bracket (70 players), but it was Life Master Russell Adams (MN) taking the playoff action, with Shelly Vadnaïs (MN), Steve Finnegan (MN) and Ken Key (WI) taking 2-3-4.

A highlight of the meet saw Scott Nordlund (MN) score the ACC's 12th 29-hand of this season...garnering Nordlund a nifty \$100 from the ACC. Butch Shelstad (MN) and Pete Severson both scored 28's. Pat Upton (MN) won the Friday night game, and Jim Hogen (MN) took home the top prize on Saturday night.

Director Todd Schaefer, as usual, ran a first-class event, attested to by yet another large crowd...and he even managed a 5-8 finish in the Main Event. Butch Shelstad (MN), Jeff Crane (IA), and Jim Hogen (MN) also finished in this bracket...taking home 70 MRP's each.

## White in January Esera in February

Director Tsarkie conducts monthly sanctioned events in Hawaii, and in January's edition (21 players) it was Hawaii's only Master player coming home first (Fred White). Roy Wong (HI) qualified 1st and finished 2nd in the playoffs. In the February edition (19 players), it was Mary Jane Esera (HI) nipping Len Wahlig (IL) in the final playoff match. Wahlig also qualified tops.

## Washington State Open Willie Evans Wins Own Trophy

Grand Master Willie Evans from nearby Richland, WA, took home the championship at the recent Washington State Open, played in Sunnyside, WA. And the win came with a trophy board...one that was donated and sponsored by Evans and his Towne Crier establishment in Richland. With 72 players in action, Evans carted home 147 MRP's, the top purse, and the Super Q prize. Another Grand Master...Jack Moritzky...took home 2nd and the 105 MRP's run this year's total to well over 500...and yet another run for the roses (he finished in the top ten last year). Master Sharon Hejtmanek (MT) and Chris McComas (WA) finished 3-4. Hejtmanek's 115 MRP's (aggregate) zips her to well over 600 MRP's this cribbage year.

But the big news was Life Master Jeanne Hofbauer's qualifying round score. Her 44 20/22 +317 has set a new standard for the ACC for a 22-game round. (See story, this issue).

54 peggers stayed for the Consolation, and it was Master George Mackie (WA) winning going away. Local Bob Brumley gave it a good try, but settled for 2nd, followed by Jo Kirby (WA) and Bruce Denend (WA) in 3-4.

## Synopsis

### Board Of Directors Meeting

#### Reno, February 1, 2001

All members present except Ramos (suspended), Jarrell (suspended), and Hom (excused). Corrected minutes from February were handed out with changes noted by Rein. After review, minutes accepted unanimously.

Financial report presented by McGibney. Motion made to table budget until later carried. Discussion followed regarding audit and transfer of funds for the Grass Roots program. Funds have been transferred but full audit still needs to be done. Loose ends and completion of dissolution of the GRCP will be discussed at September meeting in Richmond.

Julian reported on disposition of Monroe case. \$30,000 plea bargain was accepted and check has been received by McGibney. Monroe sentenced to 270 days in County Jail, with three-year probation. He also received monetary fine. Julian commended for his diligent work in this case. Letter of thanks will be sent to Napa's city attorney.

Perkins reported on Compensation committee's recommendations for stipends for various positions work performance. Anyone putting in under 100 hours per month should be given \$300/month, and anyone working over 100 hours per month receive \$600/month. Membership secretary Hassett and Cribbage World editor Colvert are in that category. Those in the under 100 hours monthly are: three Regional Commissioners (Bickford, Bernard, Hofbauer); and National Statistician (McCabe). Motion made to increase Hofbauer's stipend to \$450 since his workload is twice those of other regions. National Grass Roots Commissioner (Rein) stipend will be determined from information submitted by GR Committee meeting. Approved.

Shumate reported on Grand National 2002. Details will be reported within week or 10 days.

Rein discussed problems between GR and Ethics Committee. Procedural letter will be sent to all club directors giving guidelines and how to report problems.

Rein moved to have National Statistician mail letter to members who attain Grand Master and Life Master as to their preference of an engraved plaque or a trophy cribbage board. Rein will mail letters for last year's recipients. Master and Grand Master are to remain as boards. Approved.

Hofbauer moved to award the level of Life Master One-Star an engraved wristwatch. Cost from \$200 to \$300. Approved.

Colvert asked to note in *Cribbage World* that Dan Zeisler is the Cribadier General.

Lunch break taken. Sands Regency presented all BoD members with briefcase with ACC logo.

ACC's Hand Book reviewed and changes discussed.

Bernard moved to have Ethics Committee determine length of suspensions. Approved. Recommended changes to Ethics Committee will be reviewed at September 2001 meeting.

Section 4 (Board of Directors) was approved with changes to include purpose, authority and responsibilities of BoD members. Section 11 (Grass Roots) was delayed until September meeting. Hatcher moved to eliminate last part of F (Policies I pg. 15-1). Hatcher moved to approve Hassett's proposal regarding membership secretary. Approved. Hatcher moved to approve Secretary Statistics as read by Julian. Approved.

Bickford moved to make a rule that losers deals after first game of playoff match. First game deal determined by cut of cards. Approved.

Bickford moved to accept underage player proposal: If player is under the legal age where event is played, they shall pay only the sanctioning fee, no entry fee, and will receive Master Points only, and no prize money. Approved.

Hofbauer moved to change wording of Section 23 of Tournament Rules and Guidelines to read: Individuals who have been expelled or are currently suspended are prohibited from participation in any ACC function, including but not limited to: sanctioned events, satellite events, banquets, BoD meetings, and any Grass Roots event.

Rein moved to lower membership fee by \$1. Defeated.

Rein proposed writing new program for Grass Roots program linking to ACC membership, as present program has problems. Rein moved to allow no more than \$16,000 for purchase. Approved, with provision that a 50/50 split of the funds come from ACC and ACC Grass Roots account. Passed unanimously.

Jarrell suspension discussed. Ethics Committee recommended three-month suspension. Secret ballot approved three-month suspension. Lulinski moved to expell Monroe. Carried. Lulinski moved to accept recommendations of Ethics Committee to send letter to Ramos advising him suspension will be lifted, and he will be reinstated as of May 1, 2001 if he complies with requirements spelled out by BoD.

Barnes moved to provide \$300 for Puyallup Fair promotion, with each case being independently reviewed. Approved.

Shimp moved that 2003 Grand National be awarded to TJ Lewis and Scott Kooistra and "The Oaks" in Sioux Falls, SD. Carried unanimously.

Shimp elected to Hall of Fame. Four candidates on ballot.

Rein proposed an extra BoD meeting each year. Defeated.



Article X approved, with changes starting at section b. Section b reads:

*b. The ethics committee shall receive all reports of alleged ethical standards violations. The Committee shall not act on a complaint until it is received in written form. The Committee shall investigate and review all available information of the alleged offender (both current and prior) and determine if he/she did violate any of the ethical standards. If the committee finds that he/she is guilty but does not feel that the violation is serious enough to warrant expulsion, the Committee may immediately impose a lesser punishment and inform the offender of the punishment imposed. The Committee shall inform the alleged offender of the nature of the written complaint(s) and ask if he/she wishes to submit a defense within 30 days.*

Item 24 on agenda (Article XI-Conduct) was tabled.

Hatcher moved to rescind motion to suspend members if GRCP, Inc. was not completely dissolved by Reno meeting. Some loose ends need addressing. Passed.

Next meeting of the BoD will be in Richmond, VA on Sept. 21, 2001 in conjunction with the Grand National.

Meeting adjourned. Minutes recorded by Joan Rein.

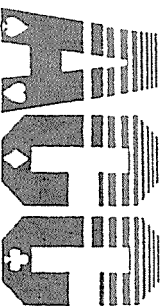

## 25 Members Will Form American Cribbage Congress's Board of Directors


In August, 1979, the American Cribbage Congress was organized. At the inaugural meeting held at the National Open in Raleigh, NC, a 26-member Board of Directors was named, and a 9-member Executive Committee was appointed. As we vote this month to form our next Board of Directors, the format has changed somewhat. We have pared the Board to 25 members, and have only five Executive positions. The five Executive positions are elected each year by the Board of Directors.

No more than 10 can be elected from any one region, nor less than six. Only four can be elected from a state. If five (or more) from one state are among the top 25, then candidate 26 (27, 28, etc.) would be elected (if from another state). The candidate(s) who finished 5th (6th, 7th, etc.) from one state would not be elected. **Be sure to vote today. Support the ACC. This is your opportunity to elect Board Members of your choice. You may vote for up to, but not more than, 25 candidates.**

## Children In ACC Play

With the ACC Board now making major decisions regarding this issue, I believe that members of the ACC should make their opinions known.

A major issue confronting cribbage tournaments in some states is the legal definition. Is cribbage a game of skill or do the tournaments fit the state's definition of gambling? The discussion about how to word the regs to let children play was amusing. They wanted to include words allowing those under the legal age to play. One person pointed out that they should not include the word "gambling" in any part of the regs because of that separate issue. "Legal Age" is not good enough because there is a legal age for driving, smoking, drinking, voting, and gambling. A specific age would have to be stated.

State agencies have rules about serving alcohol in a room where minors are present. I believe there are large numbers of adults, including me, that enjoy a drink late in the day when we no longer have a chance of making the playoffs, or during the Saturday Night Special. The conditions that had to be met at the Seven Feathers Casino to have a bar in a corner of the playing area with minors present was more trouble than the tournament director wanted to deal with. The result was no bar in the playing area. How many minor children did that decision accomodate and how many adults that would have enjoyed a drink were prevented from doing so?

I have made donations and will continue to support junior cribbage tournaments. I also go to little league, junior soccer, and support other youth activities. I have never tried to get them to change their rules so I could participate as a player. Is it in the best interest of the ACC to put more restrictions on locations for cribbage tournaments or prevent several adults from enjoying a drink to accomodate one or two minors at some tournaments?

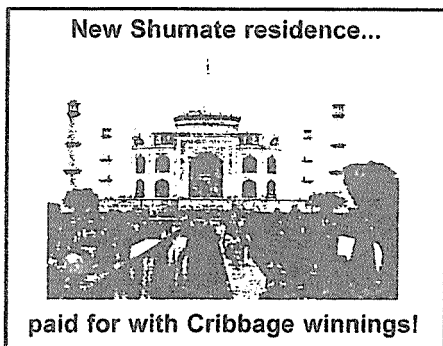
