Steve Reynolds, a Life Master from Concord, CA, was making his first foray to the Big Sky country, and very nearly took it all, losing 3-4 in the final match. Lamon copped 147 MRP's in winning, and Reynolds added yet another 105 MRP's to his 7,600+lifetime total.

Bruce Pomeroy (ID) and Gail Smith (ID) finished 3-4. Grand Master Willie Evans (WA) took qualifying honors with a nice 37 17/22 +221 (and 97 MRP's aggregate, finishing 5th).

Local Luanne Felstet nailed the 84-player Consolation, edging another local in the final playoff match...Michelle Barthelmess. Master Bob Wikstrom (WA) and Master Jim Keeling (WA) finished 3-4. 2001 All-American Ron Morgan (CA) scored a whopping 19 GP card in the qualifying round to win that leg going away.





Mary Ryan Cops Teeny Tiny Mary K. Ryan (CA) has 4,500+ MRP's (lifetime), and she came to play at Ed Bloom's unique Teeny Tiny event in San Jose, CA on September 29. About all Ryan could win was more MRP's...and that is exactly what she did. By winning this 67-player event, she carted home yet another 147 MRP's to add to her lofty lifetime totals. The \$20 entry covers the coffee, trophies, lunch and other incidentals, but little or no prize money.

Lucille Owens (CA) nailed down 2nd (and 105 MRP's), followed by Grand Master Boyd McDonald (CA) and Dan Barber (CA) in the 3-4 bracket.

Jim Crawford (CA) ran the table in the 50player Consolation, taking the top qualifying card (14 GP's in the 7-game round), and won the playoffs as well. Director Bloom nailed 2nd, followed by Paul Gregson (CA) and Al May (CA) in 3-4.

This is Bloom's 13th Teeny Tiny event, and they have all been well attended, attesting to his expertise in running a tournament, And this is all the more amazing, since there is little or no prize money.

Nostalgia (High Rollers) Many events now sport a High Roller as a satellite event, but do you know where this event originated?

Years ago (1983) the late Joe Nelson decided to add some zest to his Oregon Championship and have a "High Roller." The first year (1983) only a handful of players played with a winnertake-all payoff.

But the next year, some 30 players paid their \$100, with the payoff to be \$2,000 for first, and \$1,000 for 2nd.

Life Master Bill Hill (OR) was just beginning his tournament-cribbage competition (as was everyone else). In a close match, Hill thumped his winning card down, let out a whoop, pushed himself back from the table...and promtly fell to the floor backwards, chair and all! From that point on, Bill remembers very little, as the bar gave him a water glass full of Scotch. The next day he learned that a great time was had by all.

And that, my friends, is why we are playing those High Roller events today. And Bill Hill is still winning more than his share!

### *206 At St. Croix* Doug Munneke Cops 19th St. Croix Classic

Doug Munneke, pegging out of St. Cloud, MN, came home the winner in the 19th edition of the St. Croix Classics, played at Turtle Lake, WI. And once again, director Alan Lindner had a large crowd on hand, with some 206 players signed on for some spirited pegging. Munneke zips to the top of this year's leaderboard, picking up a whopping 196MRP's with the win as well as a sizeable purse..and bragging rights.

Life Master Lloyd "Gabby" Kraft (WI) added 147 MRP's to his lofty lifetime total, and he, too, will zip to the top of the charts with this high finish. Bob Wingo (IL) and Life Master Russell Adams (MN) finished in the 3-4 bracket. Adams scored 105 MRP's (as did Wingo) and he is knocking on the door for the ACC's 14th One-Star rating. He stands at 9,800+, needing 10,000 for the new rating.

Master James Heemstra (WI) scored one of the meet's seven 28-hands enroute to his high-qualifying score (36 17/22 +288). And each of these seven 28-hands earned a whopping \$250 bonus from the St. Croix Casino.

Grand Master Bob Hanes (IA) has made Grand National history by being the only player to win TWO of those events (V & XIII), and he continues to pick 'em up and lay 'em down by taking qualifying honors in the 122-player Consolation (16 8/9 +62). But it was last year's national runner-up winning this event...Life Master Wayne Steinmetz (WI). Master Dave Gustafson (MN) scored this year's first 29-hand (in the previous St. Croix Classic), and this time around finished 2nd in the Consolation. Master Norb Upton (MN) and Master Gloria McLeod (MN) finished 3-4.

Director Lindner had his usual satellites. The winners:

The next event will be played on February 15-17 (the 20th edition). Sign up early, these events sell out fast!

Co-director Vickie Long, playing at the 19th St. Croix Classic, went to lunch after 12 games, winning six games and standing at 13 GP's. But after lunch, she got into gear. Ten wins in a row! She qualified 4th with a nifty 35 GP card!

Master Keith Forrest (MT) was playing Les Sumner (NV) in the first-round playoffs at the Montana championship, and he held a 4-4-4 hand. You guessed it, he cut a 7 for a rare 24-hand. Alas, he needed a few more hands like this bomb, but failed to get them as Sumner advanced to the next round

Dan Hansen (OR) spoiled two grand slam bids in one night (Oct. 12) at a recent GR meet in Bend, OR. He ruined Paul Nolz's bid for a slam, and then finished his spoiler role by nailing Graeme Gossett's card with a lone loss. Nolz won the evening's action with a 17 8/9, and Gossett came home with a 16 8/9. Hansen? He came home with a smile on his face!

Julie Mack-Felkins directed her first-ever sanctioned event on September 8, and she was stunned when a whopping 112 players showed to play at her inaugural Solano 29ers September Sizzler. And 46 of these players walked in and signed on. Nevertheless, Mack-Felkins had all events on time and well-managed.

And who did the sizzling? None other than Ben Holder, Fremont, CA. He edged Master Harold Sontag (CA) in the final playoff match to walk away with all the marbles...and 147 MRP's. In taking 2nd, Sontag is getting very close to his Grand Master rating (3,700+).

Veteran Ron Morgan (CA) is one of the ACC's more dedicated peggers (All-American last year) and he took home 3rd, with Sharon Schwarz (CA) also finishing in that bracket (and 70 MRP's).

Paul Gregson (CA) is the ACC's new website manager, and he loves his cribbage. He took qualifying honors with a nice 26 11/14 +184 card.

With 72 players in the Consolation event, it was Master Tom Nohrden (CA) winning going away. Another Master finished 2nd...Ross Njaa (CA). And yet another Master took 3rd, Bob Clark (CA). Helene Sontag (CA) earned her Master rating by finishing in the 3-4 bracket as well.

### GNDX Refunds

John and I are both well aware of the circumstances that occurred on Sept. 11, 2001, 10 days before the Grand National started. We were not notified until Sept. 18 or 19 that the Board of Directors Meeting was being cancelled; prior to that date we had only received around 20 cancellations. As soon as this news hit the rumor mill, we received over 80 calls saying we heard the tournament was cancelled, that the Awards Banquet was cancelled and then another 65 people cancelled after that date. Of the 84 cancellations, 12 of those players never called to cancel, never sent any e-mails or contacted us at all. Expenses were incurred, programs had to be printed, meals ordered and awards engraved, and on and on. These expenses unlike the players did not go away, they remained. It is within tournament guidelines that we could of kept 15% of all refunds to cover expenses. John and I chose not to do this as we both felt it was wrong under any circumstances to withhold 15% of a players refund for expenses. All who called or e-mailed us their cancellations before Sept. 17 were issued a full refund. Those who had people who attended the tournament tell us that, oh, this person or that person was not coming, or who did not notify us had their lunch and/or banquet deducted from their refund which is pretty standard when you cancel so close to the tournament date. To those who feel this is wrong I am sorry. For those of you who never showed up, never called, or e-mailed, don't call and complain that you have not received your refund yet, they have all been mailed and that is the end of it, no other refunds will be issued and if lunch or banquets were deducted it was because we were notified that you were not attending, either too late or in a lot of cases not at all. To the 236 of you who made it through all the additional delays or had to drive long distances, we all thank you for attending the tournament. Some of you went through a lot to get to Richmond, and each of you should be congratulated.
