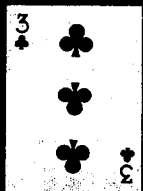

## AMERICAN CRIBBAGE CONGRESS

### TOC: Samet JPW/ACC Open: Syftestad

The 20th Annual ACC Tournament of Champions and the accompanying Joseph P. Wergin/ACC Open, once again, drew huge crowds to the Sands Regency in Reno. The Sands was awash with peggers from Thursday thru Sunday in pursuit of the ACC's highest paybacks of the year. Beginning with the 12th Annual All-Star game won by the Western Region (see story, this issue), play continued unabated for the next three days.

One-Star Larry Samet, Wellesly, MA, nailed the 512-player **Tournament of Champions** and pocketed a nifty \$8,000 for the win. No Master Points were awarded as this is a by-invite-only event. Grand Master Mike Rowe (AK) has been tearing up the track recently, and his 2nd place finished netted \$6,000. Grand Master Roberta Schweig (IL) finished 3rd, and was disappointed at not earning the top spot in order to duplicate her late husband's (Frank) feat some years back. Nevertheless, the \$4,300 eased her pain. Kathy Maresch has been doing quite well at her Greenwood, WI Grass Roots club, and the training paid off with a nice \$3,100 for a 4th place finish. Life Master Steve Reynolds pocketed a nice piece of change by taking qualifying honors in this huge event.

Canadian Hazel Croft (Edmonton) won the huge satellite **Cribbage Bowl** and took home \$1,800, nipping William Shoemaker (CT) (\$1,450) in this high-card event. Keith Widener (NC) (\$1,200) and Frank Lake (OR) (\$1,000) finished 3-4 in this 552-player event.

Saturday morning players were abuzz with anticipation as some 986 players sat down to begin play in the **Joseph P. Wergin/ACC Open**. With the grand prize of \$10,000, the play was intense as players from throughout the United States and Canada worked their way through the 22-game qualifying round. Life Master Doug Page (WI) came home the top qualifier with a great 42 18/22 card, leading the Central Region to a clean sweep of the top spots.

After playoffs on Saturday night and on into Sunday afternoon, it was John Syftestad, Mount Horeb, WI emerging as this year's champion, enriched by \$10,000 and 315 MRP's! Karen Bouffiou (WI) made a valiant effort, finished 2nd, and took home a whopping \$6,000! Lyle Lund (MN) and Master Joseph Brown (IL) took home 3-4 (\$3,000 each).

A huge crowd stayed for the Consolation, and play began with an astounding 756 peggers in action. After the 9-game qualifier, Mike Leonard (CA) came in with a great 20 GP card to take honors. In the playoffs, Walt Howell (OR) zipped to the win...and 135 MRP's! Jim Weires (MN) finished 2nd, followed by Master Elinor Breen (MA) and Victor Struminger (CA) in the 3-4 slot.

# Vignettes

## FROM RENO

With a whopping 986 players in action on Saturday morning, following the huge Tournament of Champions (512 players) that was played on Friday, the usual (or unusual) happenings occurred. Here are a few:

Henry Douglass (NC) was in action, as usual, collecting entries for his winner-take-all super Q. But this time around he was sporting a tee-shirt with an embroidered "Murphy's Law." Below the headline, it read, "'Example Division!" Douglass is, indeed, an example of the unusual.

**Life Master Bill Hill (OR)** was in action in the early going of the TOC. Oops, games 2, 3 and 4 knocked him for a loop. He lost all three by a single point! Wait 'til next year!

**But Thomas Koncan (IL) had whining rights big time! He lost all 16 games in the qualifying round of the TOC!**

And Todd Schaefer (MN) was in a dither after holding seven 4-5-5-6 combinations. He cut a deuce all seven times!

In the Main Event, Al Booth (MN) won the cut for deal 21 times in a row. The 22nd game, he cut a three-spot, and felt he was going to have a grand slam cutting. Oops, he lost that cut! With a 12% edge the first 21 games, Booth must have had a great card, right? Wrong. He posted an average 25 GP card and failed to make the cut.

Ron Morgan (CA) was in the thick of the high-hand action all weekend. In the TOC, Ron DeCenzo (CA) was seated to Morgan's left, and scored a 29-hand. Roland Hall (CA) was seated to Morgan's right and scored a 28-hand. Morgan entered the Cribbage Bowl on Friday afternoon...and dealt Mike Midgette (NC) a 29-hand! No other 29's were scored the remainder of the week. Midgette was unable to count his gem, as Morgan pegged out to end the game.

In the TOC, Al Linder (WI) and Virgil Dulin (NC), last year's JPW/ACC Open winner, had a tight game going (for a minute). Linder was in hole 57 and Dulin was dealing from hole 60. Ooops, in two hands, Dulin came home the winner with a 32-point skunk!

Bob Julian (WI) and George Bickford (MA) had one of those rare pegging sequences. Julian held 3-4-4-4, and Bickford played a 3-4-9-9 hand. The pegging (Bickford leading) went 3-3-9-4-4-4-4!! Julian pegged 22 (with a 31 for 14 play). Bickford scored two pairs and a go for 5!

Two players were observed cutting a ten for the starter, and then each pegger played a ten, with the first pegger taking 10-10-10, "30 for six! And a go!" using the starter card to pad the score! Even Grand Master Ron Morgan got a little "burned out" as the weekend progressed. He was observed using the starter card to lengthen his run of four to a run of five!

Three-Star DeLynn Colvert (MT) had a tough weekend, highlighted by his needing 11 to win with first count, and forced to hold 7-7-7. He lamented, "I led the wrong seven!" as his opponent, needing 6 to win, held an 8 and 6 card!

# Wedding Bells

Two weddings took place during the weekend. On Saturday, Scott Nordlund and Kathie Kjersten, Lexington, MN tied the knot an hour after the qualifying round of the JPW/LACC Open. The next day it was Dean Rein (son of Joan and Jim Rein) and Mary Jo Zanoth (MN) making their wedding vows! More than one couple have tied the knot at this cribbage extravaganza over the years!

Mike McDaniel (WA) was in a foul mood when he failed to qualify in the TOC by a handful of spread points. He failed to notice one of his opponents had written the wrong spread-point score on his card, causing him to miss the playoffs. However, he was the high non-qualifier...and won a lighted cribbage board, donated by Tournament Games.

Dwight Christiansen, Monroe, CT, qualified with a 33-GP card in the JPW/ACC Open and went three rounds in the playoffs to earn 77 Master Points...and the ACC's 69th Life Master (6,052!). Undoubtedly, with the huge crowd, many others in attendance earned their Master, Grand Master, and Life Master as well.

And for the majority of the field who went home empty handed...it was, "Wait 'til next year!"

## 222 In St. Croix Bingo! It's Wingo!

Director Alan Lindner once again put on quite a show at the February edition of the St. Croix Classic in Turtle Lake, WI. Lindner squeezed in a maximum 222 players...and when the playoffs had wound down on Sunday afternoon, only Bob Wingo, Zion, IL, remained unbeaten in playoff action. The win netted \$1,700, a nifty trophy, and 196 MRP's. Wingo was hot in the playoffs, as he also scored a 28-hand enroute to the win.

Frank Trojan (MN) is edging ever closer to his Life Master rating by taking 2nd (and \$1,300). He stands at 5,800+ (lifetime). Clarence Charles (WI) and Master Ken Benson (MI) finished 3-4...and garnered 105 MRP's. Grand Master Norb Upton (MN) nailed the qualifying round with a nice 37 17 +189 to take honors.

Bob Joslin (MN) won the 134-player Consolation, nipping Jerry Goedert (WI) in the final playoff match. Grand Master Les Kvien (IL) and Francis Pasiuk (MN) finished 3-4. Earl Fox (MN) took qualifying honors with a 17 8/9 +124.

Once again, director Lindner had satellite events, complete with casino perks galore. The winners:

An unusual game was played by Don Flesch (WI). He drew for two 29-hands...and missed both cuts.

Lindner reported total casino perks reached a whopping \$8,575! Needless to say, this attributes to the high interest in his events. You must sign up early to enter. With some \$149,975 in perks awarded in the 20 events played at the St. Croix Casino, coupled with great food, and complimentary soda and juice, make these events a top attraction in the Central Region.

## Rollie Heath Tops In Oregon

Rollie Heath is running for governor in Colorado, so what was he doing in Prineville, OR playing cribbage? And if he is concentrating on being elected, how could he possibly win the Oregon Cribbage Championship?

Now for the rest of the story. Wrong Rollie Heath! The ACC's Rollie Heath is a Life Master from Lincoln City, and he rolled to the win, besting some 112 players. His final match was a blitz, nailing three-star DeLynn Colvert (MT) 3-0 to walk away with 147 MRP's, a cool \$1,000, and the top Super Q prize. The win propels Heath into the thick of the annual MRP race as well (standing at 600+). Colvert's 2nd place and aggregate 135 MRP's zip him among the leaders as well (unofficial 842).

Master Ralph Reynolds (OR), along with spouse Marvis, have long been directors of this event, but retired last year. With the spare time, he finished 3rd. Betty Nolz (OR) also finished in this bracket, taking home 70 MRP's. Rod Taylor (OR) scored a nice 36 16 +256 to win qualifying honors.

The Consolation drew a whopping 82 players, and it was GN VIII King Harvey Honeycutt (OR) coming home the winner. Jim Taylor (OR) nailed down 2nd, followed by Master Marty Symons (OR) and Dean Bauman (OR) in the 3-4 slot. Carolyn Blackman (OR) won 8 of 9 with two skunks to take the top spot in the qualifying round.

In an oddity, Jerry Hearsom held a 4-4-5-6-7-8, and discarded the 7-8 to Burt Ellis's crib. Oops! Burt discarded a 7-8 also...and a 6 was cut. Both players scored a 24-hand! Needless to say, there was a vacant chair behind them after they finished this hot game!

Hazel Weichselder (WA) and Chris Christenbury (WA) donated the 2nd place trophy board (doubles) at the Washington Championship. In a rarity, they won their own boards back!

## Mary Gladish Tops Pacific Coast

Grand Master Mary Gladish, Concord, CA, is zeroing in on her Life Master rating by winning the large Pacific Coast Championship in late January. Mary is well known for her many poems..and this championship may be grist for another rhyme. Her win came the hard way, as she faced the formidable One-Star Bob Julian (WI) in the final playoff match. Julian is in the hunt for his 4th National Championship, and by finishing 2nd in this 124-player event (105 MRP's) he runs his 2002 MRP's to 676 and is among the leaders.

Grand Master Jack Shumate III (CA) is also in the title hunt this cribbage year and finished 3rd, tacking on yet another 70 MRP's and he, too, is among the leaders. Tom Owens (CA) is nearing his Master rating by taking home 4th (70 MRP's).

Veteran Boyd McDonald, a Grand Master from Mountain View, CA nailed the qualifying round with a 33 GP card, unusually low for the top card in a field this large, attesting to a veteran field in action.

A sizeable 86 players stayed for the Consolation and it was Canadian Linton Walker taking home the top prize. Local pegger Ken Mitchell (Salinas) finished 2nd, followed by Pat Farris (CA) and Bob Cross (CA) in the 3-4 slot. Master Don Brown scored a superlative 18 8/9 +183 to take honors in the qualifying round.

# TIP

of the month

One of the last break-throughs in my game was observing that when my opponent did NOT have a 10-card or a five on the table when pegging, and it was my lead holding a 10-card and five, leading the five is the percentage play. A shrewd opponent will set a trap for your five and if you hold it for last, it will cost your three points (example: Q-7-5-6, Q-4-5-6, or Q-4-5-3)! A 5-7-Q-6 is much better!

62,748,517 to 1?

No, 435,984,840 to 1!!

In January's *Cribbage World*, the report was that when Leonard Goodman and Linda Fruhmenn tied seven consecutive times when cutting for the deal, the odds were 62,748,517 to 1!

Wrong! Bruce Bowman (Cribbage Master) and several other peggers report the figuring of the odds were wrong. *Cribbage World* had each cut at 13-1, when, in fact, the odds of tying a cut is 17-1. When the first player cuts a card, there are 3 of 51 cards in the deck that will tie that cut, hence the 17-1 odds. Then the formula goes  $17 \times 17 \times 17 \times 17 \times 17 \times 17 \times 17 \times 17 \times 17 \times 17 = 435,984,840$  to 1! Goodman and Fruhmenn can rest assured they will own that record for a long, long time!

## Nelson Bakken Earns Master

Last month's *Cribbage World* did not receive the Master Points, the Tournament Results, or those players earning a new status, due to computer foul-ups.

A late report has Nelson Bakken, Chaplin, CT earning the ACC's 491st Master rating. Some 2,000 Master rating Points are required for this title.

## Syl Lulinski Contortionist?

Executive Vice-President Syl Lulinski decided to head for Reno's JPW/ACC Open extravaganza via Amtrak. This trip required an overnight stay in a narrow berth. He reports he had to be a contortionist to dress in his berth the next morning. He finally gave up and dressed in the aisle.

## Roy Cook Central Coast Champ

With a rare one-day event in the Western Region, it was Master Roy Cook, Oceanside, CA, coming home the winner. With 62 players in action, Cook garnered 105 MRP's and the top prize. Dan Wenker (CA) nailed down 2nd followed by Western Region All-Star player Roland Hall (CA) in 3rd. Art Fisher (CA) finished 4th (42 MRP's). Hall was also the meet's top qualifier (22 10/12 +181), scoring an aggregate 82 MRP's.

It was Mel vs. Mel in the 40-player Consolation. Mel Kranz (CA) nipped Grand Master Mel Ashley (CA) for the title. Master Amelee Jillion (CA) and Cy Madrone (CA) finished 3-4. Pat Farris (CA) won 6 of 8 in the qualifying round (with two skunks) to take honors.

Director Darrell Hunstad reported that Pat O'Neil scored the meet's only 28-hand, and that all events went well. The only minus was that it was a beautiful day on the California coast, and the players were indoors!

Mary Jane Esera (HI) came home the winner in the 21-player January edition of the Hawaii Open. Richard Kodama (HI) nailed 2nd.

# Synopsis

## Board of Directors Meeting Reno, NV, January 24, 2002

Jeanne Hofbauer appointed interim recording secretary.

All members present except Ready (excused). Lulinski discussed past history of BOD, listing all 122 former (and present) members. Many past accomplishments listed.

February 1, 2001 BOD meeting minutes reviewed and accepted.

Barnes questioned cancellation of Sept. 21 BOD meeting. Julian stated Executive Committee empowered to make such decisions between meetings. Definition of quorum explained.

McGibney presented Financial Report. ACC & affiliate Grass Roots in good shape. 2002 budget projects modest \$3,011 loss, but substantial assets will cover projected loss. Grass Roots software discussed. Cost: \$16,900 total, then only maintenance charges will occur. ACC pays half and GR pays other half. Budget adopted.

Accountant's draft (1-22-02) discussed. Recommendations: centralized office; separation of duties for membership secretary regarding billing and collection functions; combine ACC & GR funds to be accomplished by June 30.

Discussion regarding filing of Form 990T to report unrelated business income (advertising, *Cribbage World*). Decision to be made at next meeting.

Executive Officers elected: DeLynn Colvert, President; Syl Lulinski, Executive Vice President; Bob Wikstrom, Vice President, Policy; Bob Julian, Vice President, Operations; and George Bickford, Member at Large.

Colvert discussed National Champion award. Will be displayed at upcoming Grand National.

J. Hofbauer discussed Life Master Star Awards. BOD approved proposal at Feb. 2001 meeting. Motion approved to award watches.

Julian reported on GR meeting (Jan. 23, 2002). Changes made to GR Manual to emphasize GR and ACC one organization. Wording will also be changed on website. Rein reported 3,200 GR players and 155-160 clubs in action. She has responded to 82 requests concerning forming new clubs. Rein has appointed Kristy Haught as National Statistician, and work is under way to coordinate with Hassett and others. New system is coming together nicely, except for a few glitches.

Perkins reported on Compensation Committee actions. Recommended Rein should receive stipend of \$600 monthly, retroactive to beginning of fiscal year. Stipend to be paid from GR funds. Accepted.

Hassett discussed combining GR and ACC dues as it would eliminate duplication of some work. Tabled until later date.

Standing Committee reports: Bickford reported he had compiled a Tournament Director's Manual. One error regarding scoring system will be corrected with stick-on label. Barnes reported that two fairs and an ad sponsored in a magazine with moderate success. Shimp reported no significant changes to Judges Program. Grass Roots program covered in detail earlier. Bernard discussed Ethics Committee actions (one member half-way through a six-month suspension). Follow-up to this committee's actions will be made at September's BOD meeting.

Rein discussed General Secretary and Recording Secretary's positions. Jobs have merged, and was not original intention. Positions clarified.

Hassett discussed study to determine ways to retain members. Several suggestions discussed. *Cribbage World* will print article on how to treat newcomers and make them welcomed.

Officer's Annual Reports: President Colvert reported 14 actions taken by Executive Committee; VP Operations Julian reported coordinating reports from Hassett and McGibney; Executive VP Lulinski reported new make-up of Ethics Committee, and appointment of J. Hofbauer as interim secretary; VP Policy Wikstrom distributed report discussing Manual, and Election procedures needing changes. Ready reports "Peg Out Rule" continues to be controversial. Miller's proposals to improve judging at events has been printed in *Cribbage World*.

Colvert discussed procedure for filling compensated positions when vacancies occur. 60-day notice given membership if possible. Positions should have back-up, if possible. Back-ups to perform duties during 60-day interim announcement period.

Lulinski presented proposal to change wording of Article XI. Approved. Effective Jan. 25, 2002.

Rein discussed review of Tournament of Champions. 512 players signed on. *Cribbage Bowl* proving to be very successful satellite to TOC.

Kooistra reported 951 entries to 20th JPW/ACC Open, down slightly due to world events. First TOC had 34 players in Las Vegas in 1982.

Shumate and DeHuff reviewed GN XXI in Oct. 2002. Lodging and transportation discussed. Recognized Sands for lending playing boards, bracket boards, and providing hospitality room for travelers to and from GN XXI, and providing area at the Sands to promote event.

Kooistra and Lewis updated BOD on GN XXII to be held at the Oaks Hotel and Convention Center, Sioux Falls, SD on Sept. 19-21, 2003. 15,000 sq. ft. playing area, plus 200 rooms (\$74/double) available. 1,100 rooms nearby.

Bradshaw presented proposal for GN XXIII, with O'Neil and Stuart as co-directors. Westin Hotel in Atlanta proposed to host this event on Sept. 17-19, 2004. Details will be worked out later. Accepted unanimously.

R. Hofbauer proposed two changes to Master Point system. For 12-game, one-day event, increase MRP's in qualifying round by five points. Accepted. Hofbauer also proposed Consolation events change from a 3 + 3 system to a 4 + 4 system. Approved. Both changes effective August 1, 2002.

TOC and JPW/ACC Open playing site proposals discussed. The Sands, Hilton, and Atlantis were contacted. Hilton did not respond, but proposals from Sands and Atlantis discussed. The Atlantis did not match the Sands \$10,000 added prize money. The BOD unanimously approved the Sands as the playing site for 2003, and 2004.

TOC, JPW/ACC Open dates discussed. Events will be held one week after the Super Bowl.

R. Hofbauer questioned how extra \$3,000 added by Sands would be allocated. Tabled until Oct. meeting.

Barrett reported 9 candidates nominated for Hall of Fame (Alkas, Biegler, Bernard, Capper, Hatcher, Irons, Julian, Palmer and Schmidt). Three elected: Alkas, Bernard, Schmidt.



Bieckford proposed the ACC purchase scorecards, to be available for sanctioned events. \$1,219 for printing accepted, unless Sands agrees to provide them.

Wikstrom discussed Senior Judges position and possible elimination, and a possible condensation and consolidation of the manual to make its use easier. Senior Judges position eliminated and sections 13, 18, and 19 in the manual, under section 18 will be combined.

Hassett discussed Social Security numbers given to directors is a violation of the privacy act. Decision to allow SS numbers only when prize money meets criteria. Sands will no longer ask for SS numbers in advance. Policy will be updated in manual.

\$300 for Puyallup Fair approved for another year. Barnes suggested adding donation for fair in California (Hastie). BOD will wait for formal request with details before approval.

Barrett (Internet Committee Chairman) announced replacement of Sattler as webmaster. Five applicants received, with Paul Gregson (CA) selected. Gregson requested \$863.45 to upgrade program, making it easier and faster to maintain. Discussion included advertising, audits, and related issues. Gregson praised for outstanding website, off and running in record time. Upgrade program approved unanimously.

Hassett and Wikstrom discussed manual; preface, 3, 8, 9, 21 and 25. Hassett asked for authority to put manual in consistent format and correct spelling and grammar. Approved.

Wikstrom presented changes to section 3 (awards). Should be more descriptive, and Rein would like to add information about GR awards. Manual Committee will take action to improve this section.

Hassett discussed change to section 8 regarding official use of commercial software. Modification to item 8-equipment, as proposed, accepted. Hassett discussed changes to section 9-ethics. Tabled until next meeting. Section 21 changes accepted with minor changes (junior members have been excluded from voting). Section 25 discussed previously (dropping GR dues). Discussion about Life Members dues will be tabled for later action.

Actions deferred: format for Hall of Fame Voting (Heath); internet cribbage (Barnes); elimination of cutting for deals in qualifying rounds (Christiansen); junior members voting in BOD elections (Julian).

Next BOD meeting: Friday, October 4, 2002, North Tahoe Community Conference Center, Kings Beach, CA (GN XXI).

Meeting adjourned. Minutes recorded by Jeanne Hofbauer.

Matt Easterbrook (VA) came home 2nd, and carted home 105 MRP's. Master K. C. Finley (CT) and Grand Master Frank Corrado (CT) finished 3-4 (and 70 MRP's). It was Paul "Bear" Finley (CT) scoring a nice 22 GP card in the 12-game qualifying round. The card netted 40 MRP's...but beginning August 1, 2002, this score would be worth 45 MRP's (see article this issue concerning MRP's).

52 players stayed for the Consolation and it was Dan Patriss (CT) winning the event. 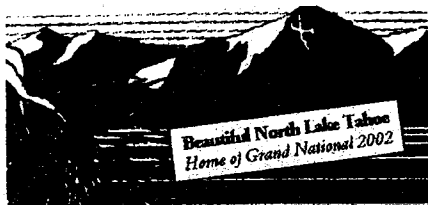

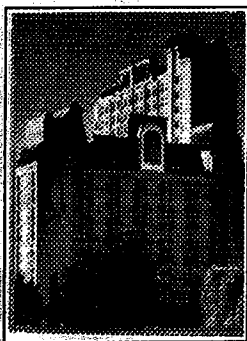

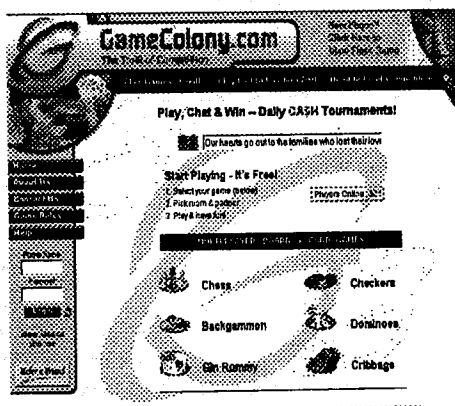

## Master Point Change: August 1, 2002

The Board of Directors have voted to make slight changes to the Master Points awarded in sanctioned tournaments.

Western Regional Tournament Commissioner Roy Hofbauer analyzed two situations that awarded slightly lower numbers than was logical. The first is the number of MRP's available in the qualifying round of a one-day 12-game round (common in the Eastern Region) vs. MRP's available in a two-day 22-game round. In looking at averages, Hofbauer found that for the same number of players, the 12-game round events awarded 4,115 MRP's, compared with 5,195 MRP's awarded in a 22-game round. Upon presenting this data to the Board of Directors, they voted to raise the value of each game point (12-game round) by 5 points, beginning with 5 points at 14 GP's instead of 5 points at 15 GP's. Each player that finishes the qualifying round in the top 1/8 would receive an extra 5 MRP's. This change will give parity to the 1-day and 2-day events (within 5%).

Consolation playoff points were also analyzed, with many BOD members feeling that the 3+3 system was a tad low (the Main Event awards 7+7). Hofbauer proposed a 4+4 system. This proposal was voted in place, effective August 1, 2002. The Consolation playoffs would award points as follows: 4-12-24-40-60-84-112-144-180. This would increase the Consolation playoff points 25%. An analysis by National Statistician Bob McCabe indicated our new system (Main and Consolation) was about 5% under the old system. These new changes address that complaint.

## www.cribbage.org Web Site Upgrade

Paul Gregson, San Leandro, CA, has an outstanding web site on line, as reported in January's *Cribbage World*. According to Gregson, this web site is hosted by RCN, a small web-hosting company based in Princeton, NJ. The account the ACC currently has is no longer supported or available for purchase and allows for the use of static, manually coded HTML pages. The cost for this service is \$215.40 annually.

Gregson proposed that the ACC switch account types to a far better package (Gold package). This upgrading costs \$863.45 (annually) and offers a multitude of increased benefits, including timesavings and better organization, tracking capabilities and more advanced web-site features, much of which will be automated. With this upgrade, Gregson can add sites like site registration, players section, enhanced schedules/results, enhanced club directory, Grass Roots results, online advertising, enhanced statistics, and other capabilities.

The Board of Directors unanimously voted to give Gregson the go-ahead to purchase the Gold package.

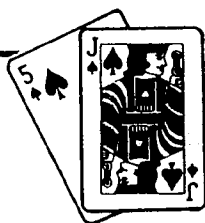

## **Three Voted Into Hall of Fame** **Rit Alkas,** **Joe Bernard,** **Phyllis Schmidt** **Earn Hall of Fame Honors**

At the Board of Director's meeting in Reno, January 24, three of the ACC's finest players were voted into the Cribbage Hall of Fame. They join 20 other members in this elite group, with the membership now standing at 23. They are:

**Rit Alkas**, Manchester, CT (deceased): Rit was one of the ACC's great players, having earned a National Championship in 1995, and All-American honors in 1997. He earned a whopping 9,914 MRP's and stands among the top twenty, lifetime, in the ACC. His trademark was a black sailor's hat, worn at a jaunty angle, the epitome of an old "salt" playing his favorite game. His expertise on the boards was matched by his good sportsmanship and comradeship shown to his fellow players. He always had time to help new players, and was, indeed, a great asset to the American Cribbage Congress. He had enormous support from his fellow players in his nomination, and he was easily elected in his first try at this honor.

**Joe Bernard**, Antioch, IL: Joe is also one of the ACC's great players, standing 3rd in the ACC, lifetime, with nearly 14,000 Master rating Points. In addition to earning one of 13 One-Star ratings, he has earned All-American honors six times. Many of his fellow players give him great credit as "being the best of the best!" His cheerful volunteering of his time in administering ACC duties, in addition to his prowess at the game, make him well deserving of Hall of Fame honors.

**Phyllis Schmidt**, Williamstown, MA: Phyllis is one of the ACC's founding members, and from day-one has been a force on the boards. She has earned All-American honors five times and was crowned National Champion in 1992. She is currently ranked 6th, lifetime, in the ACC, scoring well over 13,000 MRP's, and is the top-ranked ACC member of the fair sex. She is a member of the ACC's Board of Directors, and has volunteered her services in directing tournaments, and helping at others. Her cribbage-playing prowess, in addition to her outstanding sportsmanship, make her a well-deserved addition to the Hall of Fame.

## **Atlanta Awarded** **Grand National In 2004**

Atlanta, Georgia has been awarded the playing site for Grand National XXIII by vote of the ACC's Board of Directors. The event will be played at the Westin Atlanta Airport Hotel and Convention Center. The directors will be David O'Neil, Bobby Stuart, and Gene Bradshaw.

This trio have expertise in managing events, and this one promises to be a good one. The Westin is a beautiful facility, and has a spacious convention center with a grand ballroom measuring 123' x 53' (6,519 Square feet) with other large rooms available, if needed.

The next Grand National stops? Lake Tahoe (GNXXI) this October 3-6, under the direction of Jack Shumate, Greg Schleusner, Annett Eiffert and Dan Zeisler. Grand National XXII will be played at the Oakes Convention Center in Sioux Falls, SD in 2003 under the direction of Scott Kooistra and JR Lewis.

All three of the upcoming Grand Nationals are on track for hosting outstanding events. Mark your calendars.

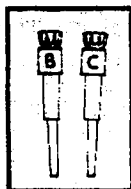
## Phil Vierela Wins Entry
