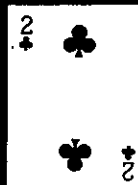

Rookie Player Cops Crown!

Ken Totten Wins Huge Washington Championship

Ken Totten, a new ACC player from British Columbia, scored a rare win in a first-time sanctioned event, coming away with the Washington State Championship, played in Centralia, WA on January 10-12. With 236 players in the field, Totten begins his ACC career on a high note, taking home 196 MRP's, a nice trophy, and a \$1,300 winner's check. And he had to do it the hard way, as his final-match opponent was GNXXI Champion Master Mike McDaniel (MT). By finishing 2nd, McDaniel throws his hat in the ring for the National Championship as well, running this year's tally to the 800 mark. Steve Harding (CA) and Ward Logan (WA) nailed down 3-4 (and 105 MRP's each).

Don Keuter (WA) was sizzling in the qualifying round, coming home with the top score of 38 18/22 +245.

With some 160 players in the Consolation, Master Lee Chambers (OR) zipped to the win and earned 112 MRP's, very nearly enough for his Grand Master. Master Lynn Gillespie (WA), Bob Page (OR), and Larry Antijunti (OR) finished 2-3-4. Master John Furler was smoking in taking home Q honors...19 8/9 +227.

"Ras" Rasmussen went all out in promoting this event, and had prizes galore, with added prize money for every event, in addition to a full schedule

of satellites. The winners:

Director Rasmussen is undoubtedly the king of the cribbage promoters, as he beat the bushes for prizes galore. Some \$2,000 in raffle prizes were up for grabs, and 22 trophies were sponsored by various business firms. Ras paid awards for 23-hands and 28-hands, with a bonus \$630 paid to the players. The host Moose Lodge proved hospitable, furnishing meals morning, noon, and night, in addition to a reasonable bar. Bob Brumley (WA) copped the grand raffle prize (\$160 value) by winning next year's entry and two nights lodging.

And to prove how much players liked the format, a whopping 61 players stayed for the Last Chance. Mark your calendars for next year's match...and watch a real promoter in action!

Steve Gawryluk, pegging out of Stewartsville, New Jersey, wound down 2002 in style. On December 28 he nailed the Chesapeake Bay Holiday Classic II played in Bowie, Maryland. With 70 peggers in the field, Gawryluk brought home 147 MRP's...and bragging rights.

His final match was vs. Maynard King (PA) and his cards remained hot for the win. King took home 105 MRP's for 2nd. Harvey Greenberg (VA) and Lou Kessler (MD) finished in the 3-4 bracket.

Harry Palmer, (MA) recently became the ACC's 3rd Two-Star player, and his qualifying round score tells all...he scored a whopping 24 11/12 +255 to easily take honors, and another 55 MRP's.

Bob Milk (VA) won the 56-player Consolation, nipping Master Dan Moore (NJ) in the final playoff match. Master Bernard Whitfield (NC) and Norm Herbert (MD) finished 3-4. Terry Howard (MD) won 8 of 9 +97 to take Q honors.

Directors Tom and Linda Brent reported Alice Haught (VA) scored the meet's only 28-hand. No 29's showed in the ACC's last sanctioned event in 2002.

Bob Page Scores 29 in Doubles!

Rob Medeiros Nails Northern New England

Life Master Rob Medeiros (MA) came to play at the recent Northern New England Championship in Portsmouth, NH as he topped the 79-player field...and added yet another 147 MRP's to his lofty lifetime total (6,400+). Carl Palmer (ME) took home 2nd money and 105 MRP's, followed by Jerry Gaff (NH) and Grand Master Zeke Veradt (MA) in the 3-4 slot. Veradt's 70 MRP's have him knocking on the door for his Life Master rating.

Life Master David Clemmey (MA) has been burning up ACC cribbage boards for the past several years, but qualifying tops has eluded him...until this match. He qualified no. 1 with a nice 34 GP card (22 games) and continues piling up MRP's, standing at over 8,700 (lifetime).

Master Pat Llewellyn (MA) scored a nifty 18 GP card in the qualifying round (9 games) of the 40-player Consolation, and came home 4th in the playoffs to take home an aggregate 45 MRP's. But it was Master Warren Gallagher (MA) coming home the winner in the playoffs. He nipped director David Campbell (ME) in the final match to win going away. Campbell, last year's rookie of the year and a member of the All-American team, directed his first event. One-Star Bill Medeiros (MA) finished in the 3-4 bracket with Llewellyn.

Campbell conducted a Friday Early Bird event, won by Bruce Brown (MA), and he reported two sanctioned 28-hands (Henry DeLong and Wayne Marchulaitis) and two non-sanctioned 28-hands (Bill Medeiros and John Chambers). A three-person team event saw David Clemmey, Jim Clemmey, and George Bickford take home the marbles. All in all, Campbell was pleased with his first event, that came complete with a 28 & 29-hand table, plus a 24-hand table. The facility was also first-class, adding to an enjoyable match for all.

Hawaii Cribbage December: Fred White January: Kathy Tsark

It was Fred White winning the December edition of the Hawaii Open, and Kathy Tsark coming home tops in January. Tsark also finished 2nd in the December match. Angela Lee (HI) finished 2nd in January.

White was also the December's meets top qualifier (34 16/22 +167). Ken Ching topped the January match with a 21 10/12 +129).

Director Tsarkie reported nary a 28 or 29 hand in either event.

Wrightman Right On!

Debbie Wrightman's (CA) chances looked slim when her opponent, Paul Yellon, needed but four points dealing to win the final match, but the cribbage gods went south for Yellon. He finished in the stink hole...and 2nd place at the recent Central Coast Open, Arroyo Grande, CA. With 62 players in action, Wrightman took home 105 MRP's...and an invite to next year's Tournament of Champions. Yellon copped 70 MRP's in finishing 2nd.

Master Cres Fernandez (CA) is in the hunt for the national championship, and a 3-4 finish keep him among the leaders as this year's competition hits the half-way mark. He is knocking on the door with almost 800 MRP's in the bag. Floyd Sowinski (CA) also finished in the 3-4 slot with Fernandez.

Norm Nikodym (CA) topped the field in the Q round with a nice 21 10/12 +142.

Aljean Simpson (CA) very nearly ran the table in the 36-player Consolation, qualifying tops with a 14 7/8 +86 and finishing 2nd in the playoffs. Grand Master Mel Ashley (CA) took home the top prize, with Barry Robson (CA) and George Waudby finishing 3-4. Director Darell Hunstad reported nary a 28 or 29 hand showed.

Kaye Knight, Kaye Knight!

At the recent X-Mas Moose Nugget Classic in Anchorage AK, it was Kaye Knight all the way as she qualified tops and took home the bacon in the playoffs as well. With 33 players in action, Knight brought home 135 MRP's (aggregate)...and bragging rights galore! Three Alaskans finished 2-3-4: Orbin Hatton, Robbie Robinson, and Chuck Feters.

Don Captain (AK) repeated Knight's trick and copped the Q round and won the playoffs as well in the 20-player Consolation. Chuck Berg (AK) took home 2nd.

A highlight of this event saw Wayne Pinquoch (AK) score the ACC's 10th 29-hand this cribbage season...and a \$100 check will soon be in his hands, courtesy of the ACC.

Kirby, Langley Get Jump On 2003!

Willie Evans, Richland, WA, is a sportsman nonpareil. To kick off the 2003 year, he began a match at his home at the stroke of midnight.

At 12:20 AM Jo Kirby (WA) plunked down a 28-hand and lays claim to scoring the new year's first 28-gem.

Then along comes 2001 National Champion Jim Langley (CA) and he kicked in the new year by winning the match, and yet another \$350 to pay his gasoline bill for a couple of months. Jeanne Jelke (WA) took home 2nd, as the new year was kicked in with gusto...and some hot cribbage!

Hard Luck Story

Cribbage World has heard just about every hard-luck story there is, but Alan Lindner has the best of the bunch this month.

As most of us know, he directs the St. Croix events at Turtle Lake, WI, and he also plays. In some 24 events, 122 28-hands have been scored (at \$250 each), and three 29-hands have earned \$500 each for the lucky recipients. Alas, despite playing in every one of these 24 events, Lindner hasn't made a dime on a 28 or 29-hand.

In January, Lindner played at the Northern Lights Casino...and they paid the first five 28-hands a bonus of \$100 each.

In game two of the Consolation up jumped a 28-hand for Lindner! Wow! One hundred bucks! Oops, not this time...this was 28-hand number six! No \$100! To make matters worse, in this game he needed 7 points to win with first count, but scored only four. Life ain't fair!

Tsarkie Skid Over

Tsarkie is the director of the monthly Hawaiian events, but he has had a long drought of not winning.

Finally, he broke the ice. With the score 1-1 and the match on the line, opponent Angie Lee appears to have the match in hand, needing but a single point with first count. Tsarkie needs 3 to win and holds a 1-2-3-K. Lee leads a 9, Tsarkie plays his king, then Lee plays a 6 for "25." Tsarkie plays his 3 and it's a go...and 3-2-1 and out! Drought over!

TIP of the month

The five best discards to your own crib:

5-5 = 8.876

2-3 = 7.135

5-J = 7.089

5-6 = 6.809

5-K = 6.726

These are average scores compiled by Ras Rasmussen (WA) over the years. His numbers are compiled the good old-fashioned way...he has played and recorded them all.

I recently played a hand and discarded two 5's. Duane Toll (WI) was standing behind me and later made the comment that he would not play the hand that way, as a 4-point sacrifice was made to discard the two 5's. The hand:

3-3-4-5-5-8

Luckily a 5 was cut, making the play a 2-point winner (14 hand and 14 crib). According to Ras's tip above, the two 5's are worth 8.9 (average). My book has the 5-8 discard worth 5.5 (average), making this play almost a wash statistically. My reasoning? I like to keep an "out" card in pegging, especially keeping two cards that add to 11. The 8 is a "sleeper" and I prefer that combination while pegging. Let the argument begin! Ed.

Nevertheless, I do have some minor complaints about how our tournaments are conducted. Now, I hope our directors don't take offense, as we are 99% wonderful, but I want to make them 100% wonderful. Two small items; 1- It seems like the 2nd round playoffs get slighted in the playoffs. If round one pays \$50, shouldn't round two pay \$100? A recent large event paid first round losers \$60, and second round losers earned \$65! \$5 for the 2nd round! I urge directors to scale their playoffs on a straightline basis, or, as most sporting events, on a slowly accelerating scale, with the winner getting a nice bump! 2- First round playoff players are commonly squeezed into a small area, when the entire room is vacant. I have heard many complaints about unnecessary crowding in this first round. Please, directors, set the boards in play with ample elbow room. Use this motto: "If I have the space, use it!"

And that's it, folks. Play on! We have a wonderful group...the best in the nation! Camaraderie is legend in cribbage! Let's keep it that way!

Landlubbers Rule The Day

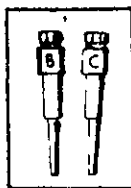

Synopsis BOD Meeting

October 4, Kings Beach, CA

Meeting called to order at 9 AM. All members present except Barrett and Bickford.

Shumate, GNXXI director, reported on progress on event. Hassenplug and Swartz (North Lake Tahoe Business Assoc.) welcomed ACC to Kings Beach.

Lulinski asked BOD to consider proposals on merit, not individuals presenting them. Minutes of Jan. 24, 2002 meeting accepted with no corrections. Hassett handed out new BOD rosters.

McGibney presented financial report. Report reflects merging of Grass Roots accounts with the ACC system. Fiscal year 2001 auditor's report affirms that assets and liabilities are properly stated. Income statement has been compiled, not confirmed. FY 2001 first year showing combined net assets of the GR with the ACC. \$30,500 was forwarded to Rein from GR, Inc., which was then forwarded to ACC. An increase in equity of \$77,000 for FY 2001 is shown, which includes \$45,000 from GR and \$30,000 recovery from Monroe. McGibney discussed auditor's report that ACC should consider financial control by requiring two signatures on checks over a certain amount, with a second party receiving dues and reporting to Membership Secretary. Julian stated that he receives monthly reports from Hassett and quarterly reports from McGibney, and he cross-checks them, so system is in place. McGibney discussed filing of 990T tax return, mainly for *Cribbage World* advertising.

McGibney discussed FY 2001 Profit and Loss Statement. Bottom line showed a \$4,000 gain for ACC and a \$9,600 gain for the GR.

In 2002 the ACC had \$91,000 in income and \$110,000 in expenses for a loss of \$18,400. GR had \$26,000 income and \$38,000 expenses for a loss of \$12,000. The combined organization lost almost \$31,000. Advertising, dues and interest were under budget. Postage \$2,300 over budget, promotion \$4,000 over budget (new banners and bumper stickers). Printing was \$1,000 under budget. A recap of ACC equity positions showed \$100,000 in equity in June, 2000. June, 2001 showed \$182,000, and June, 2002 had \$151,000 in equity.

McGibney discussed FY 2003 budget, keeping GR and ACC items separate. Projected income for ACC: \$93,724; for GR: \$25,462. Projected expenses for ACC: \$106,185; GR \$28,150. Projected loss is \$15,149. McGibney asked for \$4,000 for 2002 audit. Approved. Cribadier General program has balance of \$7,547. Julian questioned two items: \$4,000 for One Star Life Master watches and \$4,400 for GR software development, in addition to approved \$16,000. Rein reported there will be continuing maintenance expenses, but should not exceed \$2,000. Budget for FY 2003 approved.

Barnes reported that Monroe has a betting site on internet ("Lucky Elf"), and suggested Julian alert California authorities.

Executive Committee report: Voted to purchase 200 vinyl banners, voted to fund Lassen County Fair booth (CA), and accepted Wikstrom's resignation. Wikstrom's replacement left vacant for short period to allow BOD to vote replacement (Hassett).

Lulinski reported that Bernard's Ethics Committee operating efficiently. Kooistra would be reporting on GN XXII (SD-2003) and O'Neil would be reporting on GNXXIII (GA-2004) later during meeting. Request for bids for GNXXIV (2005) to be published in Oct. CW.

Julian reported Hassett working on developing computer reporting system, and hopes to have it available for Feb. BOD meeting.

O'Neil reported on Atlanta GNXXIII. Event will be at Westin Hotel 3rd week in September, 2004, with O'Neil, Bradshaw and Stuart as co-directors. Many perks on agenda.

Colvert (President), Lulinski (Executive Vice-President), Julian (Vice-President, Operations), Hassett (Vice-President, Policy), and Bickford (Executive Member at Large) all elected unanimously to form Executive Committee.

Committee Reports: Ready (Rules), nothing to report. Barnes (Public Relations Marketing), nothing to report. Shimp (Judges): inappropriate judging calls may call for decertification, asked for suggestions. Lulinski suggested directors of events name known judges. Poor judging calls should be reported to Shimp. Bernard (Ethics) reported two individuals suspended (cheating and leaving event without finishing match). Notarization of complaints eliminated as being unnecessary. Rein (Grass Roots) reported 160 GR clubs playing and 95% reporting statistics on line. After overspending on computer software, programs are working well now. Kristy Haught, new GR Statistician, introduced. Valerie Sumner appointed National GR Secretary. GR meeting in Reno is limited to BoV members. Wilson has replaced Hurlgen as Region 4 Commissioner. GR awards cost will increase. Rein discussed GR Manual, available on GR web site. Items discussed, with changes discussed to be incorporated in final manual. Approved.

Hassett (Membership) distributed new pamphlet "Cribbage Anyone?" with address and other changes. ACC has 7,154 members. New Rule Books needed in about a year. Printing and foreign mailings discussed. Report approved.

Barnes (Membership Retention) reported no action on this committee. Will discuss at Reno meeting.

\$3,000 extra added money to TOC/IPW-ACC Open by Sands will be distributed to ACC Open, mainly to lower brackets. Approved. Rein opened for bids for TOC/ACC Open. Reno Hilton's bid offered less than Sands. Morgan, and others, commented that the Sands has helped the

ACC in many other ways. Rein asked for \$1,000 "up front" money for TOC expenses. McGibney suggested a financial report from TOC and ACC Open, will be discussed at Executive Members meeting.

Lulinski presented constitutional amendments including voting age, commencement and expiration of BOD members, possible officers 2-year terms, and committee reorganizations following elections were discussed. All passed, with no nays. Ethics violations amendments tabled until Reno meeting (Feb.).

Christiansen presented proposal to eliminate cutting for deal during qualifying rounds. He stated this would promote fairness, and presented statistics to back proposal. The dealer wins 56-44 and wins skunks 2-1 ratio. Some BOD members felt this would be a disadvantage to new players, as they would never have a run of cuts to neutralize experienced players, and would eliminate the excitement of cutting for deal. Barnes reported a poll of internet players was evenly split at 50-50. Motion defeated 14-6.

Heath presented proposal for Hall of Fame selection. Basically it selects by 65% playing ability, and 35% contributions to the ACC. Proposal designed to eliminate biases and personality clashes. His proposal would establish a 7-person committee with the Chairman a member of the BOD, and 2 members from the Eastern and Central Region, and 3 members from the Western Region. A point system based upon 100, with 75 needed for automatic induction into HOF, unless nomination has 75% negative vote by BOD. Proposal to be discussed at length at Reno meeting (Feb.).

Barnes presented a need for an internet director and ACC internet play. Fosdal runs internet tournaments and she can set up her website to use the ACC scoring system. ACC internet commissioner needed to make sure website directors are honest and trustworthy. He suggested Bob Milk, who has experience in this area. Barnes asked to present ideas at Reno meeting.

Computer system comparison not yet ready, as Hassett is still working on his system. Evaluation may be made at Reno meeting.

Colvert reports Gregson's ACC website off and running, and he is working without compensation. Colvert feels he should be rewarded in some manner for his work. Item to be discussed at upcoming Executive Committee meeting.

Kooistra reported that GNXXII will be held at the Holiday Inn City Center, which is a change of playing sites. This facility will hold 500 players. Rooms are \$79-\$89 with a \$25 banquet. Rein and Lewis are co-directors.

Meeting adjourned. Jeanne Hofbauer, secretary.

Wally Reed

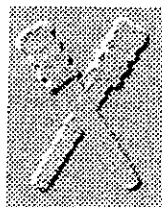
Seymour, Wisconsin

The "Members Only" site referenced above is accessible to any player with an ACC number and does not require any special computer skills. Simply click on the site and you will be able to review a wealth of information such as a directory of clubs, commissioners, club manual, rules, and personal statistics by player, club, region or division.

For our newer Grass Roots Members
Club Member?? Visitor?? Guest??

You are a Grass Roots (GR) club **Member** of the local GR club to which you have paid your \$4.00 GR registration fee. Your American Cribbage Congress (ACC) Membership must also be current.

If your membership in both ACC and GR are current and you play in a tournament hosted by another club you are considered a **Visitor**. It is important that visitors let the tournament director of the club they are visiting know if all of their fees are paid for the current season.

If either one of the above fees have not been paid you are considered as a **Guest**. This includes former club members who have not yet paid their ACC or GR fees for the present season.

During all GR Tournaments, the top 20% of the members present will earn GR Rating Points. When two or more players tie for the last position within the 20%, all tied players will receive their GR rating points. Visitors and guests do not earn points as only the members of the hosting club may earn GR points.

The Newnan, GA South Siders held their regular Grass Roots tournament on December 16, 2002. Paul Majkowski (GA 352) scored his first ever 28 hand, playing against Lois Dillhoff (OH 145). He kept the 5-5-5-K and cut the case 5. This was good for \$120 Christmas money from the skunk bank. The following week, Estill Elliott (NV 197L) a welcome Nevada transplant along with his wife Carol (NV 242) waded through nine opponents to attain a Grand Slam. The club usually awards \$20 for one of those jewels, but Paul had cleaned out the skunk bank the previous week so Estill had to settle for only \$6. Ouch!

Grass Roots Club 203 in Prince George, BC meets on Thursdays for Grass Roots tournaments and they also play an informal session on Tuesday mornings. Since not all exciting things happen during official tournaments, the December 17th Tuesday session produced the following situation: One player held 5d, 5s, 5c, Jd, Jc and Kh. Club 58 in Raleigh, NC held a GR Tournament on December 9, 2002. Charles Lebrasseur (NC 550) and David Lambeth (NC 133) both won nine games in a row for a Grand Slam Scorecard!

Mark Liebermann (CA 2559) in Yountville, CA has qualified for his Bronze award! Mark plays with Club 100 in Napa, CA. Here we have an avid cribbage player. Mark has attended 226 of the last 232 weekly tournaments, and plays on a daily basis at the Yountville Veterans home. Club 100 meets on Tuesday evenings and a vote was taken in early December to see if the club wanted to play this past Christmas Eve and New Years Eve. Mark was the only player who voted to hold a tournament on those days! Mark just missed his Bronze award last season attaining a total of 973 points. During a Club 198 session on 12/23/02, the decision for 1st and 2nd place was a very close match. The scorecard with the highest gamepoints

determines the winner. Tiebreakers are games won, then net spread points, and net plus points if needed. In this case they were all needed but did not determine the winner! Ed Weilep (WA 551) from Lilac City and Robert Ulrich (WA 973) from Valley Eagles each finished with a 16/7/+101 and net plus points of 141. It was determined to be a tie, and 1st and 2nd place money was evenly split between Ed and Robert! Most of us have never encountered this situation before in Grass Roots tournaments.

Club 46 in Salem, OR reports that Lee Bodkin (OR1654) who is recovering nicely from some serious heart problems has rebounded with a whooping 35/16 +189 card for the Grass Roots Regional Tournament played as a pre-Christmas tournament on 12/21/02. Lee then went on to take the top spot in post Christmas play with an unbeatable 16/8/ +122 scorecard.

Paul Hatcher (OR 1630) started the new year with a BANG! Paul won the top spot on 1/2/03 with an 18/8 +111 scorecard, an elusive 28 hand AND walked away with a 24 hand. The icing on the cake? Paul now leads the pack in the Club 46 quarterly race for total game points.

Club #120 of Wisconsin Rapids, WI is now in its thirteenth season. They have accumulated twenty Bronze Awards and one Silver Award. In addition, the club has attained 25 Grand Slams, three of which were by Mike Barrett (WI 1416). There have been six 29 hands, two of which were on the same night! They have Seventy-Three 28 hands as well. There have been two Grass Roots Regional Tournament (GRRT) Champions. Mike Barrett (WI 1416) and Marie Lager (WI 1897). His scorecard was 22/9/+213 and all attendees were impressed! Les graciously donated \$100 of his winnings back to the Grand Slam Pot as "seed" money. What a nice thing to do! Fran Ward Tops In Virginia

Several former winners came to Richmond looking to repeat as champion in the twelfth year of this event but it was Fran Ward (NC) edging Howard Terry (VA) 4-2 in the finals to record his first tournament win and earn 147 MRPs in this 68 player event. Terry, who qualified 5th took home 140 MRPs.

Marvin Lewis (VA) qualified first in the main event with a 37/16/296 card, but was denied a chance to duplicate his 1998 championship as he and Russ Perkins (NC) tied for 3rd. Lewis picked up 125 MRPs. Perkins, the 7th place qualifier earned 90 MRPs.

Friday evening, Twenty teams kicked off the doubles competition and at the conclusion of play Bill Medeiros and Carl Palmer (MA) turned in a 16/8/105 card for the win. Saturday night's event featured two events, the Old Dominion Special and the High Rollers. Peter Lerch of Reston, VA edged home standing Ron Reece by one game to win the Old Dominion Special. In the High Rollers event it was Bill Medeiros (again) winning 8 of 10 games to leave the rest of the field behind.

Sunday morning, while the Main event qualifiers were working their way through the championship playoffs, a field of 50 entrants turned out for the Consolation Tournament. At the conclusion of qualifying play, Steve Sattler (MD) recorded a first place qualifying round of 17/9/130 that was good for 15 MRPs. 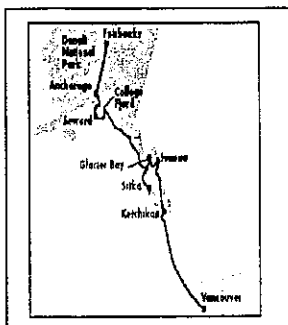

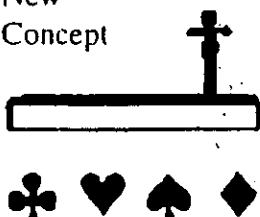

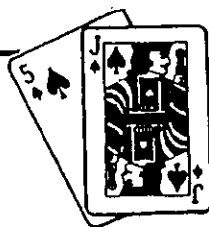
