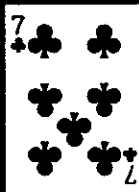
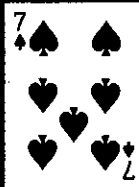

Under The Big Top

Bob Joslin Wins Outdoors at June St. Croix

The St. Croix Casino in Turtle Lake, WI was undergoing remodeling, and the cribbage event was forced to play under a 60' x 60' tent, complete with lights, heat, air, and outdoor bar. Being from Minnesota, Bob Joslin was not deterred by the fresh air and he zipped to the win at this 208-player event. The win came with \$1,600, a trophy and 196 MRP's. Grand Master Jerry Fischer (WI) finished 2nd, and garnered 147 MRP's. Master Jeff Lui (WI) and Bob Deeds (IL) finished 3-4...and earned 105 MRP's each. Shelly Vadnais (MN) took Q honors with a nifty 36 17/22 +264 (50 MRP's).

The 132-player Consolation was dominated by the ladies, as Grand National III champ, Master Grace Cummings (WI) scored a grand slam 19 9/9 +169, and Karen Bouffiou (WI) came home the winner in the playoffs. Louis DePuis (CO) finished 2nd, followed by Darlene Althaus (MN) and Alice Sather (MN) in 3-4.

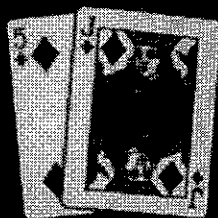

Lindner also reported that the ever-present Warren Sondericker (WI) scored five 24-hands during the qualifying round, but, nevertheless, finished with a 25 GP card, and did not qualify for the playoffs.

Lindner would like to thank all the players that attended for their fine sportsmanship under unusual conditions, and the Hawaiian look alikes for their tribute, especially Bob Chase for the "his and hers" watches for the Lindners. He also thanks Syl Lulinski for putting together a memorable event.

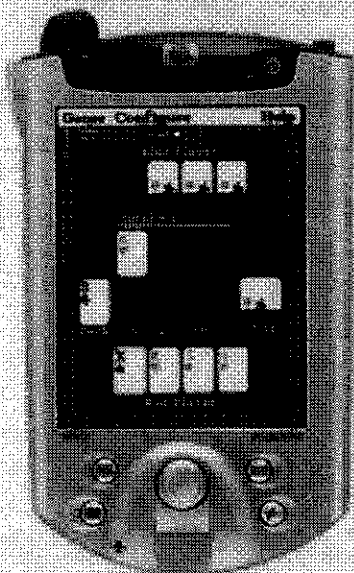

Record Breaker Charlie Brown Cops Spokane Valley

This time around "Luci" didn't pull the football away from the winning kick as Charlie Brown, the local favorite, won the Spokane Valley Open on May 25. Indeed, the kick sailed through the cross-bars dead center, as Brown disposed of four-time national champion Bob Julian (WI) in the 3-4 round, and continued home the winner by nipping Life Master Bill Wakeman in the final playoff match. This match, played to a record 144 players, awarded Brown 196 MRP's, the champion's trophy, and a sizeable winner's check. Grand Master Phil True (WA) finished in the 3-4 bracket with Julian (and 105 MRP's each). Julian's high finish propels him into the top-ten race once again, an amazing feat considering a long cold spell to begin this cribbage year.

Chris McComas (WA) set the pace in the Q round with a nice 35 16/22 +172 (45 MRP's), and he too has a shot at top ten honors.

Grand Master Ken Capper (OR) nailed the 102-player Consolation, nipping Grand Master Verne Nielsen (OR) in the final playoff match. Jim Hornbacher (WA) and Jim Langley (CA) finished 3-4, Both are Life Masters. Langley scored well in the Q round and picked up an addition 40 MRP's in the playoffs to pad his nation-leading score to the 1,600+ mark.

Pat Graves (IL) and Chuck Sladek (CA) finished 3-4. Bryant Gilkeson was smoking in the qualifying round, as this Reno pegger posted a great 40 19/22 +265 to easily take Q honors.

Master Herschel Mack (CA) was king of the hill in the 64-player Consolation. He qualified tops (18 8/8 +154) and waltzed to the win in the playoffs as well. Mack has been scoring well lately and is making a late-season charge for honors. Susan Harris (NV) finished 2nd, followed by Winona Johnson (OR) and Master Don Brown (CA) in the 3-4 bracket.

Dave Clemmey Day In CT

Life Master David Clemmey, Mansfield, MA, had a tournament to remember at the recent 23rd Connecticut Championship (Rockville, CT). He qualified tops with a 23 10/12 +165, and roared home winning the playoffs as well. With 103 players in the field, Clemmey took home a whopping 197 MRP's (aggregate) and zips to the top of the Eastern Region's leaderboard. He stands at the 1,300 mark for the year, and a shoe-in for national honors. Another Life Master...Charlie Finley (CT)...took home 2nd. Masters Bruce Brown (MA) and Pat Llewellyn (MA) finished 3-4, and added 70 MRP's to their lifetime ledger.

And the Consolation, playing to 62 peggers, saw another clean sweep. This time around, it was Stan Plachowicz (MA) taking the Q round with a 16 7 +127 and going home the winner in the playoffs as well. David Statz (NH) took 2nd, followed by Jason Collins (MA) and Life Master Bill Shoemaker (CT) in the 3-4 slot.

Director Bill Richmond reported a highlight of this event had Grand Master Joyce Vanelli (MA) scoring the ACC's 15th 29-hand this cribbage season, earning \$100 for this gem. And Kirt Flelosh (CT) scored a 28-hand in his first-ever ACC meet. Bill Shoemaker also scored a 28-hand.

Jim Langley In Catbird Seat

Life Master Jim Langley (CA) is in the catbird seat insofar as the National Championship race is concerned. The cribbage grapevine has him at the 1,800 MRP mark as we go to press, holding a 300 MRP lead on his nearest competitors. His latest exploits have him coming home the Consolation winner at the Miner's Classic in Yreka, CA (after qualifying in the main event, going two rounds in playoffs). His late season finish is a duplicate of his 2001 season. He finished with a hotrun that year and set the ACC's season record score (2,245), and appears on a repeat course.

The Western Region has a bevy of players who are in the chase, and it appears this region will dominate the top-ten race. They are: Roland Hall (CA), DeLynn Colvert (MT), Mike McDaniel (MT), Ras Rasmussen (WA), Cres Fernandez (CA), John Furler (OR), Sharon Hejtmanek (MT), and Ronald Morgan (CA).

In the Eastern Region, David Clemmey (MA), Rob Medeiros (MA), Harry Palmer (MA), and Keith Widener (NC) are setting the pace. In the Central, Duane Toll (WI), Bob Julian (WI) and Wayne Steinmetz (WI) are at the top. A score or more players have an outside chance to catch the leaders and earn All-American honors.

Paula Bergeron Takes Villager

Paula Bergeron, pegging out of Webster, NH, came to play at the recent 88-player Villager Open in Sturbridge, MA on June 8. She zipped to the win, picking up 147 MRP's. the winners purse...and bragging rights. Richard Andrews (NH) finished 2nd (105 MRP's), followed by Larry Harmon (CT) and Jeanette Verzillo (MA) in the 3-4 slot. Paul Batterson (CT) took Q honors with a nice 23 GP card (12 games)...and 50 MRP's.

Master Bob Cunningham (MA) nailed down the 52-player Consolation, nipping another Master pegger (Nelson Bakken, CT) in the final playoff match. Dick West (MA) is nearing his Life Master rating by finishing in the 3-4 slot. Life Master Bill Shoemaker (CT) also finished 3-4.

North Carolina Open Fran Ward Scores 29, Wins Tourney

It was Fran Ward's time to shine at the North Carolina Open, played at Greensboro on May 16-18. Not only did he score the ACC's 14th 29-hand this season, but roared home with the championship as well. With 75 peggers in the field, Ward took home 147 MRP's, the champion's purse, and an extra \$100 from the ACC for a sanctioned 29. Ward hails from Cary, NC, and proved tough on his home turf. Charlie Bowzer (NC) finished 2nd, followed by David Foxwell (GA) and Rosemary Glendon, Jr. (VA) in the 3-4 slot. Chris Cook (NC) topped the field in the Q round with a nice 31 14/20 +190.

With 56 players in the Consolation, it was Chuck Dolge (NC) taking home the bacon, besting Master Dutch Gehrich (MD) in the final playoff match. Master Russ Perkins (NC) and Master Rick Bryant (MD) finished 3-4. Bryant was also the top Q player with a great 19 9/10 +108.

The satellite events saw Master Bobby Stuart (GA) and Keith Widener (NC) taking home all the action. Stuart won the Friday Early Bird and Saturday Special, and Widener won the Saturday High Rollers, and Sunday "If you have to" event.

Director Henry Douglass reported Dot Davis, Jim Tanner, and Russ Perkins all scored a 28-hand, in addition to Ward's 29-gem. Douglass reported that a 29-hand has showed in 5 of the 6 events played in Greensboro.

Synopsis Board of Directors Meeting Sands, Reno, NV, Jan 30, 2003

Julian called meeting to order at 10 AM. All present except McGibney and Lulinski (both excused).

Martin Wheeler, Chinook Winds Casino (OR) summarized the Chinook Winds proposed participation in GN 2005. A tabulating room, 14 trophies, 6 cases playing cards, coffee, tea, soft drinks, and \$1,000 prize money to be donated. BOD voted later to accept this proposal.

Hassett distributed BOD rosters. October minutes accepted with one correction (TOC report added).

Julian had conference phone call hooked up to McGibney in NH. Items discussed: concern for potential deficit, since Monroe recovery and GR funds are one-time event, opinion that equity was too large for a non-profit organization, life memberships should be put into a separate reserve to be drawn from yearly, and concern for possible dues increase. Decision to monitor situation for 6 months to 2-year period. McGibney stated a net loss of \$30,654 for fiscal year ending June 30, 2002 (\$18,487 by ACC and \$12,167 by GR). Net equity of \$151,114. Auditor's report not yet complete. McGibney estimates about a \$13,000 loss for year ending June 30, 2003. Treasurer now has all GR funds, except for \$2,000 operating fund for Rein. Report accepted.

Auditor recommended office centralization. Motion defeated. Auditor recommended segregation of duties regarding billing and receiving dues by Membership Secretary. Julian pointed out that he compares reports and officers are now bonded. BOD agreed that original statement from bank be sent to Treasurer.

Auditor recommended 2 signatures on checks. Discussion as to feasibility. Bank will not send out duplicate statements. A check will be made to see if bank will do this for a fee.

Hassett presented proposal to drop GR dues and increase ACC dues by \$3, one set of dues, rather than two. Discussion followed. Motion defeated.

Barrett updated the BOD on ACC website, and Gregson as webmaster. Website received 250,000 "hits" last year. Gregson planning more items next year. Gregson is Publicity Chairman, and reports a revenue sharing with gamecolony.com, which has generated \$75 for the ACC in the last 6 months. BOD will discuss compensation to Gregson.

Hassett's computer system not yet ready, no comparison with existing programs at this time. Colvert discussed *Cribbage World's* finances. Printing costs up marginally and advertising revenues steady at about \$7,000 per year. Postage rates are up dramatically. April CW with ballots will cost about \$1,200 extra, but still most economical way to distribute ballots. Lewis has added Grass Roots column on a monthly basis, which will add to CW expense (about \$200 monthly).

Shimp noted problem not anticipated when judges recertification was discontinued. There is no way to handle incompetent judges. Procedures are being worked on, with help from Senior Judges, possibly as a committee.

Hall of Fame vote conducted. Bill Irons and Harry Palmer were two nominees, insufficient votes for induction.

Barnes discussed internet proposal. Input very positive to date. Trial site may be put in place with Lois Fosdal, Bob Milk, and Mike Schell to work as a committee with Barnes, report to BOD in Sept. on progress. Carried.

Hassett presented new 3-page section for Policy and Procedures Manual. New BOD members will be given manual after election. Rein asked for division of Secretary General and Recording Secretary. Motion carried.

Bernard noted notarization not needed for complaints concerning unethical behavior from ACC members.

Constitution amendment to elect officers to 2-year term defeated. Term to remain one year.

Colvert proposed a \$1,000 one-time cash award to Gregson for his work on website. Compensation will be considered with compensation committee. Carried.

Christiansen discussed ACC Membership Campaign plan. Hejtmank and Lindner will work with Christiansen to improve membership drives. Hassett proposes a questionnaire form be sent to dropped members, complete with an application form.

Julian, on behalf of the BOD, thanked Shumate and DeHuff for an excellent Grand National. Grand National 2005 voted to be played at the Chinook Winds Casino, Lincoln City, OR. Kooistra updated BOD on 2003 Grand National. Event will be played at the Holiday Inn, City Center, Sept. 18-21. Hotel rates are \$79, airport shuttle available within 10 minutes of airport. O'Neil not available to report on GN 2004 in Atlanta, but Barnes reported progress is going well.

Rein discussed TOC and JPW/ACC Open. Will be held at Sands in Reno. Carried unanimously.

Hassett discussed membership report. Rein reported 3,140 GR tournaments have been reported to date. Rein also suggested that BOD members take or sign an oath upholding ACC standards. Rein has request from CA GR in Lassen County for \$300 for fair booth. Hofbauer added that Ras Rasmussen had been granted \$300 for fair booth at Puyallup fair in WA, but only \$200 was granted. Julian to contact McGibney to send \$100 extra. Both items carried.

Ethics committee chairman discussed reports received concerning Todd Reynolds (CA). He distributed copies of complaints, and noted Reynolds did not accept registered letter notifying him he could have a hearing if he desired. Reynolds voted expelled, notice to be published in *Cribbage World*.

Meeting adjourned at 3:35 PM, next meeting scheduled for Sept. 19, 2003 in Sioux Falls, SD. Proceedings recorded by Jeanne Hofbauer.

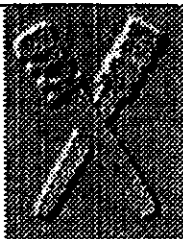

I am a recent member of ACC. At our senior center we have developed a new 3-handed cribbage game which has served us well as we have small numbers. The key to this version is that it maintains all the principles of the classic 2-handed game. I thought you might want to share it with fellow members. The game is as follows.

3-Hand Cribbage. Six cards are dealt to each of the 3 players. The player to the left of the dealer and the dealer each throw 2 cards into the dealer's crib. The other player throws 2 cards into a discard pile. The player to the left of the dealer cuts the cards for the turnup card and only the dealer and left-of-dealer play the normal 31 count game. At the conclusion of the 31 count game, all 3 players count their hands in the order of how the cards were dealt. This would be left of dealer, other player, dealer and dealer's crib. The game is a game of 111 with each player starting in the 10 hole.

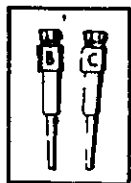
The reason for the game being 111 is so that the game's elapsed time would be more similar to the time of a 2-handed game. When we have our competition we might have 2 tables of 2 and 1 table of 3.

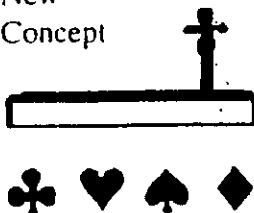
