he Thanksgiving Classic in Canyonville OR is always a crowd favorite, and the November 2006 edition was no exception. Early registration prize drawings and 24-hands paid off handsomely for many participants.

While the competition is always tough at this tournament, this year if you didn't have at least 3,000 lifetime MRPs, you couldn't buy a seat at the final-four table in either the 116-player main or the 70-player consolation. Grand Master **David Gilkeson** (OR) got the better of Life Master **Ross Njaa** (CA) in the main finals, while Grand Master **Jeanne Jelke** (WA) and Life Master **Jones Hom** (CA) had to settle for 3-4.

The consolation again saw a Grand Master beating a Life Master: this time Ira Deutsch (OR) taking down Herschel Mack (CA) in the finals. Master Rick Baird (OR) and Life Master Boyd McDonald (CA) finished in the 3-4 slot.

#### Membership Renewal

# My Deal by David Alken



I love history. My bookshelves are full of history books and biographies, and my file cabinets are stuffed with old newspaper clippings and journal articles about history.

This interest will, of course, inevitably come across in the pages of *Cribbage World*. This month we begin a series of stories about inductees into the ACC's Hall of Fame with the most famous cribbage player of all time: **Sir John Suckling** (see pages 20–21).

But history is not something that occurred only hundreds of years ago. It is also being made right now, by our friends and fellow cribbage players. **DeLynn Col-** **vert** has made his share of cribbage history over the past twenty-five years, and so as a thank-you and farewell to *CW*'s previous editor, we present below an interview conducted with DeLynn via email.

Even more recently, however, **Jason Shumate** made history by becoming the ACC's second youngest Life Master ever (see page 10). This youngster will make plenty of history before he's done.

The point of remembering history, as Santayana so eloquently quipped, is to learn from it. None of us are too old to learn something new, and so I hope you both enjoy and learn something from the history scattered throughout this issue. •



If, as physicist Niels Bohr famously said, "An expert is a man who has made all the mistakes that can be made in a very narrow field," then DeLynn is a true expert. And that's one thing I like about DeLynn: he knows when he is wrong—and he's not afraid to point out his own mistakes.

Unless you slept through the '80s and '90s, you are undoubtedly aware that one name dominates the ACC record book—DeLynn C. Colvert, former *Cribbage World* editor and immediate past president of the American Cribbage Congress. DeLynn is #1 in lifetime MRPS (28,733 and counting); he is the ACC's only Four Star Life Master; he has been on the All American team 19 times; and he has won more tournaments than anyone else: 55 (39 main, 16 consolation).

The list goes on, but I want to highlight another record that DeLynn also holds—most *CW* issues edited:

- 202 DeLynn Colvert
  - 49 Dale Munroe
  - 42 Jim Arblaster
  - 29 Bob Madsen
    - 2 David Aiken

That's right, DeLynn put out nearly twice as many CW issues as his predecessors did combined! (As for me? Only 200 more issues to go!) Beginning with his first issue in March 1990 and running all the way through his last issue in December 2006, DeLynn probably devoted more time to the promotion of cribbage than did anyone else on the planet.

We would like to know how you can get a 29-hand out of the one on page 13 in the January 2007 *Cribbage World*, assuming the three 5s and the Jack on the left are the hand and the 5 of spades is the turn card with the Jack of Hearts in the hand.

I like the new format of the Crib world newsletter, thanks for taking on this job. I have one nit to point out. On page 13, the graphic for the 29-hand seems wrong. The separate 5 (I assume the cut card) is not the same suit as the Jack. The 5 is a spade and the Jack is a heart. Also watch out for one-eyed vs. two-eyed Jacks.

David Shifflett (Pacific Grove CA)

Umm, we'd like to pretend that this was a test to see if our readers were paying attention (and apparently only about six of them were). While we couldn't pin down the precise cause of this unfortunate boo-boo, extensive research by the CW staff reveals that it may be attributed to either (1) the nearconjunction of Jupiter, Mercury, and Mars on December 10 or (2) Schriftleitervergesslichkeit, a little-known ailment that causes middle-aged, balding editors to experience difficulty recognizing common shapes.

Cribbage Fever . . . Catch It . . . And Pass It On! gevity deserves recognition, and so this month CW interviews DeLynn.

Where were you born and raised? Born in Stanley ND, and raised in Columbia SC and West Palm Beach FL.

Where do you live now? Missoula MT.

What was your career? Commercial artist, cartography, and technical illustrator.

When did you start playing cribbage? My aunt taught me at about age ten.

What are your non-cribbage hobbies? Golf, baseball (45-game hitting streak in semipro ball), softball.

When did you join the ACC? 1981.

What was the first cribbage tournament you played in? Idaho Championship in October 1981. I won the 48-player event (\$500) and was hooked.

How many tournaments do you play each year? About thirty.

What is your favorite tournament? The All Star Game, which has excellent, fast players. I played in the first fifteen but missed the cut last year.

How far have you driven to play in a cribbage tournament? Grand National in Massachusetts and NOCT in Raleigh NC three times (2,500 miles one way).

How many miles are on your Honda now? 535,000—and it still doesn't burn oil. The original engine has never been touched.

What cribbage tournaments have your directed? Montana Championship (24), Montana Open (22), Winnemucca (2), Cruise (1), Mexico (1).

In order to make many people feel good about themselves—especially those you beat on a regular basis in weekend tournaments—is it okay if we tell everyone that you have only 166 Grass Roots points lifetime? OK by me, as I seldom play (only about four times a year, in Salem OR).

How were you chosen as CW editor?

Former editor Dale Monroe threatened to resign. In desperation President Ev Bey asked me to take over. I said I would consider it after I retired (in three months). Ev said you are IT in three months! And in three months I was IT! I invested \$7,995 in computers and printers (out of my own pocket), and I was off. No pay, just \$150 a month for typesetting (in hopes of recouping my \$7,995!). This entailed labeling, sacking, and mailing (eighty bags or so) every month.

What is the biggest thrill that editing CW gave you? Being flattered by pats on the back by our membership in getting this job out month after month.

What are some of your accomplishments as a BOD member? Designing the ACC tournament banner; designing the tapering fourth-street track; coauthoring our MRP standards; designing our voting format (with a clip-out postcard, saving thousands of dollars in printing and mailing costs); designing and making the huge four-panel playoff boards for Reno; designing and making about eighty ACC awards each year.

What were your thoughts upon being inducted into the ACC's Hall of Fame in 1989? Thrilled and shocked. The format at that time allowed for ten ballots to be cast, and I needed seventeen votes to be elected. I decided I shouldn't vote for myself, and on the third ballot came up with sixteen votes. ("You dummy! You could've been in the HOF!" I said to myself!) I couldn't resist voting for myself on the fourth ballot, but, alas, my vote dropped off, so I had to wait another year. Such is cribbage in the fast lane!

The list of your cribbage accomplishments is very long; is there anything you haven't accomplished that you wanted to? Yes—to get five stars at 75 years of age! But I probably will not make it, as only ten months remain before I turn 76. I still need 1,267 MRPs, and I am playing badly (old age).

**What cribbage exploit are you proudest of?** Winning the Grand National last year in Oregon.

If you had a cribbage wish, what would it be? That I would quit complaining and could control my Irish temper.

What was the biggest mistake you ever made playing cribbage? Playing Mickey Griffin in the TOC in Reno in the late '80s. In the final game, he was dealing from 28 out, and I was 24 out with first count. Mickey played an ace, to make the count 11. I had A-A-6 in my hand. After studying a long time, I decided to pair his ace. His third ace for 6 got him within 8 points of winning with first count on the next deal—and he did. The 12 points that I scored with the fourth ace still left me 6 holes short. Goodbye \$2,000!

Where did you get the idea to write your book Play Winning Cribbage? I played lunch-hour cribbage, recorded the scores, and worked out the averages (my "26theory"). One day I noticed that Anderson's cribbage book was in its eighth printing. I also noted that his averages were inaccurate, with a 28-point total for two deals, which makes the pone the favorite to win. I felt that my averages were right on and that I could do a better job with a book than this; plus being an illustrator I could do the entire job from start to finish. And I did, printing 10,000 copies (thinking big!). For three years, I regretted printing so many. Those books are heavy, and I moved them more than once. Ugh!

What fuels your passion for cribbage? I am a nut for numbers, I catalog all kinds of numbers constantly. Cribbage is soooo tantalizing with so many averages to consider. There are 964,000,000 combinations of a 52-card deck.

What has cribbage meant in your life? I am still stunned that it has controlled my life, socially and otherwise.

Where do you predict the ACC will be in

twenty years? I feel we have a solid foundation and should do quite well. I am disturbed about our membership losing so many members yearly, but we seem able to gain as many new ones to keep pace. Bridge is not doing as well, percentage wise, as they are losing members. Poker, due to TV, is gaining like mad, however.

Why the baseball cap? Hey, man, I am a baseball player! Love that game. I saved Connie Mack's life, but that is another story for another time. I was captain of the University of Montana baseball team, and we did quite well against Utah, Utah State, Idaho, Idaho State, and Brigham Young. Proud to say that I batted third in the line-up for almost every team I played for. ◆

### Hal Mueller Sparkles at Diamond Tournament

The second annual Michigan Tournament of Diamonds, held in Muskegon MI on Veteran's Day weekend, saw 60 players vying for one of the handmade diamond-shaped trophies.

In the end, Master Hal Mueller (ON), playing in his last tournament of the year, managed to keep alive his streak of one tournament win each year since 2003 when he beat Ken Rasmussen (MI) in the finals. Life Master one star Bob McCabe (WI) and newcomer Sharon Weaver (MI), playing in only her second tournament ever, finished 3-4. John Schafer (MI) was high qualifier with a 37/18+202 scorecard.

The 34-player consolation saw a surprising first: this was the first time that perennial contender Life Master (Two Stars) Warren Sondericker (WI) was both the high qualifier (18/8+195) and the winner of the *same* tournament. Life Master (One Star) Wayne Steinmetz (WI) finished in second place, with Life Master

In the first running of the Western Washington Limited (Poulsbo WA) in December 2006, **Duane Person** (WA) showed no limits in defeating the Castle Rock Comet, Grand Master **Chris McComas** (WA), in the finals of the 35-player main tournament, with **Richard Anderson** (WA) and **Louise Wilson** (WA) in 3-4. Master **Erik Locke** (OR) was high qualifier.

Directors Dennis Misenar and Larry West report that Jay Fulwider (WA) scored a 14/7 grand slam in the 28-player consolation. Life Master (Three Stars) Jesse Jarrell (CA) got the better of Life Master John Furler (OR) in the finals, with Jay Fulwider (WA) and Rick Westerman (WA) finishing 3-4.

#### Jason Shumate Stirs Pacific Crowd

The crowd that gathered in Pacific City OR in December 2006 for the Pacific City Cribbage Special had no idea that they were going to see history in the making, but that's exactly what happened—twice.

First, two players scored 33 GPs in the 16-game main tournament: high qualifier Hal Lamon (WA) and Life Master (One Star) Todd Malmgren (OR). While no record holders are listed for a 16-game

tournament on the ACC's website, 33 GPs—the equivalent of 45+ GPs in a 22-game tournament—probably represents a new record.

And then previously Grand Master Jason Shumate (NV) won the tournament and became (to *CW's* knowledge) the second youngest Life Master ever (see story on page 10). Hal Lamon took second place, and Master Phyllis Roderick (OR) and Mike Ritthaler (OR) finished 3-4.

Half a hundred players contested the consolation title, and Master Dan Marsh (OR) was high qualifier with a 17/8/+113 scorecard. Meanwhile, two Life Masters—Herschel Mack (CA) and Jeanne Hofbauer (WA)—slugged it for champion, with Herschel coming out on top this time. And two Oregon Masters—Dean Bauman and Lowaine Pruett—finished 3-4.

## **Jason Shumate**

Jason Shumate loves cribbage, and he'll do anything to get to a cribbage tournament—drive, fly, hitchhike, skateboard, even ride in a police car (you'll have to ask him about this one!).

Jason travels to thirty tournaments a year from his home in Reno NV, where he is an inspector for state construction projects.

His first tournament win came in 1995, and since then he has tallied eleven more championships. He has made the All American team three times and is currently in fifth place (611 MRPs) nationwide in the race for All American honors.

Jason grew up playing cribbage with his dad, Jack Shumate III, and got hooked on the game when he attended the 1995 World Cribbage Championship in Quincy CA. This whiz kid quickly attained his Master ranking in 1998, then was away

from tournament play for several years while he lived in Texas, but speedily returned to form by earning his Grand Master in 2004.

And now—at age 29y 6m 20d—he has become the ACC's second youngest Life Master. This feat has been accomplished at so young an age by only one other player: **Brian Heroux** (Woonsocket RI),

Jason didn't take the easy route, however. When he and two friends were late for the one-day Pacific City Championship (Pacific City OR) in December 2006, they figured that they would just register for the consolation and come back that after-

noon. When directors Rollie Heath and Paul Hatcher graciously allowed them to play the main if they would make up the missed games, Jason repaid their leniency by going on to win the tournament—and his Life Master ranking to boot!

So, if you see Jason on the Tournament Trail, look out—you may be the next player he beats on his way to the championship!

# Norm Nikodym Coasts to Pacific Win

Obie won the first two games, but Norm came storming back to win the next three games. Master Roy Cook (CA) and Lee Foglesong (CA) finished 3-4.

The 34-player consolation saw Kerry ("I have a dozen") O'Connell (CA) whipping Life Master Don Brown (CA) in the finals, with Julien Pomerleau (CA) and Judy Gilbertson (CA) wrapping up the 3-4 slots. Ken Slama (CA) was high qualifier.

Director/Master **Roy Cook** reports one sanctioned 28—by **Obie Weeks** (CA).

# Joan Layte Captures Castro Valley

The Castro Valley Open in Castro Valley CA in December 2006 saw 82 players in action. ## **BOD Election**

This year features the biannual election for the ACC's Board of Directors. BOD members will be elected for a two-year term beginning September 1, 2007, and ending August 31, 2009. The BOD meets twice each year—on the day before both the rotating Grand National tournament and the TOC in Reno NV—to handle the administrative and financial business of the organization.

# Sir John Suckling

Kids can be so cruel. Can you imagine the ribbing that someone with the name *Suckling* would have taken from his classmates? "Johnny sucks!" "Yo mama sucks!" "There once was a man from Nan-sucket. . . ." Well, despite what may have been rough sledding throughout those difficult prepubescent years, little Johnny managed to make something of himself.

His greatest claim to fame was certainly his posthumous induction into the ACC's Hall of Fame at its inception in 1982. He was also a poet and an English knight. Oh, and he invented a little card game that he called "cribbidge."

Born in 1609 in the southeastern British county of Middlesex (another likely source of juvenile taunts), near London, John Suckling was an "English Cavalier poet"—a group of swashbuckling literary wannabes who supported King Charles I during the English Civil War.

He enrolled in Cambridge University at the age of fourteen and inherited a small fortune four years later. And then, in the tradition of his day, after college he backpacked around Continental Europe for a couple of years. When he returned to England in 1630, he was knighted—probably because King Charlie needed more warm bodies on the battlefield.

But before the skirmishes started, Sir John was elected member of the so-called Long Parliament and settled into life at the royal court, where he became known as the best cardplayer and bowler. If he was so good, however, one wonders why his sisters—weeping from fear that he would lose their dowries—once came to the Piccadilly bowling green to dissuade him from play. Surely the *best* player couldn't lose, could he?

Whether because of his sisters' concerns or because of a court scandal, at the tender age of twenty-six Suckling "retired" to his country estates to pursue a literary career. His reputation today rests on minor pieces with lines like "I prithee, send me back my heart" and "Why so pale and wan, fond lover?" But in his day, his poems and plays attracted favorable attention because of their felicity of expression, even though one critic justifiably complained that Suckling's *Aglaura* seemed "full of flowers, but rather stuck in than growing there."

Okay, so much for poetry—what about cribbage? Seventeenth-century gossipmonger John Aubrey reports that Suckling "played at cards rarely well, and did use to practice by himself abed, and there studied how the best way managing the cards could be.... Sir John invented the game of Cribbidge. He sent his cards to all gaming places in the country, which were marked with private marks of his; he got £20,000 by this way."

That juicy nugget sums up all we know about Suckling's invention of cribbage—it was simply one more scheme to make money! In the end, though, money was his undoing. Apparently not content with a tranquil lifestyle, in May 1641 Suckling was implicated in an attempt to spring a prisoner from the Tower of London, and he fled across the English Channel into

exile. Rumor has it that he ended his life by poison in Paris in 1642 because of looming poverty.

Flemish painter Anthony Van Dyck's famous portrait, now hanging in the Frick Collection in New York, shows a very debonair Sucklingalthough somewhat "pale and wan"decked out in full regalia and posing beside Shakespeare's First Folio. If Sir John had had any wits about him, he would have absconded with the book to pay his gambling debts, for

a copy of this rare tome recently sold at auction for over \$5.5 million!


Nobody's perfect, and Sir John—gambler, cardsharp, party-animal, womanizer—proves this point in spades. But the next time you're in a cribbagey sort of mood, raise a glass to our patron saint—Sir John Suckling. Where would we be without this shyster?

# What's in a Name?

**Dean Julian** (Simi Valley CA) plays only a few tournaments a year, but last fall he pulled off a rare feat: he won two tournaments on back-to-back days—the main event at the P&G Open on October 21 in Norwalk CA and the consolation at the Fall US Open on October 22 in West Covina CA.

So, where did this guy learn to play cribbage? From none other than his grandfather: Life Master (Two Stars) **Robert Julian** (Franklin WI). And that's a pretty good pedigree, if you ask me, since Bob is currently ranked #4 on the all-time MRP list—with 19,297 MRPs—and is likely to become the ACC's next Three Star Life Master within the next year.

Congrats to both Dean and Bob!



The highest hand that a Deuce can make is 20 points: 2-2-2-9. All other cards are capable of making at least 24 points; here are some examples of each:

A-7-7-7

3-3-3-9

4-5-5-6-6

6-7-7-8-8

5-5-5 plus any face card

Does this knowledge help you in a game situation? Sure does. For example, if you are the dealer and your opponent is 21 or more points out with first count and a Deuce is cut, you now know that she can't have more than 20 points, and so you should peg cautiously so as not to give her the extra pegs she needs for the win.

Pages 9–10 were filled with stories about recent tournament wins by **Jeff Shimp** (Kalamazoo Open), **Ed Nartowicz** (Western Massachusetts Open), **Harold Lane** (Rocky Mountain Championship), and **Jim Morelan** (Minnesota Open).

Finally, the membership secretary reports that the ACC now had members in every state of the Union except Louisiana and Mississippi.

#### Extreme Cribbage: 10,000 Games and Counting

In December 1982, **Stephen Hansen** and **Steve Shambeau**, law partners in Waupaca WI, started a cribbage match. And twenty-four years later—on October 13, 2006—they played their ten-thousandth game!

Executive Committee (DeLynn Colvert): covered in previous agenda item.

Tournaments Rules Committee (George Bickford): He will soon be sending out new tournament reporting forms to be used at the beginning of the year.

Ethics Committee (Dwight Christiansen): will be covered in agenda item #15.

PR/Publicity (DeLynn Colvert has resigned, Larry Samet will replace him): Larry Samet said that Tom Lewis and Dan Zeisler had been working to get educational materials for juniors amended to educational materials for colleges and other venues, and that eventually they hoped to make the material available on the ACC web site. Larry Samet also talked about a proposed concept for a "cribage week spectacular" to include tournaments, lectures, classes, exhibits, etc., to be held at the Sands in February after the TOC & ACC/JPW Open. He has talked to Barbara

Woodward regarding holding it at the Sands, and would like to know if the BOD thinks this is something feasible. After much discussion, Joan Rein made a motion that Larry Samet bring a detailed proposal to the February 2007 BOD meeting, 2nd by Bob Milk. Larry Samet requested that he has help preparing the proposal, and wants volunteers for a planning committee. Motion approved.

Rules Committee has nothing at this time.

Constitution and Bylaws Committee: Martha Fingleton said that this committee has not been productive because of health issues, but anticipates activity in the near future. Larry Hassett has brought some proposals that will be considered later in the agenda regarding ethics & conduct and order of authority of documents.

Grass Roots: Joan Rein said that as of the end of the last Grass Roots season, ten new clubs have been signed up, and or 4 or 5 old clubs have been reactivated, one of which is in Mexico. She said that there are now 175 to 180 active clubs at this time. She also said that she had replaced her printer with a refurbished one at her own expense. She said that the 1st annual GRTOC will be held this weekend, directed by Dave Aiken and Andrea Witkin. This tournament will be held at 1:00 p.m. today, and since 4 BOD members had qualified to play in it, perhaps it could be rescheduled in the future not to conflict with the BOD meeting.

Judges Program: Jeff Shimp stated that he had received no input on the problem of disbarring "bad" judges as discussed previously. He again solicited ideas from the BOD to develop procedures to eliminate them from the judges program. Discussion followed with suggestions of "retraining" judges, tournament director's "appointing" the judges at their tournaments, putting a notice in CW asking players to write to Jeff Shimp if they feel they have had a "bad judging" experience, and having a form to fill out for judges calls at the registration table.

Youth Cribbage: Dan Zeisler said he averages 6 requests per month for his teaching manual, 90% of which are from 4th–12th grade teachers. He has given permission for the manual to be available on the web-site, but this will eliminate his ability to track who and how many are using them. His 14th Youth tournament will be held 2 weeks after the ACC/JPW Open.

Agenda item #7. Election of Officers: Joe Bernard announced that DeLynn Colvert had decided not to run as nominated for the office of President, Al Lindner and Roy Hofbauer were nominated from the floor. Al Lindner was elected. Martha Fingleton was the only nominee for Executive VP, and was elected. Bob Julian was the only nominee for VP/Operations. Since there were now two elected officers from the Central Region, according ACC Constitution and Bylaws he could not hold the office (only 2 officers from a region can hold office on the Executive Committee). Bob Julian tendered his resignation. Roy Hofbauer was nominated and declined. Cathy Perkins was nominated and elected. Larry Hassett was nominated for VP/Policy and was elected. George Bickford was nominated for Memberat-Large and was elected. Martha said there would be an Executive Committee meeting immediately following the BOD meeting. The BOD thanked DeLynn Colvert and Bob Julian for their years of service as officers.

Agenda item #8, Treasurer's Report: Bob McCabe noted that the financial report documented the trend of a declining cash balance; we are, however, increasing revenue this year about \$9000-\$10,000 because of the increase in tournament sanctioning fees. Our cash is down to about \$100,000, but is always slightly down at this time of the year because of award expenditures. It will increase shortly as the Grass Roots dues will be coming in. Phyllis Schmidt moved to accept the 2006 Treasurer's report, 2nd by Cathy Perkins. Motion approved. Jeff Shimp moved to adopt the 2007 Budget, 2nd by Valerie Sumner. Motion approved.

Agenda item #9, Dues Increase Proposal: Bob Julian said that Bob McCabe and Larry Hassett were on the Committee and that Larry Hassett had sent out some information. Bob Julian asserted that Life Members are being subsidized by the rest of the membership. He said the committee suggested raising both the age (either to 62 or 65) and the cost (to \$100 or \$150) for a Life Membership. Current age is 60 and cost is \$80. After discussion, Bob Milk made a motion that Life Membership dues be raised to age 65 and \$100/\$150 for joint membership to be effective on July 1, 2007. Herschel Mack proposed to amend the motion to age 62, 2nd by George Bickford. Motion approved with 1 nay vote. Bob Julian then discussed raising the regular membership dues. He said that Larry Hassett and he recommended an increase. Bob McCabe did not feel it was necessary at this time. Discussion about future anticipated and unanticipated expenditures followed. Bob Milk made a motion to raise general dues to \$12/\$15 joint, effective July 1, 2007. Motion defeated after a count of

**Agenda item #10**, Constitution and Bylaws Changes: Larry Hassett presented changes to Article X and Article XI. After discussion, Cathy Perkins made a motion to table proposed changes to Article X until further research is done by the Constitution and Bylaws Committee, 2nd by Sharon Heitmanek. Motion approved.

Martha Fingleton announced the Lunch break, (12:45 p.m. return at 1:15 p.m.) but asked for the 2 BOD members that are planning to play in the GR TOC to stay around for the rest of agenda item #10, Article XI. Larry Hassett then dropped the Article XI proposal.

Agenda item #11, Update on ACC 2006 GN XXV: Pat Barrett welcomed us to Wisconsin Rapids and reported that there were approximately 408 entries at this time. The local GR tournament on Thursday night had 78 players attending. Pat thanked DeLynn Colvert for his help with the programs, which everyone will receive with their packets tomorrow. The bid from the local printer for 500 copies of the program was \$1500; DeLynn got it done for less than \$600, which was paid for by sponsorships. There will also be commemorative pins in the packet, paid for by the ACC GN stipend (about \$600), and name tags provided for free by the visitor's bureau. Pat mentioned that there will be media coverage by the local TV channel and newspaper. Pat also thanked several people for helping with the GN raffles.

**Agenda item #12**, Update on ACC 2007 GN XXVI: Dave Campbell said he hoped to get a flyer soon, but was held back because he could not get a price for lobster for 1 year ahead of time (he wants to have lobster at the banquet). He is working to get sponsorships so that the tournament can pay back 100%, and has been talking with L.L. Bean. He is also working on a raffle. Dates for the tournament are September 27–30, 2007. Dave said he would have the in-

formation on hotel reservations at the Reno meeting.

Agenda item #13, Proposal for GN XXVII: Jeanne Hofbauer presented the proposal for Tim and Ken Julkowski, who would be the tournament directors. She distributed packets from the hotel and a letter from Tim. The site is the Holiday Inn, which is about 1 mile from the Portland, OR airport. She asked that the BOD award the bid to the Julkowskis so they would have 2 years to prepare for the event. Martha said she has actively been soliciting bids for 2008 and no one else has come through with a bid, that two years seems to be the amount of time needed in the planning of a GN tournament, and that our policy is that the BOD awards the bid 2 years before it is held. Sharon Hejtmanek made a motion to accept the Julkowskis' bid and award GN XXVII to them, 2nd by Bob Milk. Motion approved.

Jeff Shimp, who had talked about hosting the 2009 GN Tournament in Michigan, said that he and Dave Aiken were in the process of deciding between two different properties, both of which offered complimentary playing space. They are located in Grand Rapids, MI. One is near the airport, the other in the downtown area, approximately 7 miles from the airport.

Agenda item #14, Hall of Fame Voting: Pat Barrett talked about the new HOF voting procedure, and asked the BOD members who had not given him the names of their 3 choices (for the voting panel) to please do so soon. Larry Samet and Martha Fingleton explained the procedure for the voting panel: double envelopes; ballot will be put in inner sealed envelope then mailed in second envelope; Pat receives the envelope, checks that the panel member has indeed voted, then discards outer envelope and brings unmarked, sealed envelopes to Reno meeting; votes will be counted during a break at the meeting. Pat then discussed relevant dates: nomination forms will be in November CW; nominations must be postmarked by Dec. 10th; ballots will be sent out to 75 members of voting panel within one week; return ballots must be received by Jan. 24th. When BOD members receive their HOF packet, they should call their 3 panel members to make sure those people have received their ballots; if not, BOD member should contact

**Agenda item #15**, Expulsion hearing, Martha Fingleton closed the meeting to non-BOD members. Dwight Christiansen, Ethic's Committee Chairman, said that a lot of the complaints to the Ethics Committee seemed to be "personality issues," rather than those dealing with conduct and cheating. He talked about some of the cases currently being dealt with: some will be receiving letters from the committee; one suspension has been issued (Pete Deroux); then went on to the reasons the committee is recommending expulsions for 2 players (Ron & Darren Saik). Martha explained that the Executive Committee had concurred with the Ethics Committee's recommendation, and that is why it is now being brought to the BOD. Sharon Heitmanek made a motion to expel Ron Saik and Darren Saik from membership in the ACC, 2nd by Bob Milk. Motion approved. The meeting then was reopened to observers.

#### Agenda item #16, policy changes:

Valerie Sumner, presenting a proposal from Jim Crawford, asked Bob McCabe to explain: currently deceased members are still carried on the ACC database, they are included on lists of lifetime master points if they had attained the rank of Master or above. She asked that their names be kept on top 100 lifetime wins list. His program is not currently set up to do this, but Denny Moore has agreed make

the changes, which will probably take about 3 hours. Bob suggested that Denny be compensated for this work, as he has never been paid for the many hours of work he has volunteered. Bob suggested \$100. Bob also asked if there should be a cut-off and the general consensus was for 5 or more sanctioned wins. Jeff Shimp made a motion to ask Denny Moore to make the necessary program changes for this and to compensate him with \$100, 2nd by Bill Medeiros. Motion approved.

Dave Campbell had questions about the rules being followed for midweek tournaments. He asked what a quarter was, as applied to the conditions governing midweek tournaments (did they start with the calendar year in January, or with the master point year beginning in August?). There was much discussion regarding changing the rules for and redefining midweeks. Martha Fingleton asked George Bickford to form an ad-hoc committee to bring information regarding midweeks to the Reno meeting. Larry Samet made a motion that quarters of the cribbage year start with Aug 1st, Nov 1st, Feb 1st and May 1st, 2nd by Dave Campbell. Motion approved. Larry Hassett made a motion that all midweeks that have been sanctioned will have their commitments honored until new rules regarding midweeks are voted upon, 2nd by Dave Campbell. Motion approved.

Dave Campbell brought a proposal to change how the All American Team is assembled. He feels that because the West has more tournaments than the other 2 regions, Western region players have a distinct advantage for earning more master points, thereby affecting the makeup of the All American Team, which in turn leads to disinterest by members in other regions. Much discussion and many suggestions on whether to change the current system and the problems and difficulties associated with implementing those suggestions ensued without a consensus about changes being reached at this time.

Larry Hassett regarding Ethics & Conduct: (discussed previously in meeting)

Larry Hassett presented a page (12-1 from the ACC Manual) with changes for the Hall of Fame from the ACC Manual. Larry said he would have to add date changes and make additions for the new 100 member panel. See attachment #1 to minutes for changes. Larry Samet noted that section II-C will need to be changed for the 100 member panel, and section I-E needs to be changed as reflected in page 4 of the minutes of Feb. 8, 2006. Larry Hassett made a motion to accept the proposed changes, which will go into effect after the next HOF vote, and will be reviewed by Martha Fingleton, with the changes as noted by Larry Samet, 2nd by Pat Barrett. Motion approved.

Larry Hassett proposed changes to Regionalization as listed in the ACC manual. The changes are: moving Ohio and Ontario from the Central Region to the Eastern Region and Colorado from the Central Region to the Western Region. Changes to the Grass Roots Regions would move Ohio and Ontario from Region VI to Region IX. Bob McCabe said that for master points, Ontario is listed in the East and Colorado is listed in the West, but wasn't sure about Ohio. Joan Rein agreed that both Ohio and Ontario should be in Grass Roots region IX. Bob Milk made a motion to adopt the changes to regionalization as proposed by Larry Hassett, 2nd by Dan Zeisler. Motion approved.

Larry Hassett regarding membership/dues: (discussed previously in meeting)

Martha Fingleton & Cathy Perkins presented a page listing

the problems of, and possible solutions to, random seating requirements for tournaments. After much discussion and exchange of ideas, there was no consensus.

Agenda item #17, Bob Milk reporting on ACC internet cribbage: Bob said that the 2005-2006 season had 188 internet tournaments, with participation of over 15,000 entrants. At the end of the season 792 ACC members had registered for the ACC Internet Program. 182 members earned Internet Rating Points resulting in 19 individuals having TOC eligibility. The ACC tournaments were held on MS Gaming Zone, which dropped many games, including cribbage effective June 19, 2006. Just prior to that notification, a proposal from Game Colony was received to be the primary location for ACC internet Cribbage. Bob inquired of the following sites regarding hosting ACC internet tournaments: Yahoo (response was that they were not taking on new groups at this time, to check back in a year), Cases Online (no response), Pogo (no response), Playsite (no response). He sent 2nd inquires to the no responses, and again received nothing back. He also checked out a newer sit, GameDesire, but found their software lacking. He felt the only solution to continue the internet program was on Game Colony, which sent a business proposal, which he sent to the Executive Committee for review. With a couple of changes agreed upon the ACC and Game Colony both accepted the business proposal. ACC internet cribbage has been up and running on Game Colony since early August. Game Colony developed an ACC branded portal and an ACC tournament room. 5890 individuals have joined Game Colony through the ACC portal, and over 5400 are not ACC members. This has given us tremendous free exposure, and the ACC gets paid a couple of cents for anyone that joins Game Colony through the ACC website and plays in any of Game Colony's tournaments for money (currently we have earned \$921.38). Bob continues to research and monitor different internet sites. Cathy Perkins requested that Bob have Game Colony remove the "win cash prizes" which is superimposed on a playing hand on the picture he presented to us(from the game site) on page 3 of his report, because it is misleading. Bob said he has received some vicious emails accusing him of getting kickbacks or being an investor in Game Colony, and has turned the emails over to the Ethics Committee.

Bob Milk presented a proposal to open a PayPal Account, which is an online payment system. This is the recommended way for Game Colony to transfer the earnings of the ACC to the ACC. In addition, the ACC could use PayPal as a way for the members to make their membership payments electronically. Methods of receiving the payments were discussed such as a small checking account, Bob McCabe asked Bob Milk to see if it could go to the ACC account by direct wire, which Bob Milk will check on.

Bob Milk proposed that we develop a certificate similar to the 28-29 hand certificates, to be awarded each year to the top 10 ACC internet Cribbage Players, and also one for when different rating point levels (to be developed) are attained. Larry Hassett made a motion that Bob Milk develop a certificate and an awards program for internet players, to be funded with the earnings from Game Colony, and bring it to the Reno meeting for BOD approval, 2nd by Cathy Perkins. Motion approved.

Bob Milk proposed that we establish a committee to study feasibility of "fee-based" internet tournaments. Some of the things that would have to be taken into consideration are: legal liability, security, paybacks, state laws, auditing and accountability. Martha Fingleton suggested he use the
