This issue of *Cribbage World* marks a major transition for both the American Cribbage Congress and *Cribbage World*. At the September 2006 Board of Directors meeting in Wisconsin Rapids, **DeLynn Colvert** announced his resignation as president of the ACC. DeLynn also made known his intention to turn over the reins of *CW*, after editing our monthly publication for seventeen years.

The BOD elected **Al Lindner** (Greenwood WI) as the new ACC president and appointed me as *CW* editor. I have no doubt that Al will fill the presidential role in an admirable way, and I can only hope that I fill DeLynn's editorial shoes in a similar fashion.

In his dual roles as president and editor, no one has done more for the ACC than DeLynn (more on this next month). We who play in weekly clubs and in weekend tournaments owe him a debt of gratitude that is unlikely to be repaid anytime in the near future. Without his confident leadership, editorial skills, and contagious enthusiasm, the ACC would not look like it does today. If anyone deserves a respite after years of hard work, it is DeLynn, and I wish him every good luck in his future endeavors, whatever they may be.

For starters, you'll notice that *CW* has been redesigned for the electronic age (thanks to my friend **Brian Brunsting** for his help on the new look). Every element of each issue—stories, tournament reports, statistics, ads—will now be typeset by computer and sent in electronic format to the printer, which means that information for inclusion in *CW* must come to me in electronic format or risk being retyped—with the attendant potential for error. Underdogs Were Favorites at GN25

by Patrick Barrett, Director, GN25 Cribbage tournaments are great. First, players go through the qualifying rounds, and then the top 25% of entrants play off until there is a champion. Players are seeded according to their scorecards. Most players assume that the higher the seed the better chance to advance in the playoff, but sometimes that's not quite true.

At the Grand National Tournament in Wisconsin Rapids, there were 102 matches in the main tournament playoffs. Of these, the lower-seeded player won 52 matches and the higher seed won 50! It shows that the saying is true: "Just qualify, you never know what will happen after that."

Herschel Mack Chairs Rules Committee



Deadline Change—Effective January 1, this column is due to the *CW* editor on the 10th of each month, so I will need your stories no later than the 9th of each month. *Tom*

Rule of the Month—This month features a question and answer about rules. Floyd Vincent (Club 323, Wentzville MO) writes: It is time to discuss and review rule 7e, which states that a single card released by the fingers is considered played, whether or not the count is announced, and may be retrieved only if it would cause the count to exceed 31. If the count exceeds 31 and the player claims the game, that is an overpeg and false claim of game (see rule 8.4b). If it is not a false claim of game, then rule 8.4c will apply, and it will be treated as the wrong number of points pegged.

Martha Fingleton (ACC Executive Vice President) responds: That rule was changed by the BOD's Rules Committee in 2004 because of reports of unscrupulous players who would play an unplayable card, call the count 31, and peg out without the false claim of game rule applying in that instance (because of the wording of the old rule). By reworking the rule in its present fashion, an honest mistake (which is overwhelmingly the case, I believe) in counting can be corrected with a small penalty: the offender has exposed one of his or her cards to the opponent. Since pegging is an action that is unequivocal, there is still a more severe or, in the case of false claim of game, quite severe penalty for mistakes. Perhaps if you review the rule, you might want to remind players that playing a card and pegging a score are two separate game "mechanics." The rule exists as written to protect everybody from *human* "mechanics"!

Start a Grass Roots Club in Your Area!— There are currently 175 active Grass Roots clubs in the USA, Canada, and Mexico. No matter where in the world you live, you are encouraged to start a new club, even if there is already an existing club in your city. All you need are six players! A *String of Pearls* is 1 in 22,924 deals (= 1 in 2,465 games), with 4 recorded. Only one *24-hand without an* 8 or 5 has been scored in the few months since tracking began, or 1 in 9,961 deals (= 1 in 1,071 games). *submitted by "Ras" Rasmussen*

And while not many of us will complain about having 12 points, this isn't a particularly good pegging hand, since the pone can peg a maximum of 3 points (a pair and a Go). With a little bit of luck, the dealer could peg 9 points (a pair, a triple, and a Go) if holding four Aces.



The front cover of the January 1982 issue of Cribbage World proclaimed—appropriately enough in big, bold type—"Think Big!" Under this headline, ACC president Joseph Petrus Wergin briefly discussed a number of topics, including the possibility of



and Tournament" in either Reno or Las Vegas. This idea grew into today's JPW/ACC Open, held in Reno each February at the Sands Regency Casino Hotel. Later renamed in honor of Wergin himself, this tournament is now the largest cribbage tournament in the world, featuring over one thousand of the ACC's finest players.

Elsewhere in his column, Wergin mentioned that a "closed tournament for the top 100 rated players of the 1980-81 season" had been suggested-and this idea morphed into today's Tournament of Champions, held in conjunction with the JPW/ACC Open.

Among the sixteen sanctioned tournaments listed in the "Tournament Calendar" for 1982 were some that are still active: Minnesota Open, Oregon Championship, Western New York Open, Madison Masters, and the National Open.

Elsewhere in this issue we learn that **Bob Madsen**—still an active ACC member, a longtime member of the BOD, and a former editor of CW-was the first person to pass what was then called the "Officials Examination."

Finally, we read that ACC membership was up to 1,550-a far cry from today's 7,100!


