
#### 2010 GRNT

#### **Grass Roots National Tournament**

The 2010 Grass Roots National Tournament is complete! Directed by **Bob Joslin** (Lakeville MN), this year's GRNT saw 2,052 official and junior players and 124 unofficial players playing 39,168 games! (An unofficial player is someone who played in more than one GRNT.) Both numbers are down slightly from 2009.

Consisting of eighteen games, the GRNT is held at Grass Roots clubs all around the United States and Canada, between January 1 and April 30 each year. Its unique format allows ACC members to compete locally against the best Grass Roots players across the continent—while incurring little or no travel expense. This year, members from 163 clubs participated in 113 tournaments. The largest tournament was hosted by Club 148 in Auburn WA and directed by Hal Lamon, with 74 players present.

The top GRNT player this year was **Chuck Koberg** (Folsom CA), who plays Grass Roots cribbage at **River City Peggers Club 162** (Sacramento CA). Chuck learned to play cribbage during his high school years, but didn't play much until midlife. Over the last 35 years, he's enjoyed the competition and taught his (now grown) children to play. Cribbage is now a family tradition game on vacations. He joined River City Peggers about eight years ago and has since spent most Tuesday evenings enjoying the people and competition. Chuck has been



## Tournament Tidbits

Potawatomi Peggers Powwow In twenty previous iterations of this tournament, there had never been a 29-hand. But the 21st PPP saw two people hold the biggest hand in cribbage—unfortunately, neither of them during a sanctioned event. Lorraine Thomas (Crystal Lake IL) got her 29-hand on Friday night, and Wendy Schmidt (Mount Pleasant MI) got hers on Saturday night.

Redwood Coast Tim Hutsell (Crescent City CA) had an outstanding tournament: he took first place in both the Early Bird and Saturday Night Special. With Jerald Cutsforth (Crescent City CA), he placed second in Doubles. Tim was third in the main and finished off the weekend with a second place finish in All Events. That is phenomenal cribbage in any circle.

Lake Superior Challenge A firsttime tourney held in Ishpeming-a little, out-of-the-way berg in Upper Michigan-attracted more players than any of the other five tournaments held on the same weekend in Washington, Florida, California, and Massachusetts. And here's a new way to win a tournament: Master Lee Tesch (Green Bay WI) and roommate Life Master Al Karr (Green Bay WI) locked themselves out of their hotel room on Friday night. After repeated efforts to rouse the desk clerk at the mom-and-pop hotel, and after contacting the police to do the same, and after deciding against renting another room at the \$100-a-night nearby hocontinued on page 10

tel, they finally spent the night in their car. Didn't matter—Lee qualified #10 and breezed through the field to claim his third championship. Consolation winner **Norman Vierela** (Republic MI) has some very interesting neighbors. Every night bears come out of the woods to feast on the food that Norm puts out for them.



Nugget Classic Un-Master Richard Hinrichs (Redding CA) plans to submit a rule change to the Rules Committee: reduce the number of points needed to win a cribbage game from 121 to a nice even 120 points. And he wants this rule change to be retroactive to June 6. On that day, Life Master Cres Fernandez (Santa Rosa CA) beat Richard three games straight in the finals of the main—and in all three games Richard ended up in the dead hole! Richard does not, however, want the change to be retroactive to June 5. On Saturday, he froze **Scott Milo** (Marysville CA) in the dead hole (i.e., Scott had no points and no pegging) and used this victory to help qualify for the playoffs!

St. Croix Classic The 36th Turtle Lake tourney once again proved popular, as it drew 270 players from around the nation—and no wonder: the casino added \$10,825 in cash bonuses: \$25 for each 24hand (335 of them), \$250 for each of nine 28-hands, and \$100 for two grand slams. Plus Saturday lunch was on the house. Life Master **Tony Danihel** (Brookfield WI) didn't take long to take advantage of the casino's open wallet. He scored a 28hand in his *crib* in the opening game on Friday night.

Schaefer Shuffle It was good to see a new McCabe on the tournament trail. Bernie McCabe (Milwaukee WI), nephew of recently deceased Life Master (\*) Bob McCabe, qualified with a 31-point scorecard and took third place in the main.

lucky enough to have a 29-hand this year, a hole-in-one while golfing last year, and a substantial lottery win a few years ago.

This year's prize fund of \$16,350 was distributed to the top fifth of the field (407 players). An additional \$1,000 was paid out for three 29-hands, twenty 28-hands, and eight grand slams—for a total payback of \$17,350.

The GRNT also serves as a fundraiser for the Grass Roots organization. Four dollars per entrant (this year \$8,704) is retained to pay for awards and other operating expenses.

GRNT Director **Bob Joslin** and Grass Roots National Statistician **Kristy Haught** (Rocky Mount NC) spent many hours checking and double-checking the results.


The last day to play GRNT was April 30. About a month later, Mike and Kristy had finalized the numbers, and the results and the checks were in the mail.

In addition, club directors and statisticians all around the continent volunteered to run the tournaments, collect the entry fees, compile and proofread the results, and mail in the pertinent data.

If your club didn't participate in the GRNT this year, you and your fellow club members missed a great opportunity. Make plans now to play the 2010 GRNT.

letter in my hand. She was working on a master's degree in comparative literature, and the letter offered her a position as teaching assistant in the philosophy department at the University of Wisconsin– Milwaukee. Giddy as a schoolgirl, Martha could hardly contain her glee!

My first introduction to Warren Sondericker came at the 2002 Potawatomi tournament. It wasn't so much that I saw him, as *heard* him. During a quiet moment, I heard someone across the room yell, "Anybody wanna buy a duck?"

In the following years, I got to know Warren—as a loudmouthed, brash, overbearing, quick-tempered, crass, cocky, rude, crude know-it-all. But more importantly I also learned that he personified the saying "never judge a book by its cover."

It was only on the surface that Warren appeared to be all of those things; underneath he was a teddy bear. Not the cute, fuzzy, cuddly kind that you want to snuggle up with on a cold night—but the worn-out, tattered, worldly wise bear that's been around the block multiple times.

Warren had a rapacious appetite for everything (use your imagination), and this was displayed in his amazing interest in a wide variety of subjects: literature, language, the financial world (the last book I saw him reading was *The First Tycoon*, a biography of Cornelius Vanderbilt), space exploration (he was a longtime supporter of the SETI Institute), the natural world, science, science fiction—and the list goes on and on. He read widely on all these topics and could locate on his bookshelves with near-perfect recall various passages that he had read years earlier.

Warren suffered fools neither gladly nor grudgingly. If he disapproved of something

you did, he told you—immediately, forcefully, and with an abundance of R-rated language.

The difference between Martha and Warren in this regard was this: Warren let you know how stupid you were in no uncertain terms, whereas Martha—a diedin-the-wool unreconstructed liberal—was more diplomatic and willing to allow for some underlying cause.

On the other hand, Warren would give anything to anybody in need, and he was the consummate host. I stayed at the famous firehouse in Milwaukee during numerous tournaments, and never once did I feel like I wasn't at home. The minute you walked in the door you knew you were with close friends, even family. He and Martha supplied lodging, meals, and

drinks (Warren's specialty was Brandy Alexander) for dozens of players every year.

Stieg Larsson's description of a character in *The Girl Who Played with Fire* may be said of both Martha and Warren: "When he was at his best he was brilliant, and when he was not at his best he was still far better than the average."

Martha and Warren have now passed into ACC lore, and their legend will undoubtedly grow over time. I am proud to have called both of them "friend." CW






t is summer and time to hit the road for vacations. I know that many ACC members are not cribbage board collectors, but what bet-



The sixth annual Michigan All Star Tournament was hosted by the Grand Rapids Square Peggers on July 17 in Grand Rapids. This year saw a record eight Michigan clubs playing in MAST, each represented by the four club members with the higher win percentage throughout the Grass Roots season.

#### BOARD OF DIRECTORS' MEETING • FEBRUARY 11, 2010 SANDS REGENCY CASINO HOTEL • RENO NV

President Jeanne Hofbauer called the meeting to order at 9a.

The BOD recited the Pledge of Allegiance.

J. Hofbauer added three items to the agenda: job appointment backup spots, rulebook printing, and youth program. Perkins moved to accept the amended agenda; 2nd by Campbell; motion approved.

Roll call was taken. Present were Dave Aiken, Pat Barrett, Don Brown, Dave Campbell, Annett Eiffert, Roland Hall, Sharon Hejtmanek, Jeanne Hofbauer, Roy Hofbauer, Bob Julian, Ron Logan, Herschel Mack, Bob Milk, Cathy Perkins, Joan Rein, Todd Schaefer, Phyllis Schmidt, Jeff Shimp, Wayne Steinmetz, Valerie Sumner, Keith Widener. Absent: Martha Fingleton, Charlie Finley, Larry Samet, Fred White.

Perkins moved to accept the minutes of the last meeting; 2nd by Steinmetz; motion approved.

Job appointments: Executive Committee reviewed resumes for Statistician; none were received for Treasurer. VP of Operations appointed Marlene Lazachek as ACC Treasurer/Statistician with Executive Board's approval.

ACC policy and procedure revision: Perkins proposed a total reorganization of the policy manual; she will work up revisions and send to members to review: add alphabetical index, add job descriptions for commissioners and other jobs, move Constitution and bylaws to the top, add an external relations section, take out names of people and move them to appendixes, rework grammar/spelling throughout. Milk will ensure it gets added to the website. Perkins, Brown, Aiken, and Shimp were appointed to work on the reorganization. BOD also approved a budget to do mailings (with budget to be turned in to Lazachek along with receipts). Perkins made a motion, 2nd by Shimp; motion approved.

Pegging backward: J. Hofbauer: lots of information was sent in on this issue; she asked that "deliberately and/or intentionally" be added to the statement in the new rulebook. Brown: believes that the guideline is ambiguous and unenforceable. Mack: this has already been discussed and processed by the Rules Committee and approved by the board. Following discussion by board members on this issue concerning why it's in the new rulebook; this was already approved to go in the new rulebook, 14 members voted to keep wording as is, 7 members opposed.

Rulebook printing: J. Hofbauer: rulebook will go into effect August 1, 2010; need bids for printing. Mack: Larry Hassett provided contact information for 2004 rulebook. Fingleton had budgeted \$5,000 for this last time. Shimp: should allow Aiken to do this. J. Hofbauer: have Executive Committee review this issue also. White will work on getting bids. The new rulebook should be ready to distribute by June and be on the website by the end of July. Make the regional tournament commissioners, Hassett, and Perkins the distributors. J. Hofbauer: what should we charge? Hassett discussed previous costs, etc. Aiken will find out how many we should print. Shimp made the motion to empower the Executive Board to make decisions on costs, printing, etc., 2nd by R. Hofbauer; motion approved. Eiffert made a motion that we give a free rulebook to judges, 2nd by Schaefer. Discussion on the pros and cons of doing this; too much to keep track of. Motion not approved (4 in favor, 18 against). Mack suggests that the changes in the rulebook be sent to the judges and also suggested that the changes be printed in *Cribbage World*.

Constitution and bylaws changes (discussion only): (1) holding a position in the ACC vis-à-vis suspension (Rein); and (2) right to appeal suspensions (Heitmanek). Rein states that a BOD member should step down if they have been suspended and that this should be added to the Constitution and Bylaws. Perkins said Article 11 concerning suspensions already specifies they could be suspended. Barrett also confirms that they are in "good standing" prior to applying for the BOD. If they are suspended they should not hold a position in Grass Roots either. Rein will review the manual to see if a change/addition needs to be made. Hejtmanek states that appealing suspensions should be kept with the Ethics Committee. The letter that the Ethics Committee sends out states the "why" of the suspension. The member must show documentation on why they are appealing the suspension. Further discussion on suspensions: Ethics Committee is empowered to suspend, and it should be kept confidential within the committee only-not the whole board-while it is being processed. It was noted that an expulsion goes to the Executive Board and then the full board while a suspension starts immediately. Perkins will write procedures in the manual more clearly and Heitmanek will assist her.

Madison Grass Roots Club reinstatement (Rein): Club 1 request to be reinstated. They want to accumulate Grass Roots points again and agreed to pay all back dues for ACC and Grass Roots. Julian a has full report on their back dues. Milk made a motion to reinstate Club 1 as long as all financial and other obligations are met, 2nd by Rein. Perkins amended the motion to add that points they received for the time they are paying back dues for should count also, 2nd by Aiken. Motion approved as amended.

Awards Committee report (Widener): Western region believes the All American awards are fair; other two regions do not. Discussed competing in all three regions; using batting averages; using master points accumulated; going to 30 or more tournaments as part of the process. Widener: have National Championship playoffs from twenty members from two teams. J. Hofbauer asked Widener to write up a proposal for next meeting.

Mandatory cross-checking of qualifying scorecards in tournaments (Barrett): discussion of taping over scores on scorecards and that tapers should be ACC members or disallow taping altogether. Barrett made a motion that all cross-checking of sanctioned events be mandatory, that cross-checkers must be ACC members, and that taping of scorecards for cross-checking be disallowed, 2nd by Aiken. Discussion: if you appointed group to do taping who are ACC members, it should be ok. Motion approved.

Hall of Fame Committee report (Barrett): Barrett thanked the Hall of Fame counters, noted that legal size paper is not allowed. Received 99 out of 100 ballots. Elmer "Ras" Rasmussen (Napavine WA) was elected to the HOF.

Archivist issues (White): (1) additional scanning, (2) cribbage museum, (3) legacy on Grass Roots points. White requested funds not to exceed \$3,000 to process documentation, etc. He spent \$2,600 first time. There will be additional scanning, etc. Will get legacy items scanned first, then put them on the website. Milk made a motion to make available funds for scanning, sorting, and PDFs of historical documents not to exceed \$3,000, 2nd by Logan; motion approved. White: boxes of historical items from previous tournaments, etc. Display items during big tournament at the Sands; White will work with Barbara on this issue. Will discuss legacy Grass Roots points at the Grass Roots meeting.

ACC GN Tournament expenses (Aiken): propose that expenses of BOD meeting should be borne by the whole ACC; should not be part of the prize money for Grand National. Shimp says it will not come out of the prize fund. J. Hofbauer states the GN already receives \$1,000 as seed money. Shimp made a motion to ensure the cost of the BOD meeting not come out of the tournament prize money, 2nd by Widener; motion approved. R. Hofbauer made a motion to give \$1,000 to the director at the GN for the BOD meeting expenses, 2nd by Barrett; motion approved.

Complimentary *Cribbage World* subscriptions (Aiken): request to give three people free Cribbage World for life and any further requests be considered by the Executive Committee on a case-by-case basis. Aiken made the motion, 2nd by Shimp; motion approved.

Participation in AARP Meeting in Orlando FL in October 2010 (Aiken): proposal to promote the ACC at the AARP meeting in Orlando. Perkins volunteered to go to meeting as the ACC representative. Shimp states it's good to try new things to put the word out. There are lots of clubs and tournaments in Florida; this would be a good investment. Attendees will pass the word and copies of *Cribbage World* could be handed out. Ensure the ACC logo is on all flyers, etc. Perkins will work on ensuring the logo will be on everything. Aiken made a motion for the ACC to pay half the booth space and have Perkins head it up; also take money out of publishing budget, 2nd by Shimp; motion approved.

**Double elimination tournament Master Points** (lessthan-full-brackets) (Perkins): these are currently done incorrectly; Perkins drew up a new chart that is correct. Perkins made a motion to approve new chart, 2nd by Shimp; motion approved.

Cribbage Pro game (Milk): should ACC endorse this game by putting their logo on it? J. Hofbauer: do we have any liability for the endorsement? Milk states there are already 20,000 downloads. Discussed pros and cons: Milk will write up contract for Executive Board to review and approve. Milk made a motion to sign up for six months to advertise (\$180) on ecribbage.com, 2nd by Aiken; motion approved.

**2013 GN 32 bid** (Carl Squire/Perkins): Carl Squire (Atlanta GA) is bidding for the 2013 tournament. Discussed room rates, venue, etc. that they can offer.

**2010 GN 29 update** (Jack Howsare/Perkins): Jack is moving ahead. Processing the flyer. Will have a \$2,900 pot (as this will be the 29th GN): all sanctioned and satellite events will count. The \$2,900 will come from donations, raffles, etc. Also will start soliciting ads for the booklet.

**ACC TOC and JPW Open updates** (Rein, R. Hofbauer): 832 so far for the tournament.

ACC Treasurer's report (Marlene Lazachek/Julian): Lazachek went over treasurer's report. Expenses will slow for the first quarter for the regions. Grass Roots looks balanced. Money from internet group: need PayPal account—PayPal takes certain percentage from the internet group. Personal one would not be charged. Widener made a motion to accept treasurer's report, 2nd by Shimp; motion approved.

Publicity/PR report (Norm Nikodym/J. Hofbauer): working on getting yearend numbers from states and clubs to use on statistics from Larry Hassett; also would like to start sending certificates to Grass Roots clubs showing the most progress. Membership by state shows an overall downward turn.

Youth Program (Dan Zeisler): program is still expanding. Started with teaching manuals and sending boards along with manuals. Kids can take them home to share with family and friends. There have been inquires into starting up youth tournaments; right now three are running: Grass Valley, Chico, and St. Cloud. Sands is donating custom pegs to all youth participants at tournaments. Dan has a discard chart he is willing to send to anyone and will put it in his column for all to read. Also has taken on task of online answers to rules: tremendous response—10 to 20 questions per week so far.

Membership Secretary report (Larry Hassett/Julian): 593 memberships expired; 526 new; 177 renew. Need to order more bumper stickers (10,000). Milk and White will help Hassett look into cheaper source for bumper stickers.

**MRP computer program meeting** (J. Hofbauer): This program is antiquated. Will conduct meeting to discuss it further.

Next BOD meeting: Friday, September 17, 2010, at 9a in Virginia Beach VA.

Perkins made a motion to adjourn the meeting, 2nd by J. Hofbauer; motion approved.
